Hijab row: HC restrains students from wearing hijab, saffron shawls within classrooms

Bengaluru, Feb 11 (PTI):

The Karnataka High Court, in its interim order pending considerations of all petitions related to the Hijab row, has requested the state government to reopen educational institutions and restrained all the students from wearing saffron shawls, scarves, Hijab and any religious flag within the classroom.

The court also made it clear the order was confined to such of the institutions wherein the Development College Committees have prescribed the student dress code or uniform.

"We request the State Government and all other stakeholders to reopen the educational institutions and allow the students to return to the classes at the earliest. Pending consideration of all these petitions. we restrain all the students regardless of their

SC to take up plea at appropriate time

New Delhi: The Supreme Court Friday said it would protect the Constitutional rights of every citizen and take up at an appropriate time the pleas challenging a direction of the Karnataka High Court asking students not to wear any religious clothing in educational institutions, and emphasised that these issues should not spread at national level . A bench headed by Chief Justice N V Ramana was told by senior advocate Devdutt Kamat, appearing for the students, that the high court order has led to the "suspension of fundamental right to practice religion under Article 25 of the Constitution" and the plea be listed for hearing on Monday. Refusing to list the plea on February 14 as sought by Kamat, the bench, also comprising justices A S Bopanna and Hima Kohli, referred to the ongoing hearing of the case in the high court and said it will protect the fundamental right of every citizen and take up the matter at an appropriate time. At the outset, Kamat said, I am mentioning a fresh SLP against an interim order passed yesterday in the hijab' matter by the high court. I would say it is rather strange that the high court says that none of the students should disclose any religious identity when they go to school and college.

wearing saffron shawls (Bhagwa), scarfs, hijab, religious flags or the like within the classroom, until further orders," the full bench of the Karnataka High Court comprising Chief Justice Ritu Raj Awasthi, Justice Krishna S Dixit and Justice J M Khazi said in their order, made available on Friday. In their order, the judges expressed their pain over the ongoing agi-

cational institutions for the past few days, "especially when this Court is seized of this matter and important issues of constitutional significance and of personal law are being seriously debated". The court also noted that India is a country of plural cultures, religions and lan-

Being a secular state, the country does not identify itself with any relisaid, adding, every citizen has the right to profess and practice any faith of choice. "Ours being a civilized society, no person in the name of religion, culture or the like can be permitted to do any act that disturbs public peace and tranquility. Endless agitations and closure of educational institutions indefinitely are not happy things to happen," the court observed. Stating that the interest of stu-

dents would be better served by their returning to the classes than by the continuation of agitations and consequent closure of institutions, the court said the academic year is coming to an end shortly and hoped all stakeholders and the public at large maintained peace and tranquilitv. The Court has posted the matter for February 14. The three-judge full bench was formed on Wednesday to hear the petitions by the Muslim girl students challenging the ban on Hijab after the single bench of Justice Dixit, who had been hearing the case since Tuesday referred it to Chief Justice Awasthi with a view that the petitions can be heard by a larger bench.

The Karnataka government on Thursday night decided to resume classes for high school students from Monday following the court observation to reopen schools.

'Uniform Civil Code need of the hour'

New Delhi, Feb 11 (PTI): Amid the row over wearing 'hijab' in schools and colleges, Union Minister and BJP leader Giriraj Singh on Friday said the Uniform Civil Code is the "need of the hour" and it should be discussed both Parliament and in the society. The Hijab row started in Karnataka in December-end when a few students of a government pre-university college in Udupi who attended classes wearing headscarves were asked to leave the campus.

The matter then spread to different parts of the state, with youngsters, backed by rightwing outfits, responding by wearing saffron scarves. With the protests taking a violent turn at some places earlier this week, the state government on Tuesday declared a three-day holiday for the institutions. Interacting with reporters, Giriraj Singh described the row over wearing 'hijab' as a "disturbing trend aimed at muddling the atmosphere of the country".

There are some vote ke saudagar (votes dealers) who for their political benefits are supporting such illogical demands of wearing Hijab in school. Such people are playing with the lives of innocent girls for votes. I feel Uniform Civil Code is need of the hour and it should be discussed from the streets to Parliament," he said.

Ahmedabad, Feb 11 (PTI): The Border Security Force (BSF) on Friday apprehended six Pakistani fishermen from the Harami Nalla creek area in the Kutch district of Gujarat, officials said. NCB busts pan-India drug trafficking racket

New Delhi, Feb 11 (PTI):

The Narcotics Control Bureau (NCB) has busted a pan-India drug trafficking network being run using the 'darknet' and has apprehended about two dozen persons allegedly involved in the racket, official sources said on Friday. A personnel of the federal anti-narcotics agency has also been nabbed during the operation in which numerous searches were conducted in multiple states for about four months. The clandestine smuggling ring involved use of high-end Internet tools like the 'darknet' for striking deals, usage of cryptocur-

rencies for making payments and coded or encrypted use of social media platforms.

Darknet denotes to the hidden Internet platforms that can only be accessed using specialised software and pre-configured communication protocols for anonymous communication. Drugs cartels and syndicates are known to use this to stay under the radar of law enforcement agencies

The drug traffickers caught in this case also used private courier services and India Post networks to source recreational drugs from abroad and to ship them to domestic destinations, they said.

The incident took place in Bhelkachh village under Ghui forest range, where the victim Geeta Devi was heading to her field on Thursday, said B S Bhagat, divisional forest officer (DFO) of Surajpur forest division. The woman suddenly came face to face with a tusker, which caught hold of her with its trunk and slammed her on the ground, killing her on the spot, he said. The pachyderm then threw the body into a small pond nearby before going away,

he said. On being alerted,

forest personnel rushed to the spot and shifted the body to a hospital for postmortem, the official said.

With addition to the latest casualty, the pachyderm named Pyare has killed 48 people since 2014 in Surajpur and neighbouring districts. District forest officials have sought permission from the state government to shift Pyare to a local elephant rescue and rehabilitation centre.

Suraipur, a neighbouring district of Korba, is located over 300 km away from capital Raipur. An immediate aid of Rs 25,000 has been provided to the kin of the deceased, the DFO said, adding that the remaining compensation of Rs 5.75 lakh will be disbursed after completion of the necessary formalities.

Villagers have demanded that two rogue elephants in the area be shifted to the Elephant Rescue and Rehabilitation Centre in Tamor Pingla wildlife sanctuary of the district, he said. "As many as 48 persons have been killed in attacks by Pyare in Surajpur and neighbouring districts since 2014 and permission has been sought from the state government to shift the elephant to a rescue centre, the official said. Meanwhile, Bilaspur-based wildlife activist Mansoor Khan has stressed on proper monitoring of movements of rogue elephants to prevent their entry into human settlements, and said that in case of Pyare, keeping it in the captivity

Finance Minister Nirmala Sitharaman on Friday put a staunch defence of her Budget relying on expenditure to boost growth, saying the Budget brings stability for an economy reeling under the pandemic and will create jobs through public spending.

Rejecting criticism of high prices in the country, she said the inflation at just over 6 per cent when pandemic shaved off Rs 9.57 lakh crore from the economy is less than that during past crises like the 2008-09 global financial meltdown when the economic impact was much

less. Replying to a discussion on Budget 2022-23 in the Rajya Sabha, she said there is no question of a slowdown or recession, as she cited an estimated 9.2 per cent GDP growth in the current fiscal year ending March 31. The size of

the economy has grown from Rs 110 lakh crore 7 vears ago to Rs 232 lakh crore, she said, replying to the charge that the economy was running on a treadmill. The Budget for the fiscal year beginning April 2022 (FY23) stands

for continuity and predictability in taxation while focussing on growth just as last year.

"The Budget aims at continuity, the continuity is in giving the stimulus through public expenditure. We also wanted to underline the stability and sustainable recovery that we so need now," she said. "At a time when the economy has to grow and grow at a good pace, it is important for the economy also to be stabilised.'

Public expenditure in building infrastructure as part of the massive Rs 7.5 lakh crore capital spending plan outlined in the Budget will provide stable and sustainable recovery.

Three villagers of Chandkhuri arrested for engineer's murder

lagers including a former village Chandkhuri have been arrested in connection with the murder of a young engineer. 06 teams of police were engaged in solving the murder mystery. It took 65 days for solving the high profile murder mystery.

About 500 people were questioned and 200 CCTV cameras were examined by the cops. The accused had planned to abduct the engineer for ransom. However, while executing the conspiracy, they strangled him to death. The accused buried the body in the fields and had burnt the belongings of the deceased.

The accused committed the crime for earning a huge amount of money in a short time and fulfilling the desires of a lavish life. A

persons here at the Police Control Room on Friday, OP Pal (IGP, Durg Range) informed that on December 07, 2021, Pulgaon Police had received a complaint regarding missing of a young Chandrakar. He had left his farmhouse on December 06 around 19:30 hrs on bike but did not reach his home at Maroda in Bhilai. Police started searching the missing youth but did not get

Later on January 05, 2022, Shivang's elder brother Dharmesh Chandrakar informed the cops that human skeletal remains were seen in the fields of one Harish Sahu in Chandkhuri Bhatha near Jharjhra bridge. Police team reached the spot and

The accused disclosed that they had planned to abduct Chandrakar and demand a ransom of Rs 30 lakhs. They started monitoring the movement and arrival time of Shivang Chandrakar and finally executed the plan on December 06. As per the plan, Ashok Deshmukh was waiting on the road around 19:00 hrs when Shivang generally returned home. Vicky

Chandrakar reached there, Ashok Deshmukh stopped him and requested for a lift. Immediately after sitting behind him on the bike, Deshmukh grabbed him tightly. When Shivang started screaming, they tightened the rope out of fear which resulted in Shivang's death. At this moment, they spotted a vehicle approaching there. The accused swiftly lifted the body and hid it in

the canal. Later they left Shivang's bike at some distance. Ashok Deshmukh brought his car and the accused carried Shivang's body in the car trunk to Jharjhara Bridge. They buried the body in the pit created due to the movement of



Engineer and one labourer working with construction Company of Contractor Ankit Gupta has been abducted. It was while conducting supervision of this bridge under construction in Bedare thana,

that one Engineer Ashok Pawar and his colleague Anand Kishore have been abducted.

This incident is reported to be that of Friday afternoon at around 1:00 pm and in this regard ASP Pankaj Shukla said that there is information about the abduction, but so far no complete information has been received and we are regularly in touch with Bedare thana.

It is notable here that Bedare thana is located about 70 kms away from Chhattisgarh i:e Bijapur: It is near this Gram Bedare that Indravati River flows. It is the road linking the Maharashtra state that Construction Company is constructing a bridge and it has been given on sub-contract to petty Gupta contractor.

Gupta Contractor has sent on Ashok Pawar and Anand Kishore to conduct inspection of the bridge under construction. The Naxalites have registered stiff protest on start of construction of this bridge on Indravati River, but was under Police security that the same was started.

Heart hole closed through zero rim VSD device closure

Dr Smit Srivastava fourth cardiologist in country to use the device

Raipur, Feb 11: Setting new records of heart treatment, Advance Cardiac Institute (ACI) at Dr Bhimrao Ambedkar Memorial Hospital, affiliated to Pt Jawaharlal Nehru Memorial Medical College Raipur has closed the heart hole Ventricular Septal Defect (VSD) of a 15-year-old girl using a special type of Zero Eccentric Button Device. The procedure was performed by Dr Smit Srivastava, Head Department of Cardiology,



Due to the proximity of the patient's heart valve, use of normal button device to close the hole was risky. Closing the hole to the heart with a normal button device was likely to result in leakage from the valve. So the heart hole was closed using a newly designed VSD button device, the Zero Rim Eccentric, which has a zero edge size. Ventricular septal defect (VSD) is a common



Zero Rim Eccentric VSD Occluder

heart defect, which is congenital, caused by abnormal contact between the lower chambers (ventricles) of the heart. This involves a hole in the wall between the lower chambers of the heart, the left and right ventricles. Most holes close on their own, but sometimes an operation or a catheterbased procedure may be needed to close the hole.

He was referring to Atanasio Monserrate, who is an accused in a 2016 rape case. "It was not possible to sur-

So with the support from the people and workers, I had to enter the fray," he added. With odds stacked against him, Parrikar said, "There is a silent wave in my favour", as he scampered from building to another in Altinho, a plush suburb in Panaji, housing government colonies, residences of chief ministers



CIA has secret programme that collects American data

Washington, Feb 11 (AP):

Central Intelligence Agency (CIA) has a secret, undisclosed data repository that includes information collected about Americans, two Democrats on the Senate Intelligence Committee said. While neither the agency nor lawmakers would disclose specifics about the data. the senators alleged the CIA had long hidden details about the programme from the public and Congress.

Sens Ron Wyden of Oregon and Martin Heinrich of New Mexico sent a letter to top intelligence officials calling for more details about the program to be declassified. Large parts of the letter, which was sent in April 2021 and declassified, and documents released by the CIA were



blacked out. Wyden and Heinrich said the pro-

gramme operated outside the statutory framework that Congress and the public believe govern this

There have long been concerns about what information the intelligence community collects domestically, driven in part by previous violations of Americans' civil liberties.

The CIA and National Security Agency have a foreign mission and are generally barred from investigating Americans or US businesses. But the spy agencies' sprawling collection of foreign communications often snares Americans' messages and data incidentally.

Intelligence agencies are required to take steps to protect US information,

including redacting the names of any Americans from reports unless they are deemed relevant to an investigation. The process of removing redactions is known as unmasking.

CIA recognises and takes very seriously our obligation to respect the privacy and civil liberties of US persons in the conduct of our vital national security mission, Kristi Scott, the agency's privacy and civil liberties officer, said in a statement. CIA is committed to transparency consistent with our obligation to protect intelligence sources and methods. The CIA released a series of redacted recommendations about the program issued by an oversight panel known as the Privacy and Civil Oversight Liberties Board. According to the document, a pop-up box warns CIA analysts using

the program that seeking any information about US citizens or others covered by privacy laws requires a foreign intelligence pur-

However, analysts are not required to memorialize the justification for their queries, the board

Both senators have long pushed for more transparency from the intelligence agencies. Nearly a decade ago, a question Wyden posed to the nation's spy chief presaged critical revelations about the NSA's mass-surveillance programs.

In 2013, Wyden asked then-Director of National Intelligence Clapper if the NSA collected any type of data at all on millions or hundreds of millions of Americans. Clapper initially responded, No." He later said, Not wittingly.

Intent of school uniform

he Supreme Court has declined to give urgent list ing for hearing a Special Leave Petition against Karnataka High Court's direction regarding the hijab petitions. Chief Justice of India NV Ramana said that the apex court will take up the matter at an 'appropriate time.' The Karnataka High Court bench hearing the hijab ban case said students should not wear religious dress to colleges. The matter will now be heard on February 14. Chief Justice Ritu Raj Awasthi indicated to the advocates for the petitioner-students and the State Advocate General that the court will pass an interim order for starting the educational institutions and that all students should not insist on wearing head scarves or saffron shawls till the Bench decides the issues raised in the petitions. Are school uniforms still relevant in the modern world? There are multiple reasons why a dress code is considered necessary with correct intent. The most compelling one is that of economy, parents don't need to worry about dressing their children in different clothes for school every day when there is a school uniform. In many ways, this immediately wipes out a large chunk of the class differences between students. Both poor and rich students are dressed the same way. The very first institutionalized uniform has documented evidence from 1222. The uniforms were ordered by the Archbishop of Canterbury at the time, who standardized the wearing of the cappa clausa, a cape with a closed front. After that religious use, the practice branched into educational and academic institutions around England. The idea of a standardized dress code was adopted by the Cambridge University in UK right from the 13th century. Though it was met with staunch opposition from the students, the academic dress code gradually acquired a sta-

In the 16th century, England was the first nation to require school uniforms. But these uniforms were not to be worn by elite students, they were to distinguish the poor children attending charity schools from other children. It wasn't until 300 years later that student who attended the better English public schools began wearing uniforms. Once this became the norm, it blossomed into an obsession, as well as a way to effect social and cultural control over the students. Those who support school uniforms argue that if all of the students are wearing the same clothing, they will take school more seriously instead of worrying about what they're wearing. Since many places of employment also require uniforms, this will prepare the students for future jobs, and group clashes will decrease because members will be unable to identify their rivals by their clothing. In India, school uniforms were introduced during the British rule. Girls in senior secondary schools usually wear 'Salwar Kamiz' and boys wear pants and shirts. In preschool, girls wear skirts and blouses and boys wear short pants and shirts. Though some religious institutions have specific needs, the government institutions have to strictly follow secular ethics. In other parts such as New Zealand and Australia, where the British colonial rule was in effect, the uniform system is followed in government schools. The purpose of a school uniform is to promote team spirit and discipline, and enhance equality among all students. Though uniforms have helped to wipe out the discrimination meted out to the weaker section, critics have a different story to say. According to them, uniforms have no such great impact on the mindset of students. Last, some schools in Kerala were praised for introducing gender neutral unforms for boys and girls. The court will have to keep original intent of school uniforms in perspective for its judgements.

he Directorate General of Foreign Trade (DGFT) under the commerce and industry ministry has issued a notification banning the import of foreign drones. Import policy for drones in CBU (Completely Built Up) or CKD (Completely Knocked Down) or SKD (Semi Knocked Down) form is prohibited with exceptions provided for Research and Development (R&D), defence and security purposes. Import of drones by government entities, educational institutions recognised by central or state government, government recognised R&D entities and drone manufacturers for R&D purpose will be allowed in CBU, SKD or CKD form. This will be subject to import authorisation issued by DGFT in consultation with line ministries concerned. The civil aviation ministry said that in order to promote Made in India drones, import of foreign drones has been prohibited with effect from February 9, 2022. The ministry came out with liberalised drone rules in August 2021. After the rules, the ministry issued the drone airspace map and PLI scheme in September 2021, UTM policy framework in October 2021. Besides, drone certification scheme and single window DigitalSky Platform were put in place last month. Drones are computerised aircrafts, booming due to lowered cost of electronics.

Chinese corporations have dominated the civilian drone market and now government wants the local drone industry to bloom. New technologies often start with the military and are very expensive. And then, as economies of scale kick in, suddenly they hit a consumer moment and words like 'personal' enter into it. At that point, all bets are off. That's the stage we're hitting right now with drones. It's hard to argue that we're not in an exponential period of technological innovation. The personal drone is basically the peace dividend of the smartphone wars, which is to say that the components in a smartphone like sensors, the navigation, the camera, the computing processors, the wireless antenna, the memory, the battery all that stuff, which is being driven by the incredible economies of scale and innovation at electronic corporations is available for a few hundred rupees. They were essentially not available to civilians fifteen years ago. This is stuff that used to be military industrial technology, you can buy it at any electronic store now. Society has never seen technology move faster than it's moving right now, and that's because of the supercomputer in your pocket called a smartphone. Much depends on electronic manufacturing in India.

Continuity, correctness, conservatism and crowding-in for economy



our Cs - continuity, correctconservatism and crowding-in - are the hallmarks of the budget for 2022-23 presented by the finance minister on the 1st of February for the economy of India. The budget has continued with the practice started two years ago of bringing all below-the-line items above the line. Extra-budgetary resources in which the borrowing is guaranteed and serviced by the Union Government is restricted to a single transitional item of Rupees 750 crores in the current year's revised estimates (RE). Transparency and cleaner accounting continue to be accorded the highest priority in budget-making as was the case with the previous two budgets. In the last two years, marked by the global pandemic, the government has provided resources for the vulnerable sections of the society through Emergency Credit Line Schemes, through **Emergency Food support (PM Gharib** Kalyan Yojana) involving allocation of additional foodgrain over and above eligibility under Public Distribution extended multiple times, enhanced allocations to rural employment guarantee programme and PM-

In this year's budget, it has extended the Emergency Credit Line **Guarantee Scheme to contact-based** sectors that are yet to return to their pre-pandemic levels. The revamping of the Credit Guarantee Trust for

Micro and Small Enterprises (MSME) and infusing additional capital into it will unlock additional Rupees 2.0 lakh crores of credit to MSME. The government has used the pandemic crisis as an opportunity to usher in many important structural changes in the economy. Examples include the Production Linked Incentive Schemes for fourteen sectors, the ending of the uncertainty associated with retrospective taxation, privatisation, faceless assessment and reduction in corporate and personal income taxes wherein taxpayers could opt for lower tax rates with fewer or no exemptions or to file under the old method. In addition, important process-oriented measures such as the launch of the Gati Shakti dashboard, reforms to government procurement, changes to Factoring laws and the Account Aggregator framework have been launched.

The budget for 2022-23 builds on this approach of combining structural reforms and process improvements. The many initiatives under Gati Shakti, the inter-linking of many portals (Udyam, e-Shram, NCS and ASEEM) to help MSME with credit facilities, skilling and augmentation, the enabling of post-offices with the core -banking solution, the facilitation of updated returns to correct errors in the original returns for up to two years and creating a pathway for world-class foreign universities and institutions in selected fields to be set up in GIFT city are but few of the examples. The assumption of 11.2 percent as the growth rate of GDP at current prices might strike many as being too conservative especially given that the Economic Survey for 2021-22 projects a figure of between 8 and 8.5 percent as the growth rate for GDP at constant prices. If anything, the chances of this projection being exceeded are higher than the chances of undershooting it, given that real GDP contracted q/q in 1Q2021-22. That sets up a positive base effect for 2022-23. However, depending on the impact of the omicron variant on economic activity could be weaker in the last quarter of the current fiscal year. If multiple external shocks impact the Indian economy in 2022-23 (oil price shock, Fed's monetary policy normalisation impacting global financing conditions, etc.), then 11.2 percent might not appear as conservative but prudent.

Capital expenditure by the government will rise 36 percent over the revised budget estimate (and 35.4 percent over BE 2021-22), after one excludes the cash infusion of nearly Rupees 52000 crores into AIR INDIA. It includes Rupees 1.0 lakh crores of 50-year interest-free loans to state governments to undertake capital infusion. It includes incremental (over last year's 65000 crores of Rupees) budget support of Rs. 69000 crores provided as equity) to the National Highways Authority of India. All of this information is in the public domain. If State governments were allowed these Rupees 1.0 lakh crore as an additional borrowing limit, they will bear an interest rate that is higher than the rate at which the Union Government borrow. Further, the money can be used for revenue expenditure. This interest-free loan, dedicated as it is to capital expenditure, incentivises it. The fact that states' capex up to November 2021 was 67 percent higher than in the same eight months of the previous financial year supports this 50-year interest-free loan purely for capital expenditure purposes. NHAI's capital investments in recent years have been considerably financed by borrowings and this has increased its interest burden. By providing enhanced budgetary support, the government is strengthening NHAI to remain a financially viable entity while ensuring continued investment in national highways. As far as USD 5 trillion economy is concerned, India is the fastest growing large economies in the world.

Depending on how exchange rate move Indian Rupee would remain stable to strong given what is going on the developed world. If we continue to retain the path of 8-9 per cent real GDP, it would translate into 8 per cent dollar GDP growth. If we extrapolate that we should be at the USD 5 trillion by 2025-26 or 2026-27. So, we have enough cushion to help the demand recovery. Economic stress is high because of the pandemic cloud, which is still keeping people uncertain and restrained in their spending. Once the pandemic cloud lifts, the consumer sentiment and spending habits would come back to a normal growth pattern. Crude oil is a bigger risk for the economy, bigger than a hawkish Federal Reserve, and monsoon. While monsoon is too early to talk about and regardless of how taper proceeds in the US, the fall out on India should be very, very manageable, which leaves crude oil, which is a "risk the world economy faces and not just India. Mumbai, Feb 11 (PTI): The rupee plunged by 24 paise to 75.39 (provisional) against the US currency at close on Friday due to fears of an aggressive rate hike by the Federal Reserve after US inflation raced to a 40-year high in January. Forex traders said muted domestic equities, sustained foreign fund outflows and elevated crude oil prices weighed on the local unit. At interbank foreign exchange, the rupee opened at 75.40 against the American dollar, and later witnessed an intra-day high of 75.27 and a low of 75.46 against the greenback. The local unit finally ended the day at 75.39, down 24 paise from the previous close. On Thursday, the rupee had settled at 75.15 against the US dollar, after the Reserve Bank of India kept the benchmark lending rate unchanged and said it will continue with the accommodative stance.

Sensex sinks 773 pts, Nifty slumps below 17,400

Mumbai, Feb 11 (PTI): Equity benchmark Sensex tumbled 773 points on Friday, tracking huge losses in IT and financial stocks amid a fresh sell-off in global markets.

Persistent selling by foreign funds also affected the sentiment, traders said. The 30-share BSE index ended 773.11 points or 1.31 per cent lower at 58,152.92. Similarly, the NSE Nifty plunged 231.10 points or 1.31 per cent to 17,374.75. Need for state specific agency for energy conservation, efficiency

Union Power Minister RK Singh has stressed on creating a state-specific agency dedicated for energy conservation and efficiency as part of measures to ensure participation of states and UTs in fulfilling the country's climate commitments. The minister also asserted that India will replace diesel with renewables to achieve target of zero-diesel use in the agricultural sector by 2024, a power ministry release said on Friday.

The minister held a virtual meeting with the officials of the Ministry of Power and Ministry of New & Renewable Energy, Additional Secretaries and Principal Secretaries of Power or Energy Departments of states & UTs. The power

ministry said the role of states and UTs towards energy transition goals of India was discussed in the meeting. Addressing the meeting, Singh stressed the need for collaborative enorts between the Central and State Governments towards the large-scale deployment of energy efficiency measures in potential sectors of the economy. He emphasised the need to have a state-specific agency dedicated for energy efficiency and conservation. He urged that the states should develop action plan to achieve the assigned targets. He further said that the central government is working for a new and modern India, which cannot happen without modern power systems, and it look forward to working with all states and UTs to achieve this.

RBI believes differing policy strategy, policy stance can coexist

Stating that the RBI has surprised everyone with its status quo on rates and accommodative stance for the 10th time in a row and a lower forecast for inflation and growth for FY23, SBI Research said that with this, the central bank has set a clear distinction between policy strategy and policy stance and that these can coexist simultaneously.

As result, the bond yields have shed seven basis points (bps) to 6.73 per cent on Thursday after touching 6.88 per cent on the Budget day when the

government said it would borrow a record Rs 14.3 lakh crore to fund its capex (capital expenditure) plans of Rs 7.5 lakh crore. On Thursday, the Reserve Bank of India (RBI) surprised the market with a policy statement that has a lower gross domestic product (GDP) at 7.8 per cent and an inflation forecast at 4.5 per cent for FY23. This translates into a WPI (Wholesale Price Index) projection of around 2.8 per cent in FY23. The lower inflation forecast has taken the market by surprise and the 10-year yields declined by seven bps to close at 6.73 per cent after falling 10 bps immediately after the policy was announced.

SBI Chief Economic Advisor Soumya Kanti Ghosh expects the yields to decline further to settle at 6.55-6.6 per cent.

He also said that even though the market was surprised by the tone of the policy, the RBI may have moved ahead of the market in terms of expectations. As a result, FY23 could usher in a new era of separate strategy and separate stance, an unconventional monetary policy setting in the true sense, Ghosh added.

Interim report on governance lapses in BharatPe in 2 weeks

New Delhi, Feb 11 (PTI):

BharatPe chief executive Suhail Sameer in a communication to employees has stated that there were a couple of "serious allegations" 10 governance lapses, which warranted a fine-tooth-comb audit of governance practices by outside experts.

He requested them to keep their trust in the leadership amid cofounder Ashneer Grover's tussle with the company's board and said the interim report of the auditors should come in the next couple of weeks. Sameer did not elaborate on the allegations.

Grover, who was sent on a three-month leave following allegations of using abusive language against Kotak Mahindra Bank staff and fraudulent prac-

tices, has denied all allegations. BharatPe CEO in the letter to employees, a copy of which is with PTI. said a governance review is being carried out by well-known and reputed external iirms Alvarez and Marsal (A&M) and PwC).

"Based on some internal complaints, we decided to do a full audit of our governance processes," he said. "While many of the findings of the review are pretty standard for a fastgrowth company of our size, there are a couple of more serious allegations, which the review is still substantiating."

Led by a 50 per cent jump in private equity funding to an all-time of over USD 66 billion, the overall deal activity soared nearly 40 per cent to reach about USD 115 billion in 2021 across 2,064 transactions, according to a report that expects the momentum to continue this year.

The Deal Street was boosted by a 50 per cent jump in private equity (PE) deals in value terms to USD 66.1 billion, an alltime high in 2021 across 1,258 deals, which is 32 per cent higher in volume compared with 2020, according to data compiled by PwC India.

Of the total PE money, as much as USD 35 billion were pumped into startups alone, the report added.



Despite the headwinds from the pandemic and other looming uncertainties, the deal activity saw a record high in 2021 and surpassed pre-COVID-19 levels. The deal activity reached USD 114.9 billion with 2,064 transactions, a 40 per cent increase from 2020 in terms of value and 60 per cent in terms of vol-

ume, PwC said. The record buoyancy in the deal activity was driv-

en by abundant cash reserves, availability of private equity dry powder, foreign direct investments and lower interest rates, it said. Of the total, PE deals contributed 57 per cent by value and 61 per cent by volume, while mergers

and acquisitions (M&As) contributed the remaining 43 per cent by value and 39 per cent by volume, it said. The country also saw record 43 start-ups turning

Reilly Opelka makes quarterfinals at inaugural Dallas Open



Dallas: Second-seeded Reilly Opelka advanced to the quarterfinals of the inaugural Dallas Open with a straight-sets win over Cedrik-Marcel Stebe. Opelka, a two-time ATP Tour winner ranked 23rd in the world, won 7-6 (3), 7-6 (8) in his second meeting with Stebe. The first was at Wimbledon in 2019. The 24-year-old American will play the winner of the late match between No. 5 Adrian Mannarino and Yoshihito Nishioka. Fourth-seeded Jenson Brooksby, playing with a career-best No. 54 world ranking and seeded in an ATP Tour event for the first time in his career, also advanced the quarterfinals with 6-3, 3-6, 6-3 win over Italian Andreas Seppi. Brooksby, the 21-year-old American who reached fourth round as a wild card in the 2021 U.S. Open, has yet to win an ATP Tour title despite a breakout 2021 that included 49 professional wins and three ATP Challenger titles.

Formula One extends Bahrain GP contract through 2036

Paris: Formula One extended its contract to continue racing in Bahrain until 2036, saying Friday that the Middle Eastern country holds a very special place in our sport. The Sakhir-based circuit has held F1 races since 2004 and will stage the season-opener next month. Ahead of the Bahrain Grand Prix last year, seven-time champion Lewis Hamilton urged the global racing series to not ignore human rights violations in the countries where it stages races. Bahrain has been accused of exploiting the series to gloss over, or sportswash, its human rights record. The Bahrain GP is scheduled March 20 and the Bahrain International Circuit will also host pre-season testing. Since 2004, we have had some fantastic races in Sakhir and we cannot wait to be back there for the start of the 2022 championship as we begin a new era for the sport, F1 chief executive Stefano Domenicali said in a statement.

Buyers stood in line overnight in freezing weather and emptied store shelves after the Winter Games opened Feb. 4. News reports say factory employees were called back from their Lunar New Year holiday to make more panda mascots. Three people in Beijing were sentenced to unspecified administrative penalties for reselling souvenirs at prices deemed too high, police announced. Punishment can include detention, fines and confiscation of goods. Plush toys of Bing Dwen Dwen, a panda in a clear plastic suit, sold for 192 yuan (30) at the Gongmei Emporium in central Beijing. The shop on the Wangfujing pedestrian mall and other authorised outlets also sell Olympicsthemed pens, badges and other souvenirs.

Schwartzman advances at Argentina Open



Buenos Aires: Second-seeded and home crowd favorite Diego Schwartzman defeated Spain's Jaume Munar 7-6 (2), 7-6 (4) to reach the quarterfinals of the Argentina Open. Schwartzman will face Francisco Cerundolo, the Argentinian compatriot he beat to win last year's title in Buenos Aires. Schwartzman, ranked the 15th-best player in the circuit, will take on a rival in the 107th position. Cerundolo beat Serbian Miomir Kecmanovic 6-3, 3-6, 6-2 to reach the last eight. Also on Thursday, Italy's Fabio Fognini topped Spaniard Pedro Martinez. The 34-year-old No. 4-seeded player in the clay court tournament won 6-4, 7-6 (5). Fognini will take on Argentinian Federico Delbonis on Friday. Top-seeded Casper Ruud of Norway will face local favorite Federico Coria.

India beat West Indies by 96 runs to clinch series 3-0

India affected a 3-0 whitewash over West Indies after defeating the visitors by 100 runs in the third and the final One-Day International on Friday at the Narendra Stadium Ahmedabad. Mohammed Siraj (3/29) and Prasidh Krishna (3/27) picked three wickets each while Deepak Chahar (2/41) and Kuldeep Yadav (2/51) scalped two wickets apiece as India bowled out West Indies for 169 in 37.1 overs. With this comprehensive win, Rohit Sharma registered his first series triumph as India's full-time ODI skipper.

The Windies on Friday put a decent bowling show on display at Motera. For the first time in the series, the tourists managed to bowl out India, for 265, in fifty overs. But once again, their inconsistency with the bat became the reason behind their disappointing defeat. Unlike the previous encounter, the West Indies batting line-up ap-



peared more fragile and kept on losing wickets at regular intervals.

Odean Smith continued to impress with his allround show on Friday. After scalping the wicket of Shikhar Dhawan, the 25-year-old threw away his bat to almost every ball he faced during his stay in the middle. He smashed 3 boundaries and as many sixes (most by any player in the game) before Siraj finally ended his fiery cameo in the 24th over.

Despite scalping 8 wickets inside 24 overs, the hosts had to toil a bit more to taste victory as Alzarri Joseph and Hayden Walsh showed great resistance against the Indian attack. They added enough 47 runs to the 9th wicket after staying at the crease for more than 12 overs.

Mohammed Siraj drew the first blood by trapping wicketkeeper-batter Shai Hope (5) in front in the fourth over. An early dismissal unsettled the visitors completely as Deepak Chahar came in to affect two quick dismissals, removing Brandon King (14) and Shamarh Brooks (0) in the same over. Stand-in skipper Nicholas Pooran then joined Darren Bravo

EC warns U'khand BJP to be more careful

Commission (EC) has warned the Uttarakhand BJP to be more careful in the future and advised it to follow all provisions of the poll code, days after it tweeted a morphed picture of Congress leader Harish

Last week, the poll panel had issued a notice to the Uttarakhand unit of the Bharatiya Janata Party (BJP) for tweeting a morphed image of former chief minister Rawat, in which he was shown as a Muslim cleric. An EC order issued

on Wednesday said the Uttarakhand BJP has submitted that the purpose of the tweet was neither to violate any provisions of the Model Code of Conduct nor to create any differences between groups on the basis of religion, race, caste and language.

Man hit by car, dragged on bonnet for over 100 metres

Ex-bureaucrat's son held

New Delhi, Feb 11 (PTI):

The son of a retired bureaucrat was arrested for allegedly hitting a man with his car and carrying him on its bonnet for over 100 metres in south Delhi's Greater Kailash area, police said on Friday. The police has also arrested the bureaucrat under section 212 (harbouring offender) of the Indian Penal Code, they said.

The injured man, Anand Vijay Mandelia (37), is a city-based businessman and being treated at the Max Super Specialty hospital. He is under observation but out of danger, police said. In the video of the incident, which was widely circulated on the social media, the man is seen

"Sunderam was arrested from outside the Le Meridian Hotel, Gurgaon in Haryana. Sections 308 (attempt to commit culpable homicide), 307 (attempt to murder) and 212 (harbouring offender) of the Indian Penal Code have also been added in the case on the basis of facts that emerged during the investigation." 



Hijab row: HC restrains students from wearing hijab, saffron shawls within classrooms

Bengaluru, Feb 11 (PTI):

The Karnataka High Court, in its interim order pending considerations of all petitions related to the Hijab row, has requested the state government to reopen educational institutions and restrained all the students from wearing saffron shawls, scarves, Hijab and any religious flag within the classroom.

The court also made it clear the order was confined to such of the institutions wherein the Development College Committees have prescribed the student dress code or uniform.

"We request the State Government and all other stakeholders to reopen the educational institutions and allow the students to return to the classes at the earliest. Pending consideration of all these petitions. we restrain all the students regardless of their

SC to take up plea at appropriate time

New Delhi: The Supreme Court Friday said it would protect the Constitutional rights of every citizen and take up at an appropriate time the pleas challenging a direction of the Karnataka High Court asking students not to wear any religious clothing in educational institutions, and emphasised that these issues should not spread at national level . A bench headed by Chief Justice N V Ramana was told by senior advocate Devdutt Kamat, appearing for the students, that the high court order has led to the "suspension of fundamental right to practice religion under Article 25 of the Constitution" and the plea be listed for hearing on Monday. Refusing to list the plea on February 14 as sought by Kamat, the bench, also comprising justices A S Bopanna and Hima Kohli, referred to the ongoing hearing of the case in the high court and said it will protect the fundamental right of every citizen and take up the matter at an appropriate time. At the outset, Kamat said, I am mentioning a fresh SLP against an interim order passed yesterday in the hijab' matter by the high court. I would say it is rather strange that the high court says that none of the students should disclose any religious identity when they go to school and college.

wearing saffron shawls (Bhagwa), scarfs, hijab, religious flags or the like within the classroom, until further orders," the full bench of the Karnataka High Court comprising Chief Justice Ritu Raj Awasthi, Justice Krishna S Dixit and Justice J M Khazi said in their order, made available on Friday. cational institutions for the past few days, "especially when this Court is seized of this matter and important issues of constitutional significance and of personal law are being seriously debated". The court also noted that India is a country of plural cultures, religions and lan-

Being a secular state, the country does not identify itself with any relisaid, adding, every citizen has the right to profess and practice any faith of choice. "Ours being a civilized society, no person in the name of religion, culture or the like can be permitted to do any act that disturbs public peace and tranquility. Endless agitations and closure of educational institutions indefinitely are not happy things to happen," the court observed. Stating that the interest of stu-

dents would be better served by their returning to the classes than by the continuation of agitations and consequent closure of institutions, the court said the academic year is coming to an end shortly and hoped all stakeholders and the public at large maintained peace and tranquilitv. The Court has posted the matter for February 14. The three-judge full bench was formed on Wednesday to hear the petitions by the Muslim girl students challenging the ban on Hijab after the single bench of Justice Dixit, who had been hearing the case since Tuesday referred it to Chief Justice Awasthi with a view that the petitions can be heard by a larger bench.

The Karnataka government on Thursday night decided to resume classes for high school students from Monday following the court observation to reopen schools.

'Uniform Civil Code need of the hour'

New Delhi, Feb 11 (PTI): Amid the row over wearing 'hijab' in schools and colleges, Union Minister and BJP leader Giriraj Singh on Friday said the Uniform Civil Code is the "need of the hour" and it should be discussed both Parliament and in the society. The Hijab row started in Karnataka in December-end when a few students of a government pre-university college in Udupi who attended classes wearing headscarves were asked to leave the campus.

The matter then spread to different parts of the state, with youngsters, backed by rightwing outfits, responding by wearing saffron scarves. With the protests taking a violent turn at some places earlier this week, the state government on Tuesday declared a three-day holiday for the institutions. Interacting with reporters, Giriraj Singh described the row over wearing 'hijab' as a "disturbing trend aimed at muddling the atmosphere of the country".

There are some vote ke saudagar (votes dealers) who for their political benefits are supporting such illogical demands of wearing Hijab in school. Such people are playing with the lives of innocent girls for votes. I feel Uniform Civil Code is need of the hour and it should be discussed from the streets to Parliament," he said.

NCB busts pan-India drug trafficking racket

New Delhi, Feb 11 (PTI):

The Narcotics Control Bureau (NCB) has busted a pan-India drug trafficking network being run using the 'darknet' and has apprehended about two dozen persons allegedly involved in the racket, official sources said on Friday. A personnel of the federal anti-narcotics agency has also been nabbed during the operation in which numerous searches were conducted in multiple states for about four months. The clandestine smuggling ring involved use of high-end Internet tools like the 'darknet' for striking deals, usage of cryptocur-

rencies for making payments and coded or encrypted use of social media platforms.

Darknet denotes to the hidden Internet platforms that can only be accessed using specialised software and pre-configured communication protocols for anonymous communication. Drugs cartels and syndicates are known to use this to stay under the radar of law enforcement agencies

The drug traffickers caught in this case also used private courier services and India Post networks to source recreational drugs from abroad and to ship them to domestic destinations, they said.

The incident took place in Bhelkachh village under Ghui forest range, where the victim Geeta Devi was heading to her field on Thursday, said B S Bhagat, divisional forest officer (DFO) of Surajpur forest division. The woman suddenly came face to face with a tusker, which caught hold of her with its trunk and slammed her on the ground, killing her on the spot, he said. The pachyderm then threw the body into a small pond nearby before going away,

he said. On being alerted,

forest personnel rushed to the spot and shifted the body to a hospital for postmortem, the official said.

With addition to the latest casualty, the pachyderm named Pyare has killed 48 people since 2014 in Surajpur and neighbouring districts. District forest officials have sought permission from the state government to shift Pyare to a local elephant rescue and rehabilitation centre.

Suraipur, a neighbouring district of Korba, is located over 300 km away from capital Raipur. An immediate aid of Rs 25,000 has been provided to the kin of the deceased, the DFO said, adding that the remaining compensation of Rs 5.75 lakh will be disbursed after completion of the necessary formalities.

Villagers have demanded that two rogue elephants in the area be shifted to the Elephant Rescue and Rehabilitation Centre in Tamor Pingla wildlife sanctuary of the district, he said. "As many as 48 persons have been killed in attacks by Pyare in Surajpur and neighbouring districts since 2014 and permission has been sought from the state government to shift the elephant to a rescue centre, the official said. Meanwhile, Bilaspur-based wildlife activist Mansoor Khan has stressed on proper monitoring of movements of rogue elephants to prevent their entry into human settlements, and said that in case of Pyare, keeping it in the captivity is the only option left with

Intent of school uniform

he Supreme Court has declined to give urgent list ing for hearing a Special Leave Petition against Karnataka High Court's direction regarding the hijab petitions. Chief Justice of India NV Ramana said that the apex court will take up the matter at an 'appropriate time.' The Karnataka High Court bench hearing the hijab ban case said students should not wear religious dress to colleges. The matter will now be heard on February 14. Chief Justice Ritu Raj Awasthi indicated to the advocates for the petitioner-students and the State Advocate General that the court will pass an interim order for starting the educational institutions and that all students should not insist on wearing head scarves or saffron shawls till the Bench decides the issues raised in the petitions. Are school uniforms still relevant in the modern world? There are multiple reasons why a dress code is considered necessary with correct intent. The most compelling one is that of economy, parents don't need to worry about dressing their children in different clothes for school every day when there is a school uniform. In many ways, this immediately wipes out a large chunk of the class differences between students. Both poor and rich students are dressed the same way. The very first institutionalized uniform has documented evidence from 1222. The uniforms were ordered by the Archbishop of Canterbury at the time, who standardized the wearing of the cappa clausa, a cape with a closed front. After that religious use, the practice branched into educational and academic institutions around England. The idea of a standardized dress code was adopted by the Cambridge University in UK right from the 13th century. Though it was met with staunch opposition from the students, the academic dress code gradually acquired a sta-

In the 16th century, England was the first nation to require school uniforms. But these uniforms were not to be worn by elite students, they were to distinguish the poor children attending charity schools from other children. It wasn't until 300 years later that student who attended the better English public schools began wearing uniforms. Once this became the norm, it blossomed into an obsession, as well as a way to effect social and cultural control over the students. Those who support school uniforms argue that if all of the students are wearing the same clothing, they will take school more seriously instead of worrying about what they're wearing. Since many places of employment also require uniforms, this will prepare the students for future jobs, and group clashes will decrease because members will be unable to identify their rivals by their clothing. In India, school uniforms were introduced during the British rule. Girls in senior secondary schools usually wear 'Salwar Kamiz' and boys wear pants and shirts. In preschool, girls wear skirts and blouses and boys wear short pants and shirts. Though some religious institutions have specific needs, the government institutions have to strictly follow secular ethics. In other parts such as New Zealand and Australia, where the British colonial rule was in effect, the uniform system is followed in government schools. The purpose of a school uniform is to promote team spirit and discipline, and enhance equality among all students. Though uniforms have helped to wipe out the discrimination meted out to the weaker section, critics have a different story to say. According to them, uniforms have no such great impact on the mindset of students. Last, some schools in Kerala were praised for introducing gender neutral unforms for boys and girls. The court will have to keep original intent of school uniforms in perspective for its judgements.

he Directorate General of Foreign Trade (DGFT) under the commerce and industry ministry has issued a notification banning the import of foreign drones. Import policy for drones in CBU (Completely Built Up) or CKD (Completely Knocked Down) or SKD (Semi Knocked Down) form is prohibited with exceptions provided for Research and Development (R&D), defence and security purposes. Import of drones by government entities, educational institutions recognised by central or state government, government recognised R&D entities and drone manufacturers for R&D purpose will be allowed in CBU, SKD or CKD form. This will be subject to import authorisation issued by DGFT in consultation with line ministries concerned. The civil aviation ministry said that in order to promote Made in India drones, import of foreign drones has been prohibited with effect from February 9, 2022. The ministry came out with liberalised drone rules in August 2021. After the rules, the ministry issued the drone airspace map and PLI scheme in September 2021, UTM policy framework in October 2021. Besides, drone certification scheme and single window DigitalSky Platform were put in place last month. Drones are computerised aircrafts, booming due to lowered cost of electronics.

Chinese corporations have dominated the civilian drone market and now government wants the local drone industry to bloom. New technologies often start with the military and are very expensive. And then, as economies of scale kick in, suddenly they hit a consumer moment and words like 'personal' enter into it. At that point, all bets are off. That's the stage we're hitting right now with drones. It's hard to argue that we're not in an exponential period of technological innovation. The personal drone is basically the peace dividend of the smartphone wars, which is to say that the components in a smartphone like sensors, the navigation, the camera, the computing processors, the wireless antenna, the memory, the battery all that stuff, which is being driven by the incredible economies of scale and innovation at electronic corporations is available for a few hundred rupees. They were essentially not available to civilians fifteen years ago. This is stuff that used to be military industrial technology, you can buy it at any electronic store now. Society has never seen technology move faster than it's moving right now, and that's because of the supercomputer in your pocket called a smartphone. Much depends on electronic manufacturing in India.

Continuity, correctness, conservatism and crowding-in for economy



our Cs - continuity, correctconservatism and crowding-in - are the hallmarks of the budget for 2022-23 presented by the finance minister on the 1st of February for the economy of India. The budget has continued with the practice started two years ago of bringing all below-the-line items above the line. Extra-budgetary resources in which the borrowing is guaranteed and serviced by the Union Government is restricted to a single transitional item of Rupees 750 crores in the current year's revised estimates (RE). Transparency and cleaner accounting continue to be accorded the highest priority in budget-making as was the case with the previous two budgets. In the last two years, marked by the global pandemic, the government has provided resources for the vulnerable sections of the society through Emergency Credit Line Schemes, through **Emergency Food support (PM Gharib** Kalyan Yojana) involving allocation of additional foodgrain over and above eligibility under Public Distribution extended multiple times, enhanced allocations to rural employment guarantee programme and PM-

In this year's budget, it has extended the Emergency Credit Line **Guarantee Scheme to contact-based** sectors that are yet to return to their pre-pandemic levels. The revamping of the Credit Guarantee Trust for

Micro and Small Enterprises (MSME) and infusing additional capital into it will unlock additional Rupees 2.0 lakh crores of credit to MSME. The government has used the pandemic crisis as an opportunity to usher in many important structural changes in the economy. Examples include the Production Linked Incentive Schemes for fourteen sectors, the ending of the uncertainty associated with retrospective taxation, privatisation, faceless assessment and reduction in corporate and personal income taxes wherein taxpayers could opt for lower tax rates with fewer or no exemptions or to file under the old method. In addition, important process-oriented measures such as the launch of the Gati Shakti dashboard, reforms to government procurement, changes to Factoring laws and the Account Aggregator framework have been launched.

The budget for 2022-23 builds on this approach of combining structural reforms and process improvements. The many initiatives under Gati Shakti, the inter-linking of many portals (Udyam, e-Shram, NCS and ASEEM) to help MSME with credit facilities, skilling and augmentation, the enabling of post-offices with the core -banking solution, the facilitation of updated returns to correct errors in the original returns for up to two years and creating a pathway for world-class foreign universities and institutions in selected fields to be set up in GIFT city are but few of the examples. The assumption of 11.2 percent as the growth rate of GDP at current prices might strike many as being too conservative especially given that the Economic Survey for 2021-22 projects a figure of between 8 and 8.5 percent as the growth rate for GDP at constant prices. If anything, the chances of this projection being exceeded are higher than the chances of undershooting it, given that real GDP contracted q/q in 1Q2021-22. That sets up a positive base effect for 2022-23. However, depending on the impact of the omicron variant on economic activity could be weaker in the last quarter of the current fiscal year. If multiple external shocks impact the Indian economy in 2022-23 (oil price shock, Fed's monetary policy normalisation impacting global financing conditions, etc.), then 11.2 percent might not appear as conservative but prudent.

Capital expenditure by the government will rise 36 percent over the revised budget estimate (and 35.4 percent over BE 2021-22), after one excludes the cash infusion of nearly Rupees 52000 crores into AIR INDIA. It includes Rupees 1.0 lakh crores of 50-year interest-free loans to state governments to undertake capital infusion. It includes incremental (over last year's 65000 crores of Rupees) budget support of Rs. 69000 crores provided as equity) to the National Highways Authority of India. All of this information is in the public domain. If State governments were allowed these Rupees 1.0 lakh crore as an additional borrowing limit, they will bear an interest rate that is higher than the rate at which the Union Government borrow. Further, the money can be used for revenue expenditure. This interest-free loan, dedicated as it is to capital expenditure, incentivises it. The fact that states' capex up to November 2021 was 67 percent higher than in the same eight months of the previous financial year supports this 50-year interest-free loan purely for capital expenditure purposes. NHAI's capital investments in recent years have been considerably financed by borrowings and this has increased its interest burden. By providing enhanced budgetary support, the government is strengthening NHAI to remain a financially viable entity while ensuring continued investment in national highways. As far as USD 5 trillion economy is concerned, India is the fastest growing large economies in the world.

Depending on how exchange rate move Indian Rupee would remain stable to strong given what is going on the developed world. If we continue to retain the path of 8-9 per cent real GDP, it would translate into 8 per cent dollar GDP growth. If we extrapolate that we should be at the USD 5 trillion by 2025-26 or 2026-27. So, we have enough cushion to help the demand recovery. Economic stress is high because of the pandemic cloud, which is still keeping people uncertain and restrained in their spending. Once the pandemic cloud lifts, the consumer sentiment and spending habits would come back to a normal growth pattern. Crude oil is a bigger risk for the economy, bigger than a hawkish Federal Reserve, and monsoon. While monsoon is too early to talk about and regardless of how taper proceeds in the US, the fall out on India should be very, very manageable, which leaves crude oil, which is a "risk the world economy faces and not just India. Once confidence and cheer crowd out the pandemic-induced concern that is currently clouding the minds of the citizens, then the various measures announced and the capital investments envisaged in the budget will succeed in crowding in private investments.

Quad foreign ministers resolve to keep Indo-Pacific free from coercion

The Quad foreign ministers on Friday vowed to ramp up cooperation to keep the Indo-Pacific region free from bullving, opposed "coercive" economic policies, denounced the use of terrorist proxies for cross-border terrorism and asserted that Afghan territory should not be used to threaten or attack any

The Ukraine crisis was also discussed at the fourth meeting of the Quad forministers Melbourne with US Secretary of State Antony Blinken saying that Russia would face "massive consequences" if it renewed aggression towards the Eastern European nation and that Washington is following an approach of diplomacy and dialogue to

resolve the issue. At a joint media briefing with his counterparts from the US, Australia and Japan, External Affairs Minister S Jaishankar said an agenda seeking to further the Quad's shared vision of a free, open and inclusive Indo-Pacific is being pur-

sued to ensure peace, stability and economic prosperity in the region. "As leading democracies, we pursue our shared vision of upholding a rules-based international order free from coercion, one based on respect for territorial integrity and sovereignty, the

freedom of navigation in the international seas, and peaceful resolution of disputes," he said in his remarks at the meeting. He said there is ample

scope to work together on global issues such as terrorism, cyber security, maritime security, and disinformation and that India continues to pursue an "agile" and multidimensional strategy towards the Indo-Pacific. "In the meeting, we reaffirm the Quad's commitment to supporting Indo Pacific countries' efforts to advance a free and open Indo-Pacific -- a region which is inclusive and resilient, and in which states strive to protect the interests of their people, free from coercion," a joint statement said with a veiled reference to China's bullying in region.

SC seeks to know if cases pertaining to quota in pvt sector be considered together

New Delhi. Feb 11 (PTI):

The Supreme Court Friday sought to know whether parties concerned are agreeable that cases pertaining to quota in private sector on the basis of domicile be considered together. Building collapses in north Delhi, 2 women pulled out of debris

New Delhi, Feb 11 (PTI):

Two women were pulled out of the debris of a building which collapsed in north Delhi's Bawana area on Friday afternoon and efforts are on to rescue others who are underneath the rubble, police said. The fire department officials received information about the incident at 2.48 pm, following which three to four fire tenders rushed to the spot.

The police were informed that the building near the Delhi Jal Board had collapsed and four to five people are reportedly buried under debris. The police rushed to the spot

and found that the collapsed building was the part of Rajiv Ratan Aawas in which there were about 300 to 400 flats, a senior police officer said. Three JCB, one hydra machine and two ambulances reached the spot and rescue operation was started, they said.

"Two women -- Fatima and Shahnaaz -- both residents of JJ Colony, Bawana were taken out of the debris and sent to MV hospital Pooth Khurd. EC warns U'khand BJP to be more careful

Commission (EC) has warned the Uttarakhand BJP to be more careful in the future and advised it to follow all provisions of the poll code, days after it tweeted a morphed picture of Congress leader Harish Rawat.

Last week, the poll panel had issued a notice to the Uttarakhand unit of the Bharatiya Janata Party (BJP) for tweeting a morphed image of former chief minister Rawat, in which he was shown as a Muslim cleric. An EC order issued

on Wednesday said the Uttarakhand BJP has submitted that the purpose of the tweet was neither to violate any provisions of the Model Code of Conduct nor to create any differences between groups on the basis of religion, race, caste and language.

It has also told the poll panel that the tweet has since been deleted from its official Twitter handle. The EC said it has not found the reply of the Uttarakhand BJP satisfactory. The order noted that an FIR has been lodged under various sections of the Indian Penal Code (IPC) and the

Representation of the People Act in connection with a Facebook post, which "will follow its logical conclusion". "Now, therefore, the

Commission warns the Bharatiya Janata Party, Uttarakhand to be more careful in future and advises to follow all the provisions of Model Code of Conduct and other guidelines of the Commission in letter and spirit," the order read. The 70-member Uttarakhand Assembly is scheduled to go to polls on February 14 and the counting of votes will be taken up on March 10.

Man hit by car, dragged on bonnet for over 100 metres

Ex-bureaucrat's son held

New Delhi, Feb 11 (PTI):

The son of a retired bureaucrat was arrested for allegedly hitting a man with his car and carrying him on its bonnet for over 100 metres in south Delhi's Greater Kailash area, police said on Friday. The police has also arrested the bureaucrat under section 212 (harbouring offender) of the Indian Penal Code, they said.

The injured man, Anand Vijav Mandelia (37), is a city-based businessman and being treated at the Max Super Specialty hospital. He is under observation but out of danger, police said. In the video of the incident, which was widely circulated on the social media, the man is seen

being carried on the bonnet of the car which was being driven rashly. The victim was carried on the bonnet for over 100 meters, police said. The accused, a law student, has been identified as Raj Sunderam, they said. The police identified the vehicle and seized it.

"Sunderam was arrested from outside the Le Meridian Hotel, Gurgaon in Haryana. Sections 308 (attempt to commit culpable homicide), 307 (attempt to murder) and 212 (harbouring offender) of the Indian Penal Code have also been added in the case on the basis of facts that emerged during the investigation." Deputy Commissioner of Police (south) Benita Mary Jaiker said.
