#### **Patidar case**

New Delhi: The Supreme Court Friday granted bail to BJP leader Hardik Patel in a case lodged against him in connection with the violence during the Patidar stir in Gujarat in 2015 subject to his "diligent participation" in the investigation. A bench of Justice A S Bopanna and Justice Hima Kohli made its earlier order granting protection to Patel absolute, "This court had in February 2020 issued notice and had granted interim protection. Threeand-a-half years have passed since then. In these circumstances, we see no reason to alter the order at this juncture.

#### **Pilot saching**

■ Jaipur: Rajasthan Congress MLA Ved Prakash Solanki on Friday said some leaders are trying to sideline Sachin Pilot, without whom the party's return to power is not possible. "Sachin Pilot is not going to leave Congress and he is loyal to the party. But, some leaders are trying to sideline him. Returning to power is not possible with Pilot sidelined," Solanki told reporters here. Solanki is a Pilot's loyalist and was one of the many who had revolted against Gehlot in the 2020 political crisis. Solanki stressed that Congress can repeat its government only through collective efforts. and it should make credible people the face

of the party.

■ New Delhi: A Delhi court is likely to pronounce on Saturday its order on framing charges against Aaftab Amin Poonawala, accused of strangling his live-in partner Shraddha Walkar and chopping her body into pieces. The Delhi Police is also scheduled to file tomorrow its reply to an application of Walkar's father before the court, urging it that her remains be handed over to the family for last rites as required by tradition and culture.

#### Speedboat capsizes

■ Pekanbaru: A speedboat carrying 74 people capsized in rough seas in western Indonesia, killing at least 11 and leaving one person missing, officials said on Friday. Many of the dead were women and children, said Nyoman Sidakarya, chief of the Pekanbaru Search and Rescue Agency. He said 62 people had been rescued, including some who were unconscious after drifting in the choppy waters for hours.

### SC directs all states, UTs to register cases against those making hate speeches even in absence of complaint

New Delhi, Apr 28 (PTI):

Extending the scope of its 2022 order beyond three states, the Supreme Court on Friday directed all states and Union Territories to register cases against those making hate speeches even if no complaint has been made. A bench of Justices KM Joseph and BV Nagarathna termed

hate speeches a "serious offence capable of affecting secular fabric of the country". The bench said its October

21, 2022 order shall be made applicable irrespective of religion and warned any delay in registering cases will be treated as contempt of the court. "Where have we reached in the name of religion? What have we reduced religion to is really tragic," the apex court had then observed and directed Uttar Pradesh. Delhi and Uttarakhand to crack down hard on those making hate speeches, calling them shocking for a country that is reli-

gion-neutral. Holding that Constitution of India envisages a secular nation, the court had directed Uttar Pradesh, Uttarakhand and Delhi to promptly register criminal cases against the offenders without waiting for a complaint to be filed.

On Friday, the bench said, "The judges are apolitical and not concerned with Party A or Party B and the only thing they have in mind is the Constitution of India".

It said the court has been entertaining petitions against hate speeches in different

#### IED defused



# **SC** provides big relief to IAS Anil Tuteja

Puts stay on any action by ED against him, next hearing in this case on July 13

Raipur, Apr 28: Supreme Court has given big relief to IAS officer from Chhattisgarh Anil Tuteja, as the ED team conducting investigation into money laundering and liquor scam in the state would not be able to arrest him now. In order to save themselves from ED's arrest. both Anil Tuteja and his son Yash Tuteja has knocked at SC's door. After hearing into father's and son's petition in the Supreme Court (SC), the above instructions were given. In the hearing done in Divisional bench o Ehsanuddin Amanullah in SC on Friday, the petitioners held the action being taken by ED as incorrect.



taken by ED in money laundering act does not have sufficient proof and basis. In the petition it was mentioned that the ED is not giving information as to how the petitioner has generated illegal or disproportionate income and how they have spent it. The advocates of the petitioner said that as per ED's rules, the case is registered only after defining all the points and to which the ED is now adhering to in such cases. Books from the Depot of Textbook Corporation have been started to be supplied to high schools and educational institutions for distribution to the students of class 1st to 10th of government, recognized and pri-

Textbooks have been dispatched from Ambikapur, Raigarh and Jagdalpur depots to all the high schools under its jurisdiction. According to the information received from the Education Department, the new education session in the state will start from June 16. As per the instructions of Chief Minister **Bhupesh Baghel and Education** Minister Dr. Premsai Singh Tekam, free books and uniforms

are to be distributed ceremonially on the opening day of the academic session itself.

Keeping this in mind, the education department has started sending printed books to district depots and from there to high schools and educational institutions. Out of 4611 high schools of the state, books have been sent to 3802 high schools for distribution to the students. Similarly, books for primary and secondary school students have

reached 1032 out of 5704 complexes in the state.

The process of delivering books to the remaining high schools and clusters is in the final stage, which is expected to be completed in the next one week. Books are also being sent to Swami Atmanand Excellent School as per the demand. So far books have been sent to 82 Atmanand schools. Books have reached 1051 out of 1559 high

He further challenged the Bharatiya Janata Party (BJP) leader, saying, "If you throw stones at me, I will use those to build houses for the poor."

Addressing a gathering after visiting an inflation relief camp in Rawatsar town of Hanumangarh, Gehlot said Shekhawat's friends are in jail in connection with the scam and the Union minister is also

guilty, either he should resign on moral grounds or Prime Minister Narendra Modi should sack him.

At the BJP's Aakrosh rally Chittorgarh on Thursday, Shekhawat said, "If you want to end (the rule of) Ashok Gehlot, this Ravan of politics in Rajasthan, raise your hands and resolve to establish Ram Rajya in the state."

Reacting to these remarks, Gehlot on Friday said, "Nowadays, Union minister Gajendra Singh Shekhawat and other BJP leaders have started abusing me. Am I Ravan? You (Shekhawat) looted 2.5 lakh people in the Sanjeevani Society and they got ruined. Your friends are in jail. You can also go to jail anytime."

Chandrashekhar, in his plea, said the punishment tickets will come into effect from May 1 and will be valid till May 15 and the superintendent Mandoli jail has approved

The plea said prisoners get to communicate with their family members and loved ones through mu-

cility' Chandrashekhar was able to communicate with his ailing mother only through phone-call facility as she was not allowed to travel due to various

health issues. "If the order is executed, it will deprive the petitioner from availing these basic and important facili-

# **BBC chairman resigns over UK** ex-PM Boris Johnson loan inquiry

BBC chairman Richard Sharp resigned on Friday after a report into whether he failed to properly disclose his involvement in the facilitation of a loan to former British prime minister Boris Johnson was published.

The 67-year-old former banker, who has been the chairman of the UK taxpayer-funded licence fee-British Broadcasting Corporation (BBC), said the investigafound he breached the governance code for public appointments. The independent review, led by barrister Adam Heppinstall, looked



at Sharp's appointment and his involvement in facilitating an 800,000-pound loan to Johnson.

"Mr Heppinstall's view is that while I did breach the governance code for public appointments, he states that a breach does not necessarily invalidate an appointment," Sharp said

"Indeed, I have always maintained the breach was inadvertent and not material, which the facts he lays substantiate

Nevertheless, I have decided that it is right to prioritise the interests of the BBC I feel that this matter may well be a distraction from the Corporation's good work were I to remain in post until the end of my term. I have therefore this morning resigned as BBC Chair to the Secretary of State, and to the Board," he said. "To chair this incredible organisation has been an honour," he added. Heppinstall was appointed by the UK's Commissioner

appeared in The Sunday Times' newspaper.

Sharp said the report finds he did not play "any part whatsoever in the facilitation, arrangement, or financing of a loan for the former Prime Minister".

But he said with hindsight he should have disclosed his role in setting up a meeting between UK Cabinet Secretary Simon Case and Sam Blyth a businessman who was offering the then Prime Minister financial help to the appointments panel during the scrutiny process ahead of him taking up the senior role at the 100-year-old public broadcaster.



#### **NAXAL BLOOD BATH**

#### **A Multi-Pronged Approach Needed**

he Naxal attack in Dantewada district that killed 10 security personnel and a civilian driver highlights the need for both the Central and state governments to intensify their efforts to combat the Maoist insurgency. The attack, which was carried out using an improvised explosive device (IED) with an estimated 50 kg of explosives, is a stark reminder that the Naxalites have no qualms about killing the very tribal people whose rights they claim to be fighting for. It is time for the government to up the ante against this menace. The National Policy and Action Plan on Left Wing Extremism (LWE), approved in 2015, envisages a multi-pronged strategy featuring security-related measures, development interventions, and safeguarding the rights and entitlements of local communities. This approach has yielded positive results, with incidents of LWE violence in the country dropping by 77 per cent between 2010 and 2021. The count of civilians and security personnel who lost their lives dropped by 85 per cent during this period. These results indicate that the government's citizen-centric initiatives, such as expanding the road network, improving telecommunication connectivity, skill development, and providing better financial services to the residents, are paying dividends in LWE-affected states. However, the new attack in Dantewada highlights the need for the government to remain vigilant and not be complacent. Chhattisgarh, which is going to the polls later this year, must step up its vigilance, as there is a likelihood of more violence in the run-up to the Assembly elections. Greater involvement of the local tribal community in the anti-Naxal campaign can be of immense help. The District Reserve Guard (DRG), a special force of the Chhattisgarh police, was formed in 2008 to carry out anti-Maoist operations in the state. It has mostly inducted local tribals in the force, especially from the Bastar region, and has performed several successful anti-Maoist operations there. However, it is clear that standard operating procedures were not followed in the attack, and security forces must receive specific intelligence inputs and sanitize the route before moving forward during an operation. The use of a Road Opening Party (ROP) to ensure there is no threat to the convoy can also be helpful. The Maoists' annual strategy involves conducting Tactical Counter Offensive Campaigns (TCOC) between February and June, during which the focus of the military wing is to inflict casualties on security forces. This period is chosen because once the monsoon sets in July, conducting offensive operations in jungles becomes difficult. Almost all major attacks by Maoists on security forces, including the 2010 Chintalnar massacre where 76 CRPF personnel died, have happened during the TCOC. Out of the 10 deceased personnel in the recent attack, eight were residents of Dantewada district, while one each belonged to neighboring Sukma and Bijapur districts. Some of them had joined the force after quitting Naxalism. The DRG personnel are mostly recruited from the local tribal population and Naxals who have surrendered in the Bastar division. Chief Minister of Chhattisgarh, Bhupesh Baghel, has vowed to intensify the fight against the Naxalites and not let the martyrdom of the jawans go in vain. Baghel said that in the last four years, 75 camps (of security forces) have been set up in the core areas of Naxalites, while earlier the camps were established only in buffer areas. Roads are also being constructed in the interiors pockets of the Bastar division, and police camps are being set up. However, this attack serves as a brutal reminder that the Naxalites remain a formidable threat, and the government must not let its guard down. The fact that they were able to carry out this attack despite the security measures in place indicates that there are still gaps that need to be addressed. One of the key challenges in the fight against Naxalism is the lack of development in the affected areas. The Naxalites have long exploited the grievances of the local population, who have been left behind in the country's growth story. It is important for the government to continue its efforts to bring development to these areas, and ensure that the benefits of development reach the people who need it the most. This can help in weaning away the local population from the Naxalites, and reducing their support base. Another important aspect is the need to improve intelligence gathering and sharing. The fact that the Naxalites were able to track the movement of the DRG convoy suggests that they have access to information that they should not have. There is a need for better coordination between the intelligence agencies at the Centre and the states, and for timely sharing of information. This can help in preventing such attacks in the future. It is also important for the security forces to be better equipped and trained to deal with the Naxalites. The Maoists are known to use guerrilla tactics, and it is important for the security forces to be able to counter them effectively. This requires not just better weapons and equipment, but also better training and intelligence gathering. There is a need for greater cooperation between the Centre and the states. Left Wing Extremism is a problem that affects several states, and it is important for the Centre and the states to work together to address it. This requires a coordinated strategy that takes into account the specific challenges faced by each state, and the resources available to them. The National Policy and Action Plan on LWE is a step in the right direction, but more needs to be done to ensure that it is implemented effectively.


### **Perils of Divisive Campaigns**

#### Personal Attacks on Modi Won't Help **Congress in Karnataka Elections**

he upcoming Karnataka assembly elections have been the subject of much speculation and analysis in recent weeks, with both major political parties, the Bharatiya Janata Party (BJP) and the Indian National Congress, scrambling to secure votes in what is expected to be a closely fought contest. But the remarks by Congress President Mallikarjun Kharge, comparing Prime Minister Narendra Modi to a "poisonous snake," have raised eyebrows, with many observers questioning the wisdom of such personal attacks. It is true that such attacks have a long history in Indian politics, and have often been used by rival parties to score political points. However, the evidence suggests that such tactics have generally not paid off for the Congress in the past, and are unlikely to do so in the upcoming elections. The Congress has a long history of using personal attacks against Modi, dating back to his time as Chief Minister of Gujarat. In 2007, then Congress President Sonia Gandhi called him a "maut ka saudagar" in reference to the Godhra riots, a term that Modi subsequently used to his advantage in the Gujarat elections. Similarly, during the 2014 general election campaign, Congress leader Mani Shankar Aiyar used a "chai wala" jibe against Modi, which the BJP turned to its advantage with the "Chai pe Charcha" campaign. In 2017. Aivar again courted controversy by calling Modi a "neech aadmi", a remark that Modi turned into a casteist slur and used to his advantage in the Guiarat elections. Most recently, during the 2019 general election campaign, Congress leader Rahul Gandhi used the "chowkidar chor hai" iibe against Modi. in reference to the Rafale deal. Once again, the BJP countered this attack with its "main bhi chowkidar" campaign, which proved highly successful in the polls. Given this history, it is hard to see how Kharge's remarks about Modi being a "poisonous snake" will help the Congress in Karnataka. In fact, many observers believe that such attacks may actually hurt the party's chances, by alienating moderate voters who may view such comments as crass and unbecoming of a major political party. Moreover, the Congress is already facing an uphill battle in Karnataka, with the BJP widely seen as having the edge in the polls. The BJP has been running a highly effective campaign, focusing on issues such as corruption and the alleged mismanagement of the state's COVID-19 response by the Congress-led government. The party has also sought to tap into religious and caste-based sentiments, with a particular focus on the Lingayat community, which is seen as a key vote bank in the state. In this context, the Congress would be well-advised to focus on substantive issues, such as jobs, healthcare, and education, rather than resorting to personal attacks on Modi. The party should also seek to build broadbased alliances with other like-minded parties and interest groups, in order to maximize its chances of success in the polls. Ultimately, the Karnataka elections will be a test of the Congress's ability to mount an effective challenge to the BJP's dominance in the state. While personal attacks may be tempting, they are unlikely to be the key to victory. Instead, the Congress must focus on building a broad-based coalition that can mobilize voters across the state and deliver a decisive mandate in its favor. Only then will the party be able to realize its vision of a more just and equitable Karnataka.

No six or four but a lifetime of batting innings geared Sachin Ramesh Tendulkar towards the milestone of fifty on May 24th of this year. He. like Kapil Dev. did not make any offensive stance, kept to himself and was reserved as a traditional fixture by his family members. He also chose his life partner against the flow, who did not know what cricket was: professionally she was a medical practitioner. He led his life not as a celebrity, but as an ordinary person of

this country. He appeared in several advertisements throughout his teenage years with Kapil Dev, meeting the demand through his advertisement. "Master Blaster" and "Little Master" were his nicknames. Sharjah Cricket Ground, Melbourne Cricket Ground, and Eden Gardens are some of his lucky and memorable cricket grounds where he had remarkable, awesome, and unpredictable cricket support and batting performances that are unforgettable. Sachin Tendulkar will always be remembered as a legendary cricket icon.







# Over 120 eminent citizens write to President Murmu opposing legal sanction for same-sex marriages

New Delhi, Apr 28 (PTI)

More than 120 eminent citizens, including retired high court judges and former bureaucrats, have written to President Droupadi Murmu opposing what they called "highly objectionable attempts" to legalise same-sex mar-They said the Indian society and culture do not ac-

cept same-sex behavioural institution as it is irrational and unnatural.

The signatories said they were "shocked" over "continuous onslaught" against the country's basic cultural traditions and religious tenets, in particular, the "highly objectionable attempts" towards legalisation of

institutional relations like that of a marriage is "essentially a legislative function", they said, claiming that the courts should "refrain" from creating or recognising or demolishing the institution of marriage either by way of ajudicial interpretation or striking down or reading down the existing legislative framework for marriages. The issue is being considered by the constitution bench of the Supreme Court and has become a "rallying point" for some "typical pseudo liberals" who are already "divorced" from Indian values under the bogey of "progressive and liberated thinking", they said.

The signatories to the April 27 letter include for-

mer Comptroller and Auditor General (CAG) Rajiv Mehrishi, former home secretary L C Goval. former foreign secretary Shashank, former RAW chief Sanjeev Tripathi, Justice (retired) S N Dhingra and Justice (retired) Lok Pal Singh.

The first round of caste survey in Bihar was conducted between January 7 and 21. The second round started on April 15 and will continue till May 15.

Senior advocate Mukul Rohatgi, appearing for the petitioner, submitted that this is a serious case where the Patna High Court has refused to grant interim relief.

A Delhi court on Friday dismissed the bail application of AAP leader Manish Sisodia in a money laundering case related to the alleged excise policy scam. Special Judge M K

Nagpal denied the relief to Sisodia, saying the stage was not fit to grant him bail.

The judge had reserved the order after hearing arguments on Sisodia's plea seeking relief claiming that his custody was no longer required for investigation.

Enforcement Directorate (ED) had opposed the application, asserting the investigation

The Vishva Hindu Parishad (VHP) on Friday welcomed the Calcutta High Court order for an NIA probe into the violence during Ram Navami in West Bengal, saying this makes it clear that attacks were "preplanned"

The Calcutta High Court on Thursday ordered a probe by the National Investigation Agency (NIA) into the violence at Shibpur in Howrah and Rishra in Hooghly district during and after the Ram Navami celebrations last month.

Alleging West Bengal Chief Minister Mamata Banerjee is believed to have instigated the attacks on the Ram Navami procession, VHP joint general secretary Surendra Jain demanded the NIA should also probe her and the TMC's role in the violence.

Vishva Hindu "The Parishad welcomes Calcutta High Court's order for an NIA probe into the violent attacks during Ram Navami in West Bengal. This makes it clear that the attacks were carried out in a pre-planned manner and was not in any reaction (to some act)," Jain said in a statement. "It was nothing less than a terrorist incident. It's only the NIA which can conduct an extensive investigation into the violence and ascertain the perpetrators," the VHP leader said, alleging "the Bengal police has become a puppet in the hands of the rioters. ### New Delhi, Apr 28 (PTI)

Archaeological Survey of India (ASI) has informed the Delhi High Court that an expert committee has been formed for the conservation, preservation, restoration and proper functionality of the Jantar Mantar observatory here.

The court said it "reasonably" expects the committee to hold its meeting at the earliest for taking steps towards the preservation, restoration and proper functionality of the monument and sought a status report indicating the measures taken by it in this regard.

The court's order came on a contempt petition seeking action against authorities for the non-compliance of a September 2010 high court order, in which the ASI had given an undertaking that Jantar Mantar shall be

made functional and be restored to its original glory to the best of its ability. Earlier this year, the court had directed the ASI to file a report regarding the existing status of the functionality of the instruments at Jantar Mantar. In an affidavit filed in the matter, the ASI sought eight weeks' time for setting up a meeting of the new committee and to furnish the recommendations for conservation, preservation, restoration and proper functionality of the monument. "It is stated in this affi-

davit that the ASI has constituted a fresh expert committee for the conserpreservation, restoration and proper functionality of the Jantar Mantar observatory. It is prayed in the said affidavit by the respondent, ASI, that eight weeks' time be granted for setting up a 'meeting' of the new committee and to furnish to this court the required recommendations to carry out conservation. preservation, restoration and proper functionality of the monument," the court said in its order passed on April 24. However, the petitioner in the contempt case objected to the request, saying there was no informa-

tion regarding the date of the constitution of the committee or its first meeting. He also said the affidavit was "deliberately vague" and there was "inaction" on the part of the authorities Although Justice

Manmeet Pritam Singh Arora observed that the "petitioner's grievance with respect to evasiveness as well as acts or omissions of the respondent is justified" time was granted to the ASI in the interest of

"It is, however, reasonably expected that the newly-constituted committee shall hold the meeting at the earliest so that steps taken for preservation, restoration and proper functionality of the monument can be placed on record before the next date of hearing," the court said in its order.
