Protest

New Delhi: A group of people on Sunday staged a protest against Canadian Prime Minister Justin Trudeau at the Jantar Mantar here, accusing him of supporting Khalistani separatists. The protesters led by United Hindu Front chief Jai Bhagwan Goyal also submitted to authorities a memorandum addressed to the prime ministers of Canada and India, the outfit said in a statement.

Willpower

Darjeeling: Gorkhaland Territorial Administration (GTA) chief executive Anit Thapa on Sunday said that the BJP needs "political willpower" to carve Gorkhaland state out of West Bengal. Thapa, who is also the Bharatiya Gorkha Prajatantrik Morcha (BGP) supreme, asserted that the Gorkhaland issue is known to everyone and there was no need for any tripartite talks (between the Centre, Gorkha parties and West Bengal government).

Landslide

Gangtok: Heavy rain in the hills of West Bengal and Sikkim triggered a landslide that caused a cave-in on the National Highway 10 in Darjeeling district on Sunday, disrupting vehicular movement on the key arterial link between the two states, officials said. Following heavy rain, a massive amount of rocks and slush rolled down the hill and damaged the highway at Sethi Jhora in Bengal, around 30 km from Siliguri, they said.

Rescued

Leh: A tourist from Germany was rescued from a remote area in southern Ladakh after he fell sick during a trekking expedition and made a distress call, police said on Sunday. A police team safely evacuated Cristo, a German national, from Nurbo Sumdo in Nyoma subdivision, 75 km from Korzok, near the Himachal Pradesh border on Saturday evening, the police said.

Cooperation

New Delhi: Ways to expand bilateral maritime security cooperation in sync with fast-expanding India-US strategic partnership figured prominently during Navy Chief Admiral R Hari Kumar's four-day visit to the US, officials said on Sunday. The Chief of Naval Staff visited the US from September 19 to 22 primarily to attend the 25th International Seapower Symposium (ISS).

Terrifying robbery on Sambalpur-Jammu Tawi Exp

Over a dozen passengers assaulted
Belongings worth Rs 76,000 looted

Latehar, Sep 24 (PTT):

Over a dozen passengers were assaulted and belongings worth Rs 76,000 were looted by robbers in Sambalpur-Jammu Tawi Express in Jharkhand's Latehar district in the wee hours on Sunday.

The incident happened around Saturday midnight between Latehar and Barwadih stations under Dhanbad division of East Central Railway (ECR). Around 10-12 robbers boarded the train at Latehar station and threatened passengers by firing in the air near Chhipadohar station, a passenger claimed.

Two passengers, who received bullet wounds, are admitted in

Vikas Mittal, one of the passengers in S9 coach of the train travelling in the 18309 Sambalpur-Jammu Tawi Express said he was going to Vaishnav Devi with family members. About 10 robbers boarded the train at Latehar station

as passengers. They started beating the passengers with rifle butts and did not spare even children and women. Two passengers, who resisted the loot, were hit by bullets on their heads. The robbers snatched mobile sets, ornaments and Rs 75,000 cash from the passengers. They deboarded the train

near Chhipadohar station and carried many suitcases with them.

Senior divisional commercial manager of Dhanbad division Amresh Kumar told PTI, "The incident happened in S9 coach. Seven passengers received minor injuries, while belongings of 13 passengers worth Rs 75,800 were looted." He said an FIR has already been registered. "Around eight mobile phones were also looted. Four of them were found active in the morning. Our technical team is tracing their locations," he said.

Passengers created a ruckus against the loot when the train reached Daltonganj station. The train was stopped there for around two hours. Daltonganj sub-divisional magistrate Rajesh Kumar Shah, who also reached the station last night, said that the injured were admitted to Medinirai Medical College and Hospital. Two of them are little serious, he said.

Modi flags off 9 Vande Bharat trains with new features

Speed and scale of infrastructure development matching aspirations of 140 cr Indians

New Delhi, Sep 24 (PTT):

Prime Minister Narendra Modi on Sunday said the speed and scale of infrastructure development matched the aspirations of 140 crore Indians as he flagged off nine Vande Bharat Express trains connecting religious and tourist destinations across 11 states.

Flagging off the Vande Bharat Express trains via video conferencing, Modi also slammed the previous governments for not paying

adequate attention for modernisation of railways and assured that the "day is not far when Vande Bharat will connect every part of the country". Governors, chief ministers, Union ministers and elected representatives were present at the nine railway stations from where the indigenously built semi-high speed trains were flagged off. The trains

stopped at various stations where they were welcomed by enthusiastic school children and hoards of people with elected representatives addressing functions en route. Union minister Kailash Choudhary and Rajasthan BJP president C P Joshi boarded the Vande Bharat Express train at Udaipur and travelled till Chhittorgarh where a huge

crowd of BJP workers raised the slogans of "Vande Mataram" and "Bharat Mata ki Jai" as the train chugged into the station.

In his address, the prime minister said the popularity of Vande Bharat trains was rising constantly and more than 1.11 crore passengers have already travelled in them.

CID interrogates Naidu for 2nd day in jail

Rajamahendravaram, Sep 24 (PTT):

A team of Andhra Pradesh Police CID officials has concluded its two-day interrogation of TDP chief N Chandrababu Naidu in the Skill Development Corporation scam case on Sunday at Rajamahendravaram Central Prison. The Anti-Corruption Bureau Court had on Friday granted the CID two days' custody of the 73-year-old TDP chief for interrogation in the case. In compliance with the court's orders, Naidu's questioning by CID officials was allowed from 9:30 AM to 5 PM on both days (September 23 and 24) with regular five-minute breaks given to him to consult his lawyer. Coastal Andhra Range DIG of prisons M R Ravi Kiran told PTI that Naidu was handed back to the jail authorities by CID officials after completing their interrogation.

ROW OVER BIDHURI'S REMARKS

Treat Danish Ali as accused, not victim: Ravi Kishan

New Delhi, Sep 24 (PTT):

After Nishikant Dubey, another BJP MP Ravi Kishan Shukla wrote to Lok Sabha Speaker Om Birla on Sunday urging him to examine the conduct of BSP MP Danish Ali, alleging "unparliamentary" acts and use of words by the opposition lawmaker in the House.

With opposition parties demanding stringent action against BJP's Ramesh Bidhuri over his derogatory remarks against Ali in the House on Thursday, Dubey had alleged that the BSP MP had made unsavoury remarks aimed at instigating the ruling party member.

Ali on Sunday termed Dubey's allegations as "baseless" and claimed that after his "verbal



lynching" in Lok Sabha a narrative was being set for "lynching" him outside the House.

In his letter to the Speaker, Shukla said whatever words Bidhuri used against Ali are "unacceptable in any way" but the circumstances that led to the use of "such objectionable" words by an MP against another member of Parliament in the House "needs to be revisited and examined".

'Narrative to get me lynched'

BSP MP Danish Ali on Sunday alleged that after his "verbal lynching" in Lok Sabha a narrative was being set for "lynching" him outside the House as he hit back at BJP leader Nishikant Dubey for accusing him of making unsavoury remarks aimed at instigating the ruling party MP Ramesh Bidhuri.

Bidhuri's derogatory remarks targeting Bahujan Samaj Party (BSP) member Ali during a discussion on the success of Chandrayaan-3 in the Lok Sabha on Thursday triggered a furore, with opposition leaders calling for stringent action against the BJP MP.

A nationwide cleanliness drive will be conducted on October 1 responding to Prime Minister Narendra Modi's appeal for "one hour of shramdaan for swachhata", the Ministry of Housing and Urban Affairs said on Sunday.

In a statement, the ministry said that in the run up to Gandhi Jayanti, a unique call has been given by the prime minister to fellow citizens.

In the 105th episode of 'Mann Ki Baat', the prime minister appealed for "one hour of shramdaan for swachhata" at 10 am on

October 1 by all citizens collectively, and it will be a 'swachhanjali' to Mahatma Gandhi on the eve of his jayanti, it said.

"This mega cleanliness drive calls upon citizens from all walks of life to join in actual cleaning activities of public places like market spaces, railway tracks, water bodies, tourist locations, religious places etc," the statement said. "Every town, gram panchayat, all sectors of the government like civil aviation, railways, information and technology etc, public institutions will be facilitating cleanliness events led by citizens," it said.

'Three proposed criminal laws seek to provide justice rather than punishment'

New Delhi, Sep 24 (PTT):

Union Home Minister Amit Shah on Sunday said the three proposed criminal laws are people-centric, have the flavour of Indian soil and their main purpose is to protect the constitutional, human and personal rights of citizens.

Addressing the International Lawyers' Conference organised by the Bar Council of India here, Shah also said the approach of the three bills is also to provide justice rather than mete out punishment. He appealed to all lawyers in the country to provide their suggestions to the Bharatiya Nyaya Sanhita (BNS-2023), Bharatiya Nagarik Suraksha Sanhita (BNSS-2023) and the Bharatiya

Sakshya Adhiniyam (BSA-2023) so that the country can have the best laws that benefit all.

The three bills, which were introduced in the Lok Sabha on August 11, will replace the Indian Penal Code, 1860, Criminal Procedure Act, 1898, and the Indian Evidence Act,

1872 respectively. "India's criminal justice system was imprinted with colonial law. All three new bills do not have colonial imprint but have the flavour of Indian soil. The central point of these three proposed laws is to protect the constitutional and human rights of citizens as well as their personal rights," he said. Shah said the initiative has been taken to comprehensively change the criminal laws keeping in mind the present-day demands.

"These laws are coming after almost 160 years with a completely new approach and new system. Along with new initiatives, three initiatives have also been taken by the government to create a law-friendly ecosystem," he said.

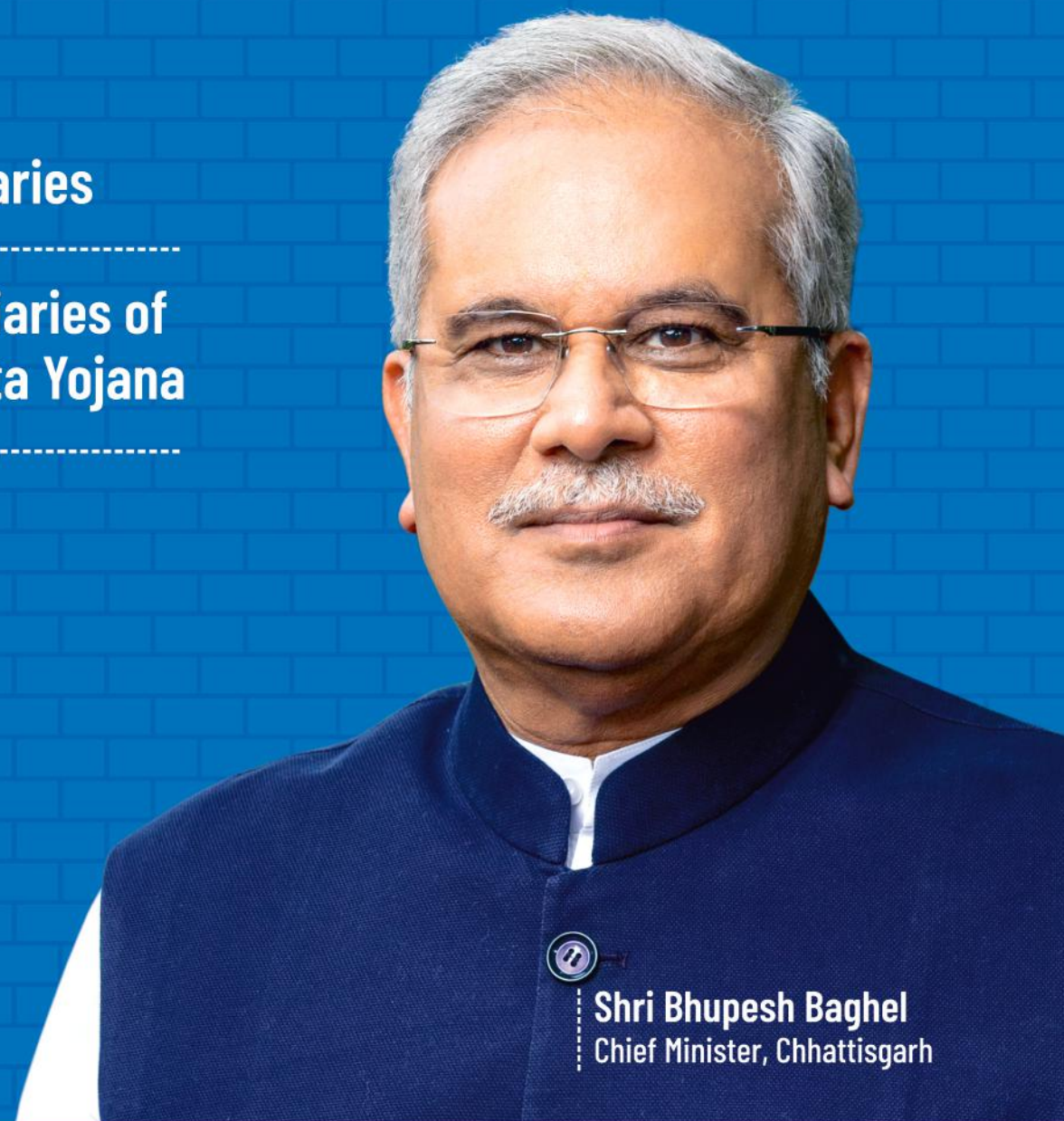

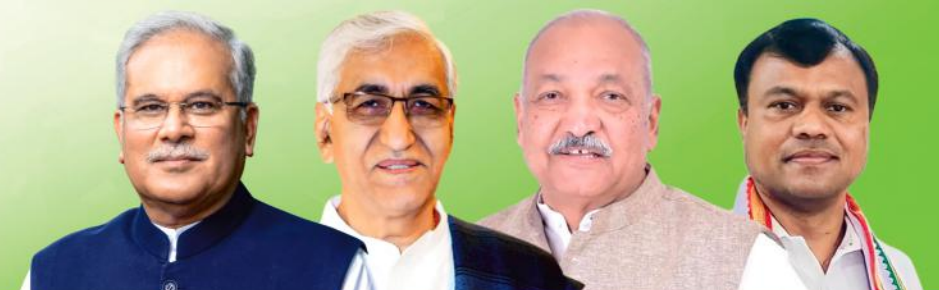

Physiotherapists played a crucial role in removing the adverse effects of COVID in the body: CM

● People should be made aware of the importance of physiotherapy: Singh Deo

Raipur, Sep 24: Physiotherapists played a significant role in removing the adverse effects that occurred in people's bodies after the difficult phase of the Corona pandemic. During that difficult time, we all learned about the importance of physiotherapy. Today, physiotherapy is proving to be very helpful in many cases, including physical pain, paralysis, and neurological disorders.

Chief Minister Bhupesh Baghel was addressing the first 'Physiocon 2023' organized at the Pandit Jawaharlal Nehru Memorial Medical College Auditorium in Raipur today. In this program organized under the aegis of the Indian Association of Physiotherapists, there was a fruitful discussion between physiotherapists and experts from across the state. CM Baghel said that due to increasing material comforts and modern means of transportation, the amount of physical activity in humans has declined, which has led to many problems and diseases. We have to understand that our body needs adequate hard work along with rest to function properly. He said that today, not only has physiotherapy emerged as an important necessity in the field of sports, it has also enhanced the physical ability of players. Baghel said that it can be seen in hospitals that patients suffering from a fracture or experiencing pain are advised physiotherapy. One thing to keep in mind is that physiotherapy should always be conducted under the supervision of a trained physiotherapist. Regular exercise and yoga also keep the body healthy.

Physiotherapy is based on the principle that the human body requires proper movement.

The Chief Minister said that with the present lifestyle, less physical activity and more mental energy are being used, which has increased the importance of physiotherapy. He said that in the last five years, health facilities have expanded rapidly in the state and because of the schemes and commitment of the state government, great achievements have been made in the field of healthcare. The Chief Minister also appreciated the role of physiotherapists during the challenging period of coronavirus disease. On the request of the association, the Chief Minister said that the executive constitution of the Physiotherapy Council should be completed soon. Deputy CM TS Singh

Deo, while addressing the program, said that in the present times, physiotherapy has the utmost importance in the lives of common people as well as in the field of sports. Physiotherapy has become an integral part of sports. Today, sportspeople depend on physiotherapy for better performance. 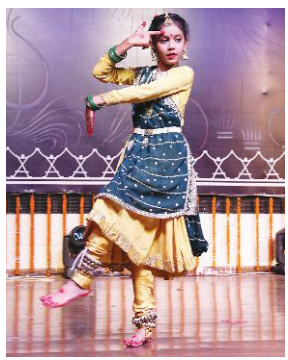
More than 250 hooligans, rowdies paraded in police stations

The accused were found guilty in the court trial. Additional Sessions Judge (Eighth) convicted and awarded life imprisonment and Rs 1000 fine under section 302 and seven years imprisonment and Rs 1000 fine under section 24(1-B)(B), 27 of Arms Act to the accused Kailash Nirmalkar (28) son of Bagas Ram Nirmalkar, a resident of Durga Nagar, Amleshwar, Durg. Additional Government Pleader Pradeep Nema informed that the prison sentences will be served concurrently.

Medicine fraudster arrested, millions worth scam uncovered

Mayank Bajaj, a local businessman engaged in wholesale medicine trading in Golbazar, reported the alleged fraud to the police, leading to the arrest of the prime suspect, Sharad Pade, the proprietor of Swastik Medical Agency in Raipur. The investigation revealed that Sharad Pade had been procuring medicines from Mayank Bajaj's business for an extended period, with a substantial quantity purchased in 2019.



However, after this major transaction, Sharad Pade ceased making any payments to Bajaj, leaving an outstanding amount of Rs 26,80,19,24. As a result of this fraudulent activity, a case was registered against Sharad Pade under Section 420 of the Indian Penal Code at the Kotwali police station, prompting a thorough investigation.

During the course of the inquiry, Sharad Pade confessed to withholding payment for the substantial medicine purchase made from Dhanraj Agency in Gol Bazaar, Jagdalpur, owned by Mayank Bajaj. Subsequently, Sharad Pade was apprehended and presented before the court to face charges related to the fraud.

Community unites for safer roads

Dongargaon, Sep 24:

In the village of Arjuni, a fervent call for road safety resonated as concerned citizens rallied together following a serious road accident that left a schoolgirl injured. The incident, attributed to a substantial pothole on the main road, prompted BJP workers and villagers from neighboring communities to stage a two-hour road block during the afternoon, causing temporary traffic disruption.

The unfortunate incident occurred near Arjuni market on the main road when Kiran Sonkar, a 9th-



grade student at Kisan High School in Gram Barsan Tola, was returning home on her bicycle. A treacherous pothole in the road caused her to lose balance and fall, leading to a collision with a school bus. Kiran suffered a severe head injury and was promptly transported to Rajnandgaon Hospital.

Due to the critical nature of her condition, she was later referred to Raipur. The entire incident was captured by a nearby CCTV camera and quickly circulated on social media, prompting swift action from the community.

In response to the distressing accident, BJP workers, supported by

HC quashes rape charges against BJP MLA's son

Says relationship with tribal woman seems consensual

Bilaspur, Sep 24:

The Chhattisgarh High Court on Friday quashed rape charges against a Bharatiya Janata Party MLA's son accused of sexually exploiting a tribal woman on the pretext of marriage with the observation that it appears to be a case of "consensual relationship".

A bench of Justice Rakesh Mohan Pandey passed the verdict on the petition filed by the accused Palash Chandel, who had sought to quash the chargesheet and subsequent criminal proceedings in the case, the petitioner's lawyer Hari Agrawal said.

The HC also quashed Indian Penal Code section 313 (causing miscarriage

without woman's consent) and provisions of Scheduled Caste and Scheduled Tribe (Prevention of Atrocities) in the case.

It, however, maintained the criminal proceedings under section 323 of the IPC in the case and directed the trial court to take necessary steps, Agrawal informed. Palash Chandel is the son of Chhattisgarh Assembly Leader of Opposition and Janjgir Champa MLA Narayan Chandel. In January this year, a case was registered against Palash Chandel in Raipur after the victim, a government school sports teacher, accused him of sexually exploiting her several times in Janjgir-Champa district on the pretext of marriage.

The victim had also alleged the accused made her undergo an abortion in 2021. She claimed he had assaulted her and refused to

marry her as she belonged to a Scheduled Tribe.

She had complained in this regard to Chhattisgarh State Women Commission before lodging a complaint with Mahila Thana Raipur.

Palash Chandel was booked under IPC sections 376 (rape), 376(2)(n) (committing rape repeatedly on the same woman) and 313 (causing miscarriage without woman's consent) as well as provisions of SC & ST (Prevention of Atrocities) Act. The case was registered as a 'Zero FIR' in Raipur and then transferred to Janjgir Champa police for further action. The police had filed a chargesheet in May before a special court in the district.

In April, the HC had granted anticipatory bail to Palash Chandel in the case. Later, he had filed an instant petition in the HC seeking to quash the chargesheet and subse-

quent criminal proceedings in the case, Agrawal said.

After the final hearing in the case on August 23, the HC had reserved its order, which was delivered on Thursday, he said.

"From the perusal of the contents of FIR and the statement of the victim recorded under section 161 of the CrPC, it appears it is a case of a consensual relationship, as both of them came in contact through social media i.e. Facebook. They were in a relationship with each other for quite some time and enjoyed each other's company," the HC observed.

"The victim is a well-educated lady who knows the pros and cons of such a relationship and entered into it with wide and open eyes based on her consent and volition. It is also not in dispute that the victim has not obtained a divorce from her first husband. Since that is

the indisputable factual position in this case, it cannot be held that the consent of the victim was obtained based on a misconception of fact or fraud," it further said.

The HC said the two were in a relationship for about two-and-half years and added there was no material or document to establish the allegation that he got her pregnancy terminated.

The HC said the petition is allowed in part and the FIR, chargesheet and criminal proceedings are hereby quashed with respect to offences punishable under Sections 313, 376, 376(2)(n) of the IPC and Sections 3(2)(v) and 3(2)(va) of the SC/ST Act.

However, the continuance of the criminal proceedings under Section 323 of the IPC is hereby maintained and the trial court is directed to take necessary steps in furtherance of this order, the HC said.

in order to ensure smoother adoption & acceptance of digital payments by small businesses which are more than 9 crore in India, the transaction charges on digital payments needs to be subsidised by the Government directly to the Banks reliving both traders & consumers from the burden of transaction charges. CAIT National Senior Vice President Mr. Amar Parwani and State President Mr. Jitendra Doshi informed that also opined that National Payment Corporation (NPCI) should run UPI, Bheem etc and a separate Regulatory Authority should be set up for monitoring and regulate the payment industry. He also said that when open network is being created as a policy by the Government then payment industry should also be given open network ensuring best services to the users. Undoubtedly, the Rupey has played an im-

portant role in the Country. Mr. Parwani & Mr. Doshi said that burden of transaction charges is one of the major deterrent in adoption and acceptance of digital payments in the Country and as such steps are needed to incentivise usage of digital payments. It will also help the efforts for bringing informal economy to formal economy. Mr. Parwani & Mr. Doshi suggested that on usage of ATMs beyond three times in a month, a nominal fee should be levied for subsequent cash withdrawal at ATMs. Further, an incentive scheme for greater usage of digital payments needs to be introduced and all sorts of debit and credit cards all other mode of digital payments including POS terminals, M-POS, mobile wallets, mobile applications, QR code, UPI & Aadhar enabled applications should be brought under the ambit of incentive schemes.

Husband appeals SP for justice in case of his wife's suicide case

● **Appeals to appoint two employees of Kalinga company as police captain**

Korba, Sep 24: In the famous private contract company Kalinga, operating in Korba District, SECL, Manikpur, the work of providing jobs was going on openly by paying money, the videos of which went viral in the social media many times. But after this, neither the colliery management nor the famous private contract Company Kalinga paid attention to it. As a result, the wife of a driver working in the same company ended her life by

hanging herself. The deceased was repeatedly requesting the well-known Kalinga Company to employ her husband, but despite this the deceased's husband was not employed. The deceased's husband, Rumel Singh, lodged a written complaint with the Korba District Police Captain and said that his wife Jindi Singh had committed suicide after being fed-up with the torture and harassment by officers Alok Kumar Panda and Prashant Kumar Deori of Kalinga Company Manikpur. Rumel Singh, husband of the victim and the deceased, told that 'I am a resident of Amraiyyapara Bypass



Road Police Post Manikpur. Earlier, I was working as a driver in Narayani Company under Manikpur Coal Field, during this time Narayani Company ended its work and became SECL. Kalinga Company again took charge of the SECL Manikpur project by signing a contract with the SECL management system on the new contract system which was adopted from the Manikpur mine. After taking charge, Alok Kumar Panda and Prashant Kumar Deori started hiring people by taking money. Rumel said that since he was already working as a driver in Manikpur Coal Mines he should have been taken in the post of driver on priori-

ty basis. Despite many requests, initially I was kept being taken around by the said two officers by assuring them of employment and after that they demanded Rs 40,000 from me in the name of getting me a job and it was said that on giving the said amount I would be released. In this regard, assurance has also been given to me in writing by the above two officers. Trusting this, I was forced to withdraw Rs 20,000 from my bank and my wife borrowed Rs 20,000 from her acquaintances and gave it to me. Then I took the said Rs 40,000 in cash and gave it to the two officers, but even after this I did not get employment.

Rumel said that when his wife Jindi Singh, went with him and requested the said two officers several times due to the bad condition of their family, the wife was badly harassed and humiliated by the said two officers and they refused to give me a job. Angered and upset by this, my wife Jindi Singh had gone towards Kalinga Company's office to commit suicide on 6 July 2023 due to the tortures of the above mentioned two officers, but on the way, she committed suicide by hanging herself in Manikpur Coal Mines. It was done for which both the above mentioned officers are fully responsible, he alleged. Not only this, my wife's body remained lying

at the spot from July 6, 2023 to July 9, 2023, because even after a lot of searching, we could not find her. After which, after receiving the information on 9th July 2023, the post-mortem of my wife was conducted by the police on 10th July 2023. Rumel Singh has demanded from the Superintendent of Police that Alok Kumar Panda and Prashant Kumar Deori officers of Kalinga Company Manikpur are responsible for his wife's murder and it was getting fed-up with the torture and harassment by the two, she committed suicide and cime should be registered against the two and punishment be given for forcing her wife to commit suicide.

India's Naval Buildup

Amidst Pakistan-China Submarine Deal

India's maritime security is facing a significant test as Pakistan prepares to acquire eight Chinese Yuan-class submarines between 2023 and 2028. This development has thrust immense pressure upon Mazagon Dock Shipbuilders (MDL) to swiftly finalize a deal for the construction of three additional diesel-electric Kalvari-class submarines, in collaboration with the French Naval Group. The urgency arises from the risk of MDL's submarine-building capacity, currently at 11, becoming idle by year-end. MDL is currently completing the last of the six Kalvari-class submarines, INS Vagsheer, soon to undergo sea trials. Simultaneously, negotiations with the Naval Group are underway for the additional three submarines, which will boast operation-specific features along with indigenous torpedoes and air-independent propulsion (AIP) for extended endurance. Currently, the indigenous torpedoes and AIP systems are undergoing operational validation in France. Pakistan's existing submarine fleet comprises an aging French Agosta 70 (PNS Hurmat) and an upgraded Agosta 90 B (PMS Hamza) equipped with French single-use MESMA AIP technology. Furthermore, it is set to welcome four Yuan-class diesel-electric submarines this year. Of note, the Yuan-class submarines represent a significant advancement, featuring AIP and potentially submarine-launched cruise missiles. The three additional submarines under discussion are expected to outperform the Kalvari-class in terms of advanced capabilities. These submarines, approved for necessity by the Modi government in July, could be up to seven meters longer than the Kalvari-class if the Navy opts for a pure diesel-electric model, accommodating additional batteries for extended submergence. Alternatively, they could be 10 meters longer to house the AIP unit designed by DRDO. These vessels will be equipped with advanced optronic, electronic warfare suites, and heavyweight torpedoes boasting a 40-kilometer range and higher explosive content. Future iterations may also include SM-39 Exocet missiles and SCALP 1000-kilometer range submarine-launched cruise missiles. Furthermore, a recent memorandum of understanding (MoU) between the Naval Group and MDL has opened doors for submarine exports to countries like Indonesia and Malaysia, giving India an opportunity to showcase its Scorpene-class submarines. Collaborative efforts are also underway with Kolkata-based GRSE to build surface combatants, such as destroyers and frigates, for export to third countries. This strategic move ensures that the capacity of these dockyards does not dwindle due to a lack of work orders. Given India's depleting submarine force strength, characterized by aging Shishumar and Sindughosh-class submarines facing spare parts issues, the Indian Navy requires additional sub-surface combatants. These vessels are vital for safeguarding the nation's 7,500-kilometer coastline and establishing a deterrence against regional rivals, namely Pakistan and China. The Kalvari-class submarines have been actively patrolling Pakistan's Makran coast, located a mere six hours from Mumbai. These submarines also played a pivotal role in Operation Balakot in 2019 when they were operationally deployed outside Karachi and Gwadar harbors. As the U.S. anticipates a military crisis in Taiwan by 2027, and with China likely to extend its naval presence in the Indian Ocean by 2025-2026, India's indigenous submarine building capacity assumes paramount importance. This capacity forms a vital component of Prime Minister Narendra Modi's "Atmanirbhar Bharat" plan in defense and security, emphasizing self-reliance and security in these strategic domains.

Equity in SC Reservations

An Imperative Move

The proposition of implementing a sub-quota within the Scheduled Castes (SC) reservation system signifies an essential stride towards rectifying the prevailing imbalance in benefit distribution among these marginalized communities. It is indeed a commendable initiative. The system of reservations was established with the noble intent of offering opportunities for representation in prominent political and bureaucratic positions to the underprivileged and oppressed segments of society. However, the data gathered over the generations since its inception reveals a stark reality - the lion's share of these privileges has consistently funneled into the hands of a select few families or segments that have already reaped the advantages of the reservation system. This unfortunate trend has created a lopsided scenario, wherein the more disadvantaged factions within the SCs have been systematically excluded from access to jobs and educational prospects, resulting in their continued marginalization. The root cause of this predicament lies in the fact that the offspring of those who have secured government positions through reservations invariably hold a significant advantage over their peers. This advantage translates into preferential treatment when it comes to securing reserved seats in prestigious educational institutions and coveted government jobs. It's essential to recognize that the SC community itself encompasses a broad spectrum of distinctions, ranging from sub-groups of agricultural laborers to those who endure the harsh reality of manual scavenging. Consequently, it comes as no surprise that certain segments of the SC population in various states are vehemently advocating for a sub-quota within the overarching SC reservation. They have resorted to legal avenues, with the matter currently awaiting a Supreme Court verdict. The government, too, finds itself at a crossroads, pondering over the merits and demerits of this proposition. While it could await the court's judgment, it also possesses the prerogative to amend the reservation rules autonomously. The timing of this issue is noteworthy, particularly in an election year, where it has taken center stage, particularly in states like Telangana. Here, the Madiga community has raised its voice, contending that the Mala community has disproportionately seized the majority of opportunities available within the SC quota. In light of these developments, it is imperative for the government to address this issue judiciously and promptly. The objective should be twofold: firstly, to guarantee that the original intent of reservations - uplifting the most marginalized and underprivileged - is upheld, and secondly, to ensure that the advantages of this system are more equitably dispersed among the diverse factions that constitute the SC community. The principle of reservations is a powerful tool to address historical injustices and offer a semblance of justice to those who have been systematically oppressed. However, it must evolve with changing times to remain effective. The introduction of a sub-quota within the SC reservation is a step in that direction, aimed at fine-tuning the system to make it more inclusive and representative. The government faces a critical choice. It can choose to adapt and proactively address this matter or await a judicial directive. However, given the urgency and the aspirations of marginalized SC communities, it would be wise for the government to act swiftly. A fair, just, and inclusive society is the collective vision of a thriving democracy, and ensuring equitable distribution within the SC reservation is a vital component of realizing this vision.

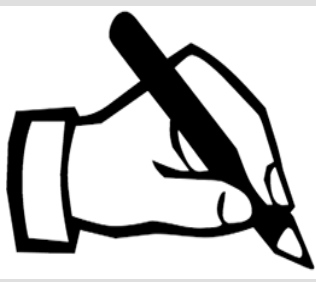

Coaching hub 'Kota' facing the eclipse of innocent suicides?

Some time ago, a heart-wrenching news was in the headlines that in just 24 hours, 3 students of a renowned coaching institute in Kota committed suicide. It is being told that 20 children have sacrificed their lives in the last 11 months. According to a recent news, a student of this famous coaching institute of Kota committed suicide. According to this news, in the last 245 days, 18 students committed suicide in same coaching institute. The figure is shocking. The future generation of the country is having to wither before it can blossom. Some time before, similar news also came from another branch of the same coaching institute located in Jaipur, where first the issue of suicide of a student was heated up and then the issue of two girl students of the same institute leaving the hostel without informing, made headlines in Newspapers. Earlier such incidents were limited to Kota, but now as renowned coaching institutes have started expanding their institutes as branches in other cities of the country, such tragic incidents are gradually becoming common there too. Such accidents are not new in Kota city, which is called Kashi of coaching. Recently, I was saddened to read the painful news of another student committing suicide in the same coaching town of Rajasthan. The student was from Orissa state who was living in Kota for the last six months and taking coaching. It is not new that there is a close connection between Kota

children, have these coaching institutes made any analysis public till date on the causes and prevention of suicides? Do institutions conduct psychometric tests (educational psychological tests) of children to assess their mental ability and intelligence quotient (IQ) before admission? These are the real questions to which neither these coaching institutes nor the administration have the answer. It is often seen that the reasons for these suicides are that immature children are unable to bear the pressure of this blind race of competition and the unlimited expectations of the parents force the students to take such drastic steps. Parents ignore the child's natural and innate talents and abilities and put pressure on their children to achieve things for which the child is not inclined. In such a situation, students become frustrated, either become victims of depression or take suicidal steps like suicide. In the year 2016, according to a news, in the suicide note written by a student after committing suicide in Kota, she made a poignant request to the government to close these coaching institutes. Just think... a child, who has not lived his life and wants to live it, but if the ambitions of his parents and the pressure of studying in coaching institutes take away his right to live, then before whom should he beg for his life? The student is interested in humanities or any other subject but the parents have only one dream that their children become a great surgeon or an engineer from IIT itself, this ambition is responsible for taking the child to this position. It hurts more when even learned intellectuals are seen supporting coaching without exception. The government will have to take strict steps in this direction. If any coaching institute admits students without assessing the mental capabilities of the children and their natural interests, then strict action should be taken against such institutes and such parents also need to be put in the dock

who do not allow their children to study despite knowing about the mental capabilities of people, they put such pressure on them.

This is enough to expose the rules of coaching institutes, our education system and education boards. There is a rule of all the education boards of the country that only those students can give the board examination, who have minimum 75 percent attendance in regular school. How the thousands of students who are taking coaching in the coaching institutes of Kota, while staying in Kota, are achieving 75% school attendance is a big question, the answer to which neither the School Education Board nor our education system can give. Let's understand the mechanism: Because it is not possible that all the students who have enrolled them in some coaching in Kota, take coaching only in the evening and then who is ensuring the attendance of the students, taking coaching in the morning sessions in Kota i.e. during school time? This is a matter of investigation.

It is a strict rule of almost all School Education Boards that no school can admit students in the classes as dummy or non-attending students and if the schools are doing so, then should strict action be taken against them and should their recognition be terminated? Shouldn't it be done? The future of the country is dying, it would not be an exaggeration to call it murder instead of suicide. This highly ambitious civilized society and parents are not ready to introspect even after the suicides happening every day. Hon. Supreme Court of the country will have to come forward to protect the little children so that the flowers do not have to wither before they bloom. Their right to live, see and celebrate the world should be protected at any cost.

Why are simultaneous elections harmful to India's democracy?

There is also a possibility that the federalism of the country will be challenged by simultaneous elections. There is a danger of simultaneous elections blurring these specific platforms and areas of democracy, as well as the risk that state-level issues get subsumed into national issues. If elections for the Lok Sabha and State Assemblies are held simultaneously, there is a greater possibility that regional issues may become secondary to national issues or, on the contrary, national issues may lose their existence in front of regional issues.

Simultaneous elections imply that elections to the Lok Sabha and all state assemblies across India will be held simultaneously, with voting possibly taking place around the same time. The idea of simultaneous elections, or "one nation, one election", was first formally proposed by the Election Commission of India in a 1983 report. Along with some potential benefits of holding simultaneous elections, there are also some drawbacks, which raise the question: Is holding simultaneous elections harmful to India's democracy?

Analysts against One Country One Election believe that the Constitution has provided us with a parliamentary model under which the Lok Sabha and the Legislative Assemblies are elected for five years, but our Constitution is

silent on the issue of holding simultaneous elections. Many provisions in the Constitution appear to be completely contrary to this idea. For example, under Article 2, Parliament can include a new state in the Indian Union and under Article 3, Parliament can create a new state, where separate elections may have to be held. Similarly, according to Article 85(2)(b), the President can dissolve the Lok Sabha and according to Article 174(2)(b), the Governor can dissolve the Legislative Assembly even before five years. Under Article 352, the tenure of the Lok Sabha can be extended by imposing a national emergency in the event of war, external aggression, or armed rebellion. Similarly, under Article 356, President's rule can be imposed in the states, and in such a

situation, the possibility of re-election increases due to an unexpected reversal in the political equation of the concerned state. All these circumstances are completely contrary to one country one election. Holding simultaneous elections would require a constitutional amendment to coordinate the terms of the State Legislative Assemblies with the terms of the Lok Sabha. In addition, the Representation of the People Act as well as other parliamentary procedures would require amendments. The main fear of regional parties regarding simultaneous elections is that they will not be able to raise their local issues strongly, as national issues will take center stage. Additionally, they will not be able to compete with national parties in terms of election expenditure and election strategy. There is also a possibility that the federalism of the country will be challenged by simultaneous elections. There is a danger of simultaneous elections blurring these specific platforms and areas of democracy, as well as the risk that state-level issues get subsumed into national issues.

Blurred attribution prevents voters from holding governments accountable for poor performance or rewarding them for good performance. Having separate elections for different levels of government makes it clear to the voters which level of government is responsible for what and focuses on the performance of the respective government. The result will

be a strong effort to save the government from collapse, even if it would, under normal circumstances, have lost the confidence of the House. There is a possibility of an explosive situation of horse-trading if elections are held simultaneously.

One Nation, One Election would be contrary to the federal structure of the country and would be a fatal step for parliamentary democracy. If elections for the Lok Sabha and state assemblies are held simultaneously, the tenure of some assemblies will be increased or reduced against their wishes, which may affect the autonomy of the states. The federal structure of India is inspired by the parliamentary system of governance and the frequency of elections in the parliamentary system of governance is an irrefutable fact. If elections for the Lok Sabha and State Assemblies are held simultaneously, there is a greater possibility that regional issues may become secondary to national issues or, on the contrary, national issues may lose their existence in front of regional issues. The nature and issues of Lok Sabha and Assembly elections are completely different. While Lok Sabha elections are held to form the national government, Assembly elections are held to form the state government. Therefore, while issues of national importance are given prominence in the Lok Sabha, issues of regional importance remain at the forefront in the Assembly elections.

Democracy is called the rule of the people. Being a parliamentary system

in the country, elections are held at different times and the public representatives have to remain continuously accountable to the public. Apart from this, no party or leader can act autocritically after winning an election because it has to face some elections at short intervals. Analysts believe that if both elections are held simultaneously, the chances of this happening will increase. India is the second largest country in the world in terms of population. Therefore, in the absence of a large population and infrastructure, it does not seem logical to hold elections for Lok Sabha and state assemblies simultaneously.

There are many compelling reasons in favor of simultaneous elections. However, achieving political consensus among different political parties, especially regional parties, is a legal and political challenge in itself. Therefore, there is a need to harmonize the views of stakeholders including national political parties, the Election Commission of India, bureaucrats, academicians, and experts on the proposal of holding simultaneous elections in the country. There is no doubt that India, the world's largest democracy, seems to be surrounded by an electoral maze all the time.

The company is leveraging existing brands and distribution strength for its ready-to-cook and ready-to-eat products in the Convenience & Health segment, a category where consumption has increased in Indian homes, particularly after the pandemic.

Deadline

New Delhi: All individual demat account holders and mutual fund investors have time till September 30, to nominate a beneficiary or opt out of it by submitting a declaration form, failing which their demat accounts and folios will be frozen, and they will not be able to redeem their investments. This mandate applies to both new as well as existing investors, according to the Securities and Exchange Board of India (Sebi). The move is aimed at helping investors to secure their assets and pass them on to their legal heirs.

Agreement

New Delhi: State-owned Oil and Natural Gas Corporation (ONGC) has signed an agreement to sell crude oil it produces from Mumbai offshore fields to HPCL - the second such agreement in as many months, as India's top oil and gas producer prefers term contracts over auctions where refiners hammer deep discounts. In a post on X, formerly known as Twitter, ONGC said it has inked "term agreement with HPCL for sale of crude oil from Mumbai offshore." While it did not give details, sources aware of the matter said the pact for sale of about 4.5 million tonnes per annum of crude oil to Hindustan Petroleum Corporation Ltd's (HPCL) Mumbai refinery.

Investment

New Delhi: Fertiliser cooperative Krishak Bharati Cooperative Ltd (KRIBHCO) is investing around Rs 1,100 crore to set up three ethanol manufacturing plants using maize and broken rice as feedstock. These three plants are being set up in Gujarat, Telangana and Andhra Pradesh with a capacity of 250 kilo litre per day. "We are setting up three bio ethanol plants as part of our diversification plan," KRIBHCO's Chairman Chandra Pal Singh said.

'Govt has 'mismanaged' economy across all sectors'

New Delhi, Sep 24 (PTI):

The Congress on Sunday alleged that the government has mismanaged the economy across all sectors and since it is "too inept" in fixing issues such as unemployment and price rise, it is distorting the data instead.

Congress general secretary Jairam Ramesh said now that the special session of Parliament is over, it is clear that the Modi government was trying to "distract and divert" the nation from some critical issues "the Adani scam, the caste census and especially the rising unemployment, growing inequality and the economic distress".

In a statement, he said no matter how much the Modi government hides the data, the reality is that the vast majority of people are suffering. He claimed that some of the facts re-

ported last week are being "brushed under the carpet". He said RBI's latest bulletin of September 2023 shows the "complete failure" of the Modi government to execute a recovery from the COVID-19 pandemic.

"Forty-three per cent of people were in the labour force in February 2020. Over 3.5 years later, the participation rate remains around 40 per cent. As a matter of grave concern, a report from Azim Premji

University shows that over 42 per cent of graduates under the age of 25 were unemployed in 2021-22," Ramesh said.

In 2022, women were still making only 85 per cent of their earnings before the pandemic, he claimed. "Remember that India was already facing the highest unemployment rate in 45 years before the onset of the pandemic a statistic that the Modi government tried hard to hide from the public domain," he alleged.

The Congress leader highlighted that the prices of essential commodities have been rising sharply impacting the household budget of ordinary families.

"After the uncontrolled spike in tomato prices, now tur dal prices are up 45 per cent from January 2023, and overall pulses inflation has touched 13.4 per cent.

"Apple has plans to increase production in India to over USD 40 billion in the next 4-5 years. It has crossed USD 7 billion in the last fiscal," the official said. An email query sent to Apple did not elicit any reply. Apple manufacturers' iPhones in India and has plans to start manufacturing AirPods from next year. The officer said

scale up existing production levels," the officer said. The company globally sold iPhones worth USD 191 billion and products worth USD 38.36 billion in the wearable, home and accessories segment in the financial year ended on September 25, 2022.

In the first nine months of the current fiscal, the company recorded about a 4 per cent dip in iPhone sales at USD 156.77 billion and a slight decline in the wearable, home and accessories segment at USD 30.52 billion.

The company has become the largest exporter of mobile phones from India. According to industry sources, sales of Apple's iPhone 15 series registered a 100 per cent growth compared to that of the iPhone 14 series on the launch day on Friday.

Why everyone wants a pie of Adani Green Energy

New Delhi, Sep 24 (PTI):

French energy giant TotalEnergies SE's USD 300 million investment in clean energy projects of Adani Green Energy Ltd has taken the total investments poured in by global investors in India's largest renewable power producer to USD 1.63 billion or about Rs 14,000 crore, sources close to the company said.

Last week, Total announced it will hold a 50 per cent stake in the new joint venture firm where Adani Green Energy Ltd (AGEL) will hold the rest. The joint venture will hold a portfolio of 1,050 MW, including 300 MW of already operational capacity, 500 MW under construction and 250 MW under-development assets with a



blend of solar and wind power. Total already has a 19.7 per cent stake in AGEL. It also has an equal joint venture with AGEL, called AGE23L that holds a portfolio of 2,353 MW. The USD 300 million investment Total is making in the joint venture is the first since the Hindenburg report in January highlighted Adani Group's debt pile and alleged accounting fraud and stock manipulation, which Adani de-

nies. Sources said AGEL is one company within the Adani Portfolio, which has attracted a range of investors over the past few months including repeat strategic investor Total, one of the largest emerging market funds GQG Capital Partners and one of the world's largest sovereign funds Qatar Investment Authority. Together these three investors have invested USD 1.63 billion or close to Rs 14,000 crore over the past few months, taking advantage of the attractive valuations post the short-seller report, they said. GQG Partners has taken a 6.8 per cent stake in AGEL while QIA picked up 2.7 per cent. IHC International Holding Company has another 1.3 per cent stake.

'G20 declaration should spur govt to give big push to MSMEs'

New Delhi, Sep 24 (PTI):

The declaration of G20 nations under India's presidency should spur the government to give a big push to the MSME sector by simplifying the regulatory process and enhancing their access to affordable capital, say experts.

Additionally, they seek job security for existing workers when changes are made and the inclusion of a weekly off in the fiscal year 2023-24, with additional compensation for those engaged in work on that day.

Deteriorating road challenges students and residents

Community demands urgent action for improvement

Balrampur, Sep 24: The village panchayat of Tangarmari, nestled in the heart of the Balrampur Development Block, is grappling with the deplorable state of a dirt road that leads to the Jawahar Navodaya Vidyalaya. This issue has grown into a major concern for students, parents, and local residents, making daily commutes to the school a daunting challenge. The problem began when a new Jawahar Navodaya Vidyalaya, constructed at a cost exceeding 23 crores, was inaugurated in Tangarmari last year. Although the school commenced operations,

funds allocated by the central government were solely for the construction of the school building, neglecting the dire need for road development. As a result, no tenders were floated for road construction, exacerbating the road's lamentable condition. During rainy days, the road becomes an impassable quagmire, riddled with potholes and mud. This poses significant challenges, especially to parents who visit the school to meet their children. The temporary principal of the Navodaya Vidyalaya had previously approached the District Collector, urging the prioritization of road construction. Unfortunately, the Collector's transfer, followed by the principal's replacement, left the issue unresolved. On a disheartening note, despite the Gram Panchayat's expenditure of lakhs of rupees to re-



pair the road, no improvements have been discernible. This has raised suspicions among locals, who suspect embezzlement of funds by Panchayat officials. Villagers also allege that the Sarpanch and Secretary have siphoned off significant amounts earmarked for various development projects under

the Gram Panchayat's purview. Notably, the district's pride, Jawahar Navodaya Vidyalaya, lies merely 6 kilometers from the district headquarters. Yet, it remains devoid of proper road connectivity, with neither the district administration nor Panchayat officials addressing the issue.

In response, Panchayat Secretary Mrs. Lalati Ravi claimed that the road had indeed been repaired and was presently in good condition. She attributed the muddy conditions during rainfall to the road's unpaved nature and indicated that a proposal for road construction had been forwarded to the District Panchayat. She expressed optimism that, upon approval and fund allocation, road construction would commence. While a proposal for constructing a concrete road under the Pradhan Mantri Gram Sadak Yojana has been drafted and sent to the District Panchayat, a temporary resolution to address current road conditions is imperative. Coordination with the Panchayat Secretary is advised while awaiting the proposal's approval and subsequent action.

Hangzhou, Sep 24 (PTI):

In a rematch of World Championship final, top Indian boxer Nikhat Zareen outclassed Vietnam's Thi Tam Nguyen 5-0 to move to the women's 50kg pre-quarter-finals while Preeti Pawar (54kg) sealed a place in the quarter-finals of the Asian Games here on Sunday. Two-time world champion Zareen defeated the two-time Asian Champion Nguyen by unanimous decision.

One of only four boxers to not get a first round bye in the 50kg event despite being the reigning world champion, Zareen controlled the proceedings from the word go.

"I had not expected it (to be a one-sided bout) but my plan was to make it one because it's happening in another country and I didn't want to give any chance to her. My plan was to win the first two rounds unanimously and then relax in the third," Zareen said after the win. In the opening two rounds Zareen landed accurate punches, rattling her opponent. Such was her power that the referee was forced to give Nguyen the eight count twice in 30 seconds in the opening round.

Nguyen tried to attack in the second round but Zareen retaliated with strong combination punches, forcing a third eight count upon the Vietnamese boxer. With her work done, Zareen conserved energy in the final three minutes, defending beautifully with the help of her nimble footwork.

With coveted Olympic quotas at stake, Zareen said she is concentrating on qualifying for the Paris

Games first. "I am focussing on qualification first. Then step by step I'll think of final and gold," Zareen said. All four semi-finalists in the light fly-weight category will earn Olympic quotas.

The 19-year-old Preeti, who made the pre-quarter-finals of the World Championships earlier this year, is now one bout away from assuring herself of a medal and an Olympic quota. Playing a strategic

bout, Preeti started the contest on a defensive mode before unleashing her attacking game.

After a sedate start, the Indian went on the offensive and landed perfect jabs and hooks to win the opening two rounds easily. After showing promise initially, Silina faded away and looked at sea as the referee gave her two standing counts in the second and third rounds before stopping the contest.

Nagal, Myneni-Ramkumar enter pre-quarterfinals

Hangzhou, Sep 24 (PTI):

India's top tennis player Sumit Nagal moved to the men's singles pre-quarterfinals of the Asian Games without losing a game as he expectedly thrashed Macau's hapless Ho Tin Marco Leung, here on Sunday. It was expected to be an easy second-round match for the 159th ranked Nagal, whose rival does not even have a ranking on the ATP computer. The fifth seed Nagal, who had got a first round bye, needed just 45 minutes to dispatch his opponent 6-0 6-0. He will next take on Kazakhstan's Beibit Zhukayev, who advanced after his Tajikistani rival Firuz Mukhidinov retired from the contest. Zhukayev was leading 3-0 in the match when Mukhidinov decided to concede the contest. The second seeded Indian pair of Saketh Myneni and Ramkumar Ramanathan outplayed Nepal's Abhishek Bastola and Pradip Khadka 6-2 6-3 in another easy match in their men's doubles opening round that lasted just 57 mins.

Indian women go down to Thailand 0-1

Wenzhou (China), Sep 24 (PTI): The Indian team failed to qualify for the knockout stage of the Asian Games after their 0-1 defeat to Thailand here on Sunday. Indian side fought bravely but a 52nd minute goal from Thongrong Parichat helped Thailand to emerge winner in their Group B match. India had lost their Asian Games opener to Chinese Taipei 1-2. The defeat against Thailand also ended their chances of finishing among the three second placed teams, who will enter the knockouts along with five top-ranked sides, from five groups.

Men's volleyball team goes out of medal hunt

Hangzhou, Sep 24 (PTI): Japan pushed Indian men's volleyball team out of the medal race at the Asian Games with a fluent 3-0 win in a cross-group match here on Sunday. Keihan Takahashi emerged as star performer for Japan by logging 21 points, playing a key role in his team's 25-16 25-18 25-17 victory in one hour and 11 minutes. Erin Varghese was top scorer for India with eight points. Japan will now face China in the semifinals whereas India will play against either Pakistan or Qatar in fifth-sixth place classification match on Tuesday. The Indian team had topped the Group C after winning against Cambodia and South Korea.

Vastrakar takes Indian women to final; to face SL for gold

Hangzhou, Sep 24 (PTI):

Pooja Vastrakar bowled a sharp and incisive spell to take the Indian women's cricket team to its maiden Asian Games final, crushing Bangladesh by eight wickets in a lopsided semifinal here on Sunday.

Right arm seamer Vastrakar, who replaced Anjali Sarvani in the squad just before leaving India, had career-best figures of 4/17 in four overs as Bangladesh were bowled out for 51 in 17.5 overs -- their lowest ever T20 score against the neighbours.

India will face Sri Lanka in the final on Monday. Lankans defeated defending champions Pakistan, who had won the gold at Incheon Games 2014, by six wickets in the semifinals. Against Bangladesh, Vastrakar and her young new-ball partner Titas Sadhu (1/10 in 4 overs) extracted all the juice available from the deck as they bowled quick, with the bounce on offer also helping. Only skipper Nigar Sultana (12) was able to

New Delhi, Sep 24 (PTI):

Exuding confidence about a good showing in the upcoming assembly polls, Congress leader Rahul Gandhi on Sunday said that as of now the Congress is certainly winning Madhya Pradesh and Chhattisgarh, probably winning Telangana, and there is a "very close" contest in Rajasthan which the party believes it will emerge victorious in.

Gandhi also referred to the row over BJP MP Ramesh Bidhuri's derogatory remarks against BSP leader Danish Ali in Lok Sabha, alleging that the BJP indulges in such tactics to distract from the demand for a caste census.

He asserted that the opposition is adapting and working together and the BJP is "in for a surprise in 2024" general elections.

Speaking at a conclave organised by the Pratidin Media Network of Assam, Gandhi also said the idea of 'One Nation, One

Election' was aimed at distracting from real issues of the people.

"It's one of the BJP's distraction strategies," he asserted.

The main issues in India are concentration of wealth, huge inequality in wealth, massive unemployment, huge unfairness towards the lower caste, OBCs, and tribal communities, and price rise, he said.

"Now, the BJP can't contest those. So let's have Mr. Bidhuri make a statement. Let's get together and sort of have elections together. Let's change the name of India'. This is all distraction. We know it, we understand it. And we're not going to let them do it," he said.

He asserted that his party not winning any of the states in the upcoming state polls is out of the question.

Assembly polls are scheduled to take place in Rajasthan, Madhya Pradesh, Chhattisgarh,

Telangana and Mizoram.

Asked about the party's chances, Gandhi said, "I would say, right now, we are probably winning Telangana, we are certainly winning Madhya Pradesh, we are certainly winning Chhattisgarh. Rajasthan, we are very close, and we think we will be able to win. That is what it is looking like, and by the way, that is also what the BJP internally is saying."

The Congress learnt a very important lesson in Karnataka that the BJP wins elections by distracting and not allowing us to construct our narrative

and so we fought the polls constructing our party's narrative.

"What you are seeing today, this gentlemen Mr. Bidhuri and then suddenly Mr. Nishikant Dubey, all this is the BJP trying to distract from the idea of the caste census. They know that the caste census is a fundamental thing that the people of India want and they don't want to have that discussion," the former Congress chief said.

"Every time we bring a point on the table, they use this type of stuff to distract us and we have learnt now how to deal with it," he said.

"What we did in Karnataka is we gave a clear vision for the state, 'this is the social security programme that we are going to set up for you' and then we control the narrative. "If you look at the Telangana polls, we are controlling the narrative, the BJP is not even in the narrative, it is gone. The

BJP has been decimated and it is over in Telangana," Gandhi said.

He claimed that the Congress is controlling the narrative in Madhya Pradesh and Chhattisgarh in the run up to the polls there.

"If you speak to people in Rajasthan on what is the issue in terms of anti-incumbency, they will tell you they like the government," he said.

"We are adapting in a situation where the BJP controls the media. Don't think the opposition is not capable of adapting, we are adapting, we are working together, we are 60 per cent of India's population. BJP is in for a surprise in 2024 (Lok Sabha polls)," he said.

Gandhi also said that the women's reservation bill can be implemented "tomorrow morning" and all that is required to be done is to state that 33 per cent of the seats will be reserved in the Lok Sabha and Vidhan Sabhas.

A Tata satellite cancer care facility in Kathua will therefore prove to be a great boon for the region," he said.

Under the leadership of Modi, he said, satellite hospitals and the facility of Tata Memorial Centre have been started in different parts of the country and in Guwahati, even Onco DM and MCh super speciality courses have been started, which could be contemplated for Kathua as well.

'Percentage of Indians appearing in TOEFL for secondary education abroad rising'

New Delhi, Sep 24 (PTI):

The percentage of Indians appearing in TOEFL to pursue secondary education and certifications abroad has seen a gradual increase over the years while those taking the test for immigration purpose has declined, according to Educational Testing Service (ETS).

The Princeton-based ETS, which conducts the Test of English as a Foreign Language (TOEFL) and Graduate Record Examination (GRE), said the trend reflects the shifting aspirations of the younger demographic. According to data

exclusively accessed by PTI, the percentage of Indian test takers for licensure, certification or to attend secondary school abroad, has gone up from 5.83 per cent of the total aspirants in 2021 to 7.77 per cent in 2022. During the same period, the percentage of Indian test takers appearing in TOEFL for employment or immigration has declined from 8.19 per cent to 7.22 per cent.

Top officials at ETS have confirmed that the trend is being observed since 2018.

The data showed that the percentage of Indians appearing in TOEFL to attend a graduate or post-graduate business pro-

gramme/a graduate or postgraduate programme, other than a business programme, has increased from 70.84 per cent in 2021 to 71.87 per cent in 2022.

"From our data, we observed a growing trend of secondary education students opting for the TOEFL test. This trend is testimony to the shifting aspirations of the younger demographic, especially in their pursuit of international education," Sachin Jain, the Country Manager of ETS India and South Asia, told PTI. There was a 53 per cent growth in Indian TOEFL test takers in 2021 compared to the previous year.

Two tribal communities involved in the conservation of the endangered Western Hoolock Gibbon in Meghalaya have got a shot in the arm with a local coffee and chocolate producer announcing to support their cause.

The Western Hoolock Gibbon is called Huro by the Garo community while people in eastern Khasi-Jaintia Hills call it Huleng.

Dasumarlin Majaw, the proprietor of Smoky Falls Coffee, told PTI that their firm will help in the conservation of the endangered ape found in the forests of the state.

"We are officially

launching the conservation initiative at the World Coffee Conference and Expo, a world-class event for coffee and coffee producers, in Bengaluru on Tuesday. We are excited to be working on something new," she said.

The collaboration for the conservation project was initiated by the Sauramanga Foundation founder Nagakarthish, whose concept of combining Meghalaya's finest coffee/cocoa and conservation efforts of the endangered ape will stand to benefit both parties, she said. Majaw said she could not relate to it at first until she paid a visit to the Huro Foundation project in

Garo Hills last month that felt strongly for the apes.

The Huros are found in several forests of Garo Hills and there are a few of them at the Sonja Wildlife Rescue Centre, where they were brought after rescuing them from people who had held the apes as captive pets.

The Garo Hills Autonomous District Council also had formally identified a village wildlife reserve in Selbalgre village, about 20 km from Tura in West Garo Hills district, which is considered as a habitat for the Huros.

Around 300 km east of Selbalgre, communities in Hima Malai Sohmat (Malai Sohmat chief-

tainship) in East Khasi Hills district are also working on the conservation of the Hulengs (local name for Hoolock Gibbons).
