## **Mathematics In India**

s early Indian as-A tronomers tried to quantify the paths of the sun, the moon, the planets and the stars on the celestial sphere with ever more accuracy, or to predict the occurrence of eclipses, they were naturally led to develop mathematical tools. Thus astronomy and mathematics were initially regarded as inseparable. About 1400 BCE the Vedanga Jyotisa, the first Indian text on astronomy, states itself in 2 different versions:

Like the crest on the head of a peacock, and the jewel on the hood of a cobra, is Jyotisa(astrono-

Wheras Ganita (mathematics) is the crown of the Vedanga Shastras (basically texts on various branches of knowledge).

In fact Jyotisa initially referred to astronomy and mathematics combined; only later did it come to mean astronomy alone and later included astrolo-

### THE FIRST STEPS

As its first steps, India's first urban developments. the Indus or Harappan civilization acquired a high degree of town planning with proportions, angles and degrees all kept in mind. This implies that basic geometric principles were used to their fullest. The discovery of cylindrical compasses made of shell with a slit cut every 45 degrees prove this point.

Though there is no consensus on the dates of the 4 Vedas, (except they are almost 3000 years old ) we find in them frequent mentions of numbers by name, in multiples of tens hundreds thousands and all the way to a million millions, known as 'Parardha' in the Yajur Veda. And by comparison, much later, the Greeks named numonly 10,000(which was

'Myriad') and only in the

13th century was the con-

cept of a million adopted in Europe. This way we were pioneers in mathematics even before the other side of the world comprehended it

### THE EARLY HISTORICAL PERIOD The first Indian corpus

of texts dealing only and only with maths were the 'Sulbasutras', dated between 8th and 6th century. They were written in Sanskrit in the highly concise 'Sutra' style and were, in fact manuals for the construction of fire alters (called 'Citis' or 'Vedis'). The alters often had 5 layers of 200 bricks each, the lower layer symbolizing Earth and the highest, Heaven. Thus they were symbolic representations of the universe.

A few centuries later, Pingala's -'Chandasutras', a text on Sanskrit prosody, made use of binary system to classify the meters of Vedic hymns, whose syllables might be light(laghu) or heavy(guru). Rules of

calculations were worked out to relate all possible combinations of light and heavy syllables, expressed in binary notation, to numbers in one - to - one relationship, worked both ways. In the course of these calculations, Pingala referred to the symbol for Shunya or Zero. Thus we were pioneers for zero or infinity

### THE CLASSICAL PERIOD The classical and post

classical periods were entirely dominated by the unhinged theories of Aryabhatt, Bhaskaracharya, Neelkantha Somayaji, the Kerala School Astronomy, Bramhagupta, Shridhara, Mahavira and Jyeshthadeva ( just to name a few), which were the base of India's golden period along with advents in arts and other prominent and less prominent forms of science.



### ISIS trying to establish foothold in **Pakistan: Ministry of Interior tells Senate**

Islamabad, Jan 03 (PTI):

Pakistan, which is witnessing an influx of Tehreek-i-Taliban terrorists in significant numbers in the restive Khyber Pakhtunkhwa's tribal districts, is also facing a threat from the Islamic State (ISIS) which is trying to establish a foothold in the country, the Ministry of Interior has said.

The ministry's statement came as the Senate was briefed about the escalating influence and activities of the TTP following the withdrawal of US troops from Afghanistan and the inaction of the interim Afghan government led by the Taliban against the banned group.

The interior ministry, in a written response during question hour, highlighted the TTP's reorganisation and operational expansion during the peace talks in 2022, which has significantly increased its militant activities.

'It has given significant rise to its activities and is seeking the support of other militant groups to increase strength and capabilities. It is mostly concentrated in Khyber Pakhtunkhwa, especially merged districts, with foot-

prints in Balochistan and trying to activate its network in the country," it said. It said that the arrival of TTP in significant numbers continues in merged districts, along with the recruitment, training and placing of suicide bombers, is a cause of concern.\ The ministry said Daesh an Arabic acronym for the self-proclaimed Islamic State militant group was also trying to establish a foothold in Pakistan and resorted to terrorist activities against Shias and religious minority communities to ignite sectarian strife. It said fencing along the west-ern borders of Pakistan

had largely been completed to further strengthen the state mechanism of curbing the illegal movement from across the border. However, it pointed out that the two organisations, particularly the TTP, continued to sabotage the fence.

Pakistan started fencing its porous borders with Afghanis tan in March 2017, after facing a spate of deadly attacks from Afghanistan-based militant groups in the pre vious year.

### **A Lesson for All**

Japan's Resilience in the Face of Quakes

apan, a nation perched on the fiery Pacific Ring of Fire, knows all too well the terror that Mother Nature can unleash. On New Year's Day, it experienced yet another reminder of its seismic vulnerability, as a formidable earthquake measuring 7.6 on the Richter scale sent shockwaves through the land of the rising sun. Despite the devastation it brought and over 155 smaller tremors that followed, Japan has emerged from this ordeal with its characteristic resilience. This remarkable resilience is no accident. One of the most critical takeaways is the importance of issuing timely alerts to inform and prepare citizens for impending disaster. Moreover, it is about steadfastly adhering to building bylaws related to quake resistance. Japan's strict enforcement of such regulations has played a pivotal role in minimizing casualties during earthquakes. India, a country with its own seismic vulnerabilities, must take heed and strengthen its commitment to building codes and regulations designed to withstand earthquakes. Japan's experience serves as a poignant reminder that preparedness is the cornerstone of disaster resilience. While we may not have the same seismic activity as Japan, India is by no means immune to natural calamities. We must invest in technology, infrastructure, and disaster management strategies to protect our citizens and minimize the loss of life and property. In a world increasingly defined by climate change and shifting tectonic plates, the lessons from Japan are a testament to the indomitable human spirit and the power of preparation. # Hit and Run Bill will bring a sense of responsibility on Indian roads?

it-and-run cases are those where the driver of the vehicle that causes a road accident flees the scene. It is also proposed to increase the jail term to seven years and a fine for causing death by negligent driving in the Indian Judicial Code, which amounts to culpable homicide. The existing provision under section 304A of the IPC provides for "imprisonment of up to two years or fine or both". These proposed provisions are likely to prove to be a deterrent to errant drivers, who often get away with paying fines or serving lesser jail terms. At present, the accused in hit-and-run cases are prosecuted under Section 304A after their identification and hence they get away with even minor punishment in most of the cases. The new provisions under Section 104 (2) make it mandatory for anyone who causes death to a person by negligence or culpable homicide not amounting to murder and flee the scene of the incident or fail to report the incident. The police officer or magis-

trate immediately following the incident shall be punished with imprisonment of either description for a term which may extend to 10 years.

The hit-and-run case has become a common cause of road accidents in India. In simple terms, hit-andrun accidents can be described as a case where a person while driving hits another vehicle and runs away from the spot. It is the driver's criminal and civil responsibility to report a road accident involving his vehicle. As hit-and-run cases are on the rise in India. it is essential to understand the Motor Vehicles Act. which explains the laws imposed on anyone involved in hit-and-run accidents. Road accident statistics show how roads have become unsafe places for everyone. Hitand-run cases account for more than 30 percent of all road accidents in India, but only 10 percent of drivers involved in hit-and-run accidents are booked. Lack of concern for the safety of another person and reckless driving are comafter causing an accident on the road and leaves the injured on the road, he will be punished with 10 years of imprisonment. At the same time, if the person causing the accident takes the injured person to the hospital, his punishment will be reduced. Along with this, it should also be there in the law that if the general public assaults the driver during an accident, then they should also be punished. Then the driver of the vehicle will guarantee it and will take the victim to the hospital in case of emergency.

Under the new law made by the Central Government, if a driver runs away

mon. The Motor Vehicles Act, of 1988 contains a law that gives strict punishment to a person involved in a hit-and-run accident. IPC sections 279, 304A, and 338 are imposed on victims of hit-and-run incidents.

According to government data, a

According to government data, a total of more than one lakh people died in hit-and-run cases on Indian roads in four years due to reckless driving and hit-and-run cases. Generally at present police investigating officers are trained in IPCrelated sections and are hardly aware of the provisions of the Motor Vehicles Act. Therefore, it becomes all the more important that the police officers also understand the provisions of the MV Act to make it more effective." The proposed bill also provides for the provision of a provision prohibiting speedy or reckless driving, endangering human life, or causing injury to any other person. The same provision of the IPC for causing hurt or likely to cause hurt has been retained. The punishment for such an offense is imprisonment for up to six months or a fine of up to Rs 1,000 or both. It is well known that India has the highest number of accidents in the world. India is one of the most prone countries, with approximately 1,50,000 deaths, which is 10% of all deaths related to motor vehicles

worldwide. According to the World Health Organization, India has the highest number of road accidents worldwide. Even China, the most populous country, is lagging behind us in this matter.

According to the Ministry of Road Transport and Highways report; About 5 lakh road accidents occur in India every year, in which about 1.5 lakh people die. As far as road safety is concerned, discipline is essential. If implemented in the right spirit, the law can not only change the road habits of everyone by imposing harsher penalties but can also try to inculcate a sense of responsibility among the citizens. It will provide an efficient, safe, and corruption-free transportation system after the passage of the hill. Along with this, there is also a provision in the law if the general public assaults the driver during an accident, then they should also be punished. As we were negotiating the price with him, I noticed his impeccable humility and innocent smile. So without opting to negotiate with another driver so as to get a "better deal" in our favour, we chose him. Without belittling the "mainstream" tourists, it is my humble submission that my definition of tourism is stark opposite to their mindset. Landing in a spot, promptly flashing mobiles to take a selfie in front of the chosen peak or fort and immediately posting it in social media to count the number of "Likes" is definitely not my cup of tea.

I would prefer to negotiate dangerous steps to reach the bottom of Bong Bong falls near Tawang, Arunachal Pradesh instead of searching every alley of the Buddhist town to purchase electronic goods at comparatively cheaper price or to have a good bite at restaurants. No wonder why I have to regularly meet blank faces when asking the "tourism lover" where the particular fort (embedded in his glamorous pictorial album) is located - - Jaisalmer or Jodhpur, Bikaner or Barmer. My tourism is not confined within the facade of the Taj or flowers of

Mughal Gardens Srinagar only; but it extends to the history and heritage of the place state country visited with the greatest focus reserved for the culture. lifestyle, general mindset and attitude of the local population concerned. And just like the famous Lalmohan babu or "Jatavu" (one of the three icons of Feluda series of Satyajit Ray), who frantically asked Feluda on their Uttarakhand visit (then Uttar Pradesh) in which exact spot on the Indian map were they stationed and felt satisfied on getting the exact picture; I also always remain inquisitive of the roads streets upon which I am travelling and also minutest details of the surrounding area.

So when our cab driver, Mr.Suresh, started commenting in his own accord that now we are travelling through Lebong Cart Road or Peshok Road or that village in far distance on the Himalayan ridge is actually situated in Sikkim; I got thrilled that I have met my match - - call it luck destiny coincidence or God's will. However it was not running commentary, just a small description at the right place at the right time.

Also the tone was not of "know all" brand, rather a very humble presentation of facts which was enriching my horizon of knowledge that cannot be found readily available in books and brochures. It was he who notified us that we were passing below the Ramkrishna

Mission and even informed us that Sister Nivedita had passed her last days there. This proves that far from mechanically transporting us from one tourist location to another, Mr.Suresh (bearing the stamp of humble economic roots upon his persona) is also intellectually strong enough. On the Darjeeling days, whenever we asked him to report to a particular place and time, he used to reach there at appointed time despite traffic congestion of the hill town with a soft warm smile thereby proving his punctuality and discipline.

How can I forget the honesty of Mr. Suresh who called in his own accord to declare that he has got paid an extra amount of Rs. 1000/-. He could have taken the unfair advantage of my forgetfulness (paying Rs. 1000/- as advance in a fuel station) and pocketed the money, but he didn't do so.

After venturing a spot to start for another, whenever we used to offer him tea, he used to refuse it by saying "I have already taken a cup". And on the day of return to the plains, he stopped at prescheduled Mirik after noon. As I offered him a certain amount so that he can have his lunch while we ventured the lake, vehemently refused. It took me much cuddling to make him accept the amount, such was his non-greedy nature. During return trip to Siliguri, there were lot of scenic spots - - - the

beautiful sleepy hamlet of Lepchajagat to Indo-Nepal border viewpoint offering a spectacular sight of Mount Kanchenjunga (resembling "Sleeping Buddha" from that angle) to series of tea gardens.

Apart from the scheduled spots, he was encouraging us to stop here and there (be it a secluded place where large green valleys can be witnessed or river beds) and enjoy as much as we wish instead of rushing to Siliguri to save his own time. Despite being in driving profession just for sheer money, Mr. Suresh is conscientious enough to give back due enjoyment to the customers/travellers also just like I witness the same mentality in the proprietor-cum-driver of the local car service which we regularly hail since a decade. During Durga Puja pandal-hopping (contract of certain hours at the expense of a pre-fixed amount), Mr. Bappa, of our local area, voluntarily takes us to more Puja pandals (without charging an extra penny) even after time limit if he finds that we haven't seen enough idols due to traffic jams within

Not to speak of his extremely sweet behaviour(not only to customers, but to his subordinates and family members also), humility, sense of timing and ethics. This brings us to a particular Director of our office who was agitated about the driver allotted to him. Yes, that particular driver might have been rude, dishonest, inefficient etc. The Director could have expressed his frustration revolving around his driver as an individual. But, while referring to his driver, the Director bluntly said "Surely you know the "class" of the drivers". And get remembered of that otherwise nice Bangla comedy film where the popular song starts with "Oh what a disgrace, girl of a Bhadralok family escapes with a driver" - - which directly transmits a message that drivers can never be

termed as "Bhadralok".

The rate is valid for a Fixed Deposit (FD) amount over Rs 2 crore and less than Rs 50 crore, BoI said in a statement.

"Globally growth has been negative, international trade is in the negative territory, estimates are that this year international trade may fall, and in that perspective after having grown so rapidly

### **Growth in Asia Pacific** emerging markets to remain strong in 2024: Fitch

New Delhi, Jan 03:

The economic growth in Asia Pacific will remain strong in 2024 and GDP is expected to grow by about 5 per cent in India and a host of emerging market countries, Fitch Ratings said on Wednesday. In its report titled 'APAC Cross-Sector Outlook 2024', Fitch said the outlooks for the banking sectors in India and Indonesia, as well as APAC emerging markets as a whole, move to improving in 2024, partly reflecting the robust economic backdrop, "Economic growth in APAC will generally remain strong in 2024, especially in emerging markets (EMs), supporting sector outlooks across the region. We expect real GDP to expand by, or above, 5 per cent in India, Indonesia, the Philippines and

Vietnam, and China's performance will still be strong by most other countries' standards "Fitch said The Indian economy grew 7.2 per cent in 2022-23 fiscal year. India's GDP expanded 7.8 per cent and 7.6 per cent in the June and September quarters, respectively. Fitch had last month said it expects India to be among the world's fastest-growing large sovereigns, with resilient GDP growth of 6.9 per cent this fiscal, followed by 6.5 per cent in 2024-25. "Robust regional economic growth particularly in Asia's large emerging markets should offset headwinds from slowing growth in China, weak global demand and high interest rates, helping to support performance across sectors in APAC in 2024." # **ONGC** wins 7, Reliance-BP one oil, gas blocks in latest bid round

New Delhi, Jan 03:

State-owned Oil and Natural Gas Corporation (ONGC) won seven areas for exploration of oil and gas while a consortium of Reliance Industries Ltd and BP Plc walked away with one in the latest bid round. Oil Minister Hardeep Singh Puri said 10 blocks for exploration and production of oil and gas were offered in the eighth round of Open Acreage Licensing Policy (OALP-VIII).

Contracts for the 10 blocks were signed on Wednesday morning, he said. Of the 10 blocks offered, ONGC won seven while Reliance-BP, Oil India Ltd and Sun Petrochemicals Pvt Ltd got one area each.



Parallelly, three coal-bed methane (CBM) blocks too were awarded and the ninth round of OALP was launched for bidding. "Estimated investments in awarded blocks for a committed exploration work programme is to the tune of USD 233 million," an official note said. India had offered 10 blocks for

bidding in the eighth round of the OALP in July 2022. After extending the bid deadline a few times, the round closed in July 2023. Five companies -- ONGC, Vedanta Ltd, Oil India Ltd (OIL), Sun Petrochemicals Pvt Ltd Reliance-BP Exploration (Alpha) Ltd -put in 13 bids for the 10 blocks on offer in OALP-VIII, according to the Directorate General of Hydrocarbons (DGH). Seven of the 10 blocks on offer received single bids and the other three blocks had two bidders each. Global energy giants like ExxonMobil, Chevron and TotalEnergies, which India has been courting to give a fillip to exploration and production, did not

## Coal India's supply to non-regulated sector rises 31 pc in Apr-Dec period

New Delhi, Jan 03:

State-owned CIL said its supplies to the non-regulated sector rose 31 per cent to 98 Million Tonnes (MT) in the April-December period of the current fiscal. Coal India Ltd (CIL) supplied 75 MT fuel in the corresponding period of the previous fiscal. "Even as CIL supplies to the country's power sector exceeded the projected commitment, the company supplied an all-time high volume of 98 million tonnes to non-regulated sector consumers till December," the maharatna firm said in a statement. With increased production and maximised supplies through all modes of despatch, the coal offtake to power plants of the country by the PSU rose to 454 MT during the April-December period.

"This is 8 MT higher than the committed quantity of 446 MT for the period. Compared to 433 MT of April-December last year, the increase is 21 MT with around 5 per cent growth," the PSU said. It produced 532 MT of coal in the Anril-December period of FY24, logging a year-on-year growth of 11 per cent. Coal stocks at domestic coal-based power plants have surged to 32 MT at the end of December, 5.6 per cent higher than the year-ago period. "Coal stock at CIL's pitheads was around 50 MT as of December end, 56 per cent higher than the inventory of 32 MT of the same period last year, providing a comfortable buffer against any sudden demand surge," the PSU said. CIL accounts for over 80 per cent of domestic coal output.

## **Govt relaxes certain quality control** order norms for AC industry

New Delhi, Jan 03:

The government has relaxed quality control order (QCO) norms for the air conditioner industry to promote ease of doing business. The order was issued in 2019 and it came into effect from October last year. These relaxations have been given after a detailed stakeholder consultation with the industry. To resolve the issues faced by the industry due to the order, the Department for Promotion of Industry and Internal Trade (DPIIT) has introduced amendments. According to a government notification, Hermetic Compressors of more than 7000 W (2 TR) capacity have been removed from the order for one year for the manufacturers of air conditioning and refrigeration equipment and related parts It has also exempted 200

numbers of goods or articles imported per year for the purpose of research and development by the manufacturers. These imported goods and articles nowever will not be allowed to be sold in the market and should be disposed of as scrap.

"The OEMs (original equipment manufacturers) shall maintain a yearwise record of such goods or articles and furnish the same, if so desired by the Government," it said. Exemption have also been given to 6,000 hermetic compressors and heat exchangers domestically manufactured or imported for maintenance and sales per year by each of the manufacturers. This is "subject to the condition that such manufacturers shall declare its old stock'

of hermetic compressors and heat exchangers, it added. The DPIIT initially issued Air Conditioner and its related Parts. Hermetic Compressor and Temperature Sensing Controls (Quality Control) Order, 2019 on December 5, 2019. The Temperature Sensing Controls were dropped from the list subsequently as requested by the industry due to practi-

cal difficulties. The date of implementation of the QCO was extended three times keeping in view of difficulties faced by the AC manufacturers due to the COVID-19 pandemic, to align with the date of implementation of BEE energy table, nonavailability of adequate testing labs, and inability of BIS to undertake in-person audits of foreign manufacturers due to restrictions on foreign travel.



The 30-share BSE Sensex fell by 535.88 points or 0.75 per cent to settle at 71,356.60. During the day, it tumbled 588.51 points or 0.81 per cent to 71,303.97. The broader Nifty of the National Stock Exchange slipped 148.45 points or 0.69 per cent to 21,517.35. Among the Sensex firms, JSW Steel, Tata Steel, Tech Mahindra, Infosys, Wipro, Tata Consultancy Services, Nestle, HCL Technologies, HDFC Bank and Maruti were the major laggards. IndusInd Bank, ITC, Bharti Airtel and State Bank of India were among



the winners. In Asian markets, Seoul and Hong Kong settled lower Shanghai ended in the green. European markets were trading lower. The US markets ended mostly lower on Tuesday. "The lack of fresh triggers and concerns over valuation influenced investors to stay sidelined. ### Rupee rises 4 paise to close at 83.28 against US dollar Mumbai, Jan 03: RUPEE 15 DOLLAR

The rupee appreciated 4 paise to close at 83.28 (provisional) against the US dollar on Wednesday, supported by easing crude oil prices and foreign fund inflows. However, forex traders said the Indian currency remained under pressure amid a negative trend in domestic equities. At the interbank foreign exchange market, the local unit opened at 83.30 against the greenback. The rupee oscillated between an intra-day low of 83.33 and a high of 83.25 against the greenback and finally settled at 83.28 (provisional) against the dollar, higher by 4 paise from its previous close, even as domestic benchmark indices were trading in a negative note. On Tuesday, the rupee settled at 83.32 against the dollar. "The Indian rupee recouped

The launch programme will start in the first quarter of 2024 with the Streetfighter V4 Lamborghini, followed by DesertX Rally, Hypermotard 698 Mono, and the new Streetfighter V4 range in Q2, it added. The company said it will bring the Multistrada V4 RS and the Diavel for Bentley, which will be brought to India in limited numbers, in the fourth



quarter. 

India collapsed to 153 all out in their first innings in the final session after skittling out South Africa for 55 on the opening day of the second and final Test here on Wednesday.

Virat Kohli top-scored with 46 while captain Rohit Sharma and Shubman Gill made 39 and 36 respectively. India faced just 34.5 overs. They had resumed the posttea session at 111 for 4.

India lost six wickets in 11 balls for no run. They lost their fifth wicket at 153 in 33.1 overs and the next five batters were dismissed in a jiffy without the addition of any run. India, who had lost the first Test in Centurion, are ahead by 98 runs.

Earlier, in a straight spell of nine overs, Siraj picked six for 15 as the South African batters made a beeline back to the dug-out, unable to counter the disconcerting bounce and the movement, both inward and



off the surface. It was also South Africa's lowest total in Test cricket since their readmission into international cricket in 1991.

The security personnel struggled to control them as they shouted slogans against Punia, Malik and Phogat. The protesters were carrying banners that read: 'UWW save our wrestling from these 3 wrestlers'. Soon after the election of new office-bearers, the Wrestling Federation of India (WFI) announced hosting the Young wrestlers hold placards during a protest against wrestlers Sakshi Malik, Bajrang Punia and Vinesh Phogat at Jantar Mantar, in New Delhi, Wednesday, Jan. 3.

## HC pulls up Guj govt over non-payment of compensation

To 16 dead workers' kin

Ahmedabad, Jan 03 (PTI)

The Gujarat High Court on Wednesday pulled up the state government over the non-payment of compensation to the kin of 16 sanitation workers who died during manual scavenging between 1993 and 2014 and directed it to explain the reason in an affidavit. The court of Chief Justice Sunita Agarwal and Justice Aniruddha P Mayee also wanted to know from the state what steps it has taken to adopt the 2013 anti-manual scavenging law, and whether the government was in a position to do away with the practice or still taking the help of sanitation workers for it. The court was hearing a public interest litigation (PIL) filed by Ahmedabadbased NGO Manav Garima, seeking the impleof the

### **MANUAL SCAVENGING**

Employment as Manual Scavengers and their Rehabilitation Act, 2013.

When the petitioner's lawyer informed the court that the family members of 16 deceased manual scavengers were yet to be paid the compensation as per the Supreme Court guidelines, the court pulled up the government and said the latter could not go on making payments to some and leaving out the others.

It directed the principal secretary of the urban development and urban housing department to file his personal affidavit to bring on record the reasons for non-payment of compensation to the families of the 16 workers whose names were included in the list of deceased submitted by the petitioner. The court also took note of another recent incident of manual scavenging in Bhavnagar city adopt the zero manual where a sanitation worker

of the civic body died of asphyxiation while another suffered serious injuries after entering a sewage tank on the campus of the Central Salt and Marine Chemicals Research Institute (CSMCRI) on November 10, 2023.

It permitted the petitioner to implead the civic body as a respondent with a direction for it to file an affidavit to bring on record details concerning the incident. The court also directed the principal secretary to submit a report regarding the same.
