#### Redressal of complaints against entities regulated by RBI

#### Reserve Bank - Integrated Ombudsman Scheme (RB-IOS)

- > The Reserve Bank has mandated all its regulated entities (REs) to have a mechanism at their end to resolve the complaints received by them from their customers, which is considered as the Internal Grievance Redress Mechanism of REs.
- > The Reserve Bank has also put in place an expeditious and cost-free Alternate Grievance Redress Mechanism for resolution of customer complaints relating to deficiencies in services rendered by its REs through the Reserve Bank Integrated Ombudsman Scheme, 2021 (RB-IOS).
- > Banks, Non-Banking Financial Companies, Payment System Participants and Credit Information Companies are considered as REs under the Grievance Redress Mechanism.
- > The RB-IOS adopts a "One Nation One Ombudsman" approach for all complaints against any RE. It is therefore no longer necessary for a complainant to identify under which Ombudsman scheme/office, he/she should file a complaint with the Ombudsman.
- > The complaints against REs not covered under the RB-IOS, 2021 are handled at Consumer Education and Protection Cells (CEPCs) for resolution.
- The list of REs covered under the ambit of RBI-OS and CEPC can be accessed by visiting https://cms.rbi.org.in

#### What to do if you have a complaint?

Complainant must approach the concerned RE with the details of the grievance for redress.

#### When to approach the RBI Ombudsman?

You can approach the RBI Ombudsman, in case of:

- No reply is received within 30 days Anytime within one year and one month from the date of your complaint to RE.
- Unsatisfactory Reply Anytime within one year of receipt of reply from the concerned RE.

Note:

- > The complaint should contain all requisite details / information as mentioned in the RB-IOS.
- The complaint should not have been dealt with / pending with any other forum (like Courts) or dealt earlier by the RBI Ombudsman.

#### How to lodge a complaint?

Complaint against the RE can be filed through any of the following modes:

- Online through the Complaint Management System (CMS) portal of RBI at https://cms.rbi.org.in → File a complaint
- Physical complaint (letter / post) in the form as specified in Annexure in the RB-IOS, 2021 to "Centralized Receipt and Processing Centre, 4th floor, Reserve bank of India Sector-17, Central Vista, Chandigarh 160017"

### How to know more about lodging a complaint with RBI?

- Any person can approach the Contact Centre of RBI for information / clarification on the grievance redress mechanism of RBI and to seek guidance in filing of a complaint / track the status of already lodged complaints.
- Contact Centre personnel are available on all working days from 8:00 am to 10:00 pm for Hindi and English and from 9:30 am to 5:15 pm in ten regional languages (Assamese, Bengali, Gujarati, Kannada, Marathi, Malayalam, Odia, Punjabi, Telugu and Tamil).
- Toll free number (14448) is also available 24x7x365 through Interactive Voice Response System facility.

## **EC directs States to** implement transfer policy strictly

In both letter and spirit

Raipur, Feb 25: Taking serious note of the cases wherein officers are being transferred / posted in the adjacent districts within the same Parliamentary Constituency by the state government. Commission has strengthened its existing transfer policy to ensure that officials are not able to disturb the level-playing fields in the elections.

So plugging the loopholes in the existing in-Commission has directed

that, except for the States / UTs that comprise up to Parliamentary Constituencies, all State shall ensure that officers who are transferred out of the district are not posted within the same parliamentary constituency.

It has been reiterated that the transfer policy of the Commission must be adhered to in both letter and spirit and not just

being camouflaged to show compliance. This rule applies respectively to transfers and postings that have already been implemented in accordance with the Commission's prior instructions.

As per ECI policy, all the officers who were either poster in their home district or have completed three years at a place, have been directed to be transferred. This includes officers who are in any way connected to the election work either directly or in the supervisory capacity.

There has been a Zero Tolerance Policy of the Commission against disturbing the level playing field in the elections. It may be recalled that in the recently held sate assemelections, Commission ordered transfer of various officials even senior level police officials in the state(s), informs Joint Director Election (Media) Commission, New Delhi in a press release.



# ACB/EOW launch raids on premises of 13 people

Raipur, Feb 25:

Chhattisgarh's The Economic Offence Corruption Wing/Anti launched raids on the premises of 13 people, including two former IAS officers and some businessmen, in connection with alleged liquor scam unearthed during the previous Congress government in the state, officials said. The action also covered premises of a businessman in Greater Noida in Uttar Pradesh, they said.

According to ACB/ EOW officials, 70 persons, including several leaders of the Congress, and companies have been named in the FIR registered by the state agency last month in the alleged liquor scam based on complaint Enforcement Directorate which has also been probing the case.

Absconding for 22 years, SIMI operative Hanif Sheikh arrested

Both drivers-loco pilot and assistant loco pilot were not on board the freight train, the officials said. The train gained speed along the way, finally coming to a stop on a steep gradient near Unchi Bassi railway station in Punjab, they said.

Divisional Manager, Jammu, Prateek Srivastava told PTI that "an inquiry has been initiated to know the exact cause of the incident. Prima facie, it seems that the train started rolling down the slope gradient towards Punjab without the driver and his assistant".

He said the train came to a halt near Unchi Bassi due to steep gradient, after covering a distance of more than 70 km.

The officials said that the train was successfully halted with the assistance of sandbags.

Whether the train had been "secured" properly at Kathua on the down gradient is a matter of investigation, the spokesperson said and added that an in-

depth probe is underway.

According to the police, Hanif Sheikh was declared a proclaimed offender in 2002 and has been abscond-

ing for the last 22 years. He was nabbed on February 22 from Bhusawal in Jalgaon district in Maharashtra where he was a teacher in an Urdu school under a different identity, they said.

Deputy Commissioner of Police (Special Cell) Alok Kumar claimed that Hanif was the most notorious and wanted SIMI terrorist who had played pivotal roles in various activities of the proscribed organisation across the country. Police said the SIMI magazine that Hanif Sheikh edited had his name

printed as Haneef Hudai. This was the only lead available with the police, making it difficult to trace him, they said. A case of sedition and under the Unlawful Activities (Prevention) Act (UAPA) was registered against him in 2001 at New Friends Colony police station in the national capital. "A local court declared him proclaimed offender in 2002," Kumar said.

"A team from the Special Cell was tasked with collecting data, information and other digital footprints about the absconding SIMI cadre, sympathisers and sleeper cells across states. The team extensively visited and collected information from various parts of the country," he said. The information collect-

Vaishali Nagar MLA Rikesh Sen, Dr MN Mansoor, Dr Richa Biswas, Laghu Udyog Bharti President Om Singhania, Corporator Mukesh Agrawal, BJP leader Brijesh Bichpuria and other dignitaries were present on the dais. Till now, the ESIC beneficiaries were dependent on an ESIC clinic located in Radhika Nagar. As the facilities were not sufficient, this clinic was working as a referral centre to refer the patients to private and government hospitals. Now the ESIC beneficiaries will get all the medical

treatment facilities at this new hospital.

According to information, the process of recruiting 18 specialist doctors and 38 medical officers is underway. After recruitment of doctors, paramedical staff, nursing and non medico staff, the 100 bed hospital will start functioning.

It needs to be mentioned here that the union government has given approval for ESIC hospital in the year 2016 and its construction was to be completed by 2019. Due to several reasons, the construction work was delayed and has been completed with a delay of about five years.

## Be the Facilitator & Challenge your Team to find Solutions; Results will Follow

■ Former CGM Ajay **Bedi shares his** experiences & insights

Bhilai, Feb 25:

Ajay Bedi who retired from SAIL-BSP towards the end of 2022 as Chief General Manager of Merchant Mill & Wire Rod Mill Services shares his experiences and talks about challenges faced and how decisions and actions he took along with his team impacted the organisation.

"I worked for a total of 37 years in BSP. I joined in 1985 and was posted at Blooming & Billet Mill where I spent 26 years. Thereafter, I worked for brief periods in Rail & Structural Mill and ED (Works) Sectt. This was followed by a longer stint in L&A and finally I retired as CGM (Merchant Mill & Wire Rod Mill) in Nov 2022."

Challenges & Their **Solutions:** The challenges in all the areas were unique in their own way! When I joined BBM in 1985, there was no shortage of manpower. We were 26 executives in Mechanical Maintenance in BBM in 1990 but when I left BBM in 2010, we were only 12 executives and production had improved dramatically.

Moving to Non-Works area and working in L&A was a totally different ball game - the working and the challenges were completely different from Works area. Deployment of cars to Offices of HODs and visiting guests from Vehicle Casual

Contract was a nightmare! Taking care of guests at Bhilai Niwas and catering to their needs was no less challenging because there was no catering contract and the Reception and Housekeeping jobs were



being done by BSP employees. Some of these employees were Plant employees deployed to Bhilai Niwas on Medical unfit grounds. Some catering arrangements had been done with help of Base Kitchen but it was only a stop gap arrangement with lots of anguish to the visiting guests. Thereafter, we explored many possibilities and floated expression of interest. Many vendors participated. We gathered different views and came to the conclusion that good vendors are not interested due to the sprawling 24 acre property at Bhilai Niwas.

We then studied the models followed at other We found that NTPC, NMDC etc had deployed Indian Coffee House to manage their houses. Committees were subsequently formed. One Lower Committee was formed to study the situation and give recommendations. Α Committee consisting of 3 EDs was formed to examine the recommendations of the Lower Committee and make the final recommendation. Both the com-

mittees recommended that

Coffee House) be given all

Niwas - Catering, Front Desk and Housekeeping on Single Tender basis. With management approval, the contract for day-to-day running of Bhilai Niwas was awarded to Indian Coffee House. Even today, I feel that there was no better solution and the outcome is that the visiting guests and local citizens are happy with the arrangement. One SAIL Chairman who visited Bhilai after introduction of Coffee House services commented during his visit that the stay and arrangements at Bhilai Niwas was his best experience at Bhilai! Similarly, we found that

many progressive organisations were leasing vehicles instead of buying or contracting. We went for this model and I take the credit for introducing the lease culture at BSP. The

three related jobs at Bhilai result is that all users are happy with the condition of vehicle which was not

so with contract vehicles. Merchant Challenge During Covid Times: During Covid, it was decided to stop Blooming & Billet Mill. This was a challenge to Merchant Mill because the input section of Billets from BBM was 95X95 mm and 100X100 mm depending on the profile. But the input section from SMS 3 was only as 105X105 mm. To overcome this challenge, the collective of Merchant Mill modified the reheating furnaces and with help of RTS, modified the passes for rolling.

Keep Moving If You **Can** - I wish to say that people should be willing to move to other departments to have better experience. As is said "a roving bee gathers more honey.'

Some More Initiatives Taken - As I mentioned earlier the collective of M/Mill took the initiative to adapt to rolling with SMS#3 billets without any external help MECON/CET and modified their rolling regimes. Similarly, the collective of WRM went for rolling high carbon grades to capture new market when the rolling of rimming grades was stopped due to closure of BBM

My Role - I looked upon my role as 'only being a facilitator' where my team used to accept the chal-

To Improve Key Performances: The workforce has to be given challenging assignments and their morale has to be regularly gauged and boosted as necessary to achieve the targets.

Work Life Balance:

The working in a steel plant is tough with long work hours, being available on call for 24 hours, taking reports in all three shifts and the need to be in touch always at the back of your mind, even on Sundays. It amazes me how other organizations manage with five day weeks, with Tata Steel also implementing it. As for myself, I must say, I could strike a good enough work life balance.

Another 2 naxalites arrested with iron spike and Naxal material in **Dantewada** 

Jagdalpur, Feb 25:

In a significant breakthrough in the ongoing campaign Naxalism, law enforcement authorities have apprehended individuals involved in subversive activities in Bijapur and Dantewada districts.

In Bijapur, as part of the concerted efforts to curb Naxal influence, a joint operation conducted by security forces led to the arrest of four Naxalites in the vicinity of Pondavaya hill water point. The arrested individuals, identified as

4 Naxalites arrested with election boycott pamphlets in Bijapur Pondavaya, were found in possession of election boycott pamphlets, leaflets, firecrackers, and batteries. The ultimate ambition? The bioprinting of entire organs. Recent advancements in 3D printing, bio-ink formulations, and tissue engineering offer a glimmer of hope for the organ transplant crisis. 





## ICC suspends Hasaranga for two matches

"Sri Lanka's T20I skipper and second-ranked T20I bowler on the ICC Men's Player Rankings, Wanindu Hasaranga, has been presented with a two-match suspension after his total demerit points reached five within a 24-month period following his latest breach of the ICC Code of Conduct, for which he received a 50 per cent fine and three demerit points," the ICC said in a statement.

The incident involving Hasaranga took place towards the end of the third and final T20I on Wednesday when he approached the on-field umpire Lyndon Hanibal to criticise a decision regarding a full toss delivery not being adjudged a

Hasaranga was thus found guilty of breaching the article 2.13 of the ICC Code of Conduct for Players and Player Support Personnel. The article relates to "personal abuse of a Player, Player Personnel, Umpire or Match Referee during an International



# Will protest outside residence of Fadnavis: Jarange

#### Fadnavis trying to kill me

Mumbai, Feb 25 (PTI): Maratha quota activist Manoj Jarange on Sunday said he would march to Mumbai and protest outside the residence of Maharashtra Deputy Chief Minister Devendra Fadnavis who he accused of trying to kill him.

The announcement, made at the end of a speech of more than one hour in Antarwali Sarati in Jalna in which Jarange made several allegations against Fadnavis, took his supporters by surprise.

Asked about Jarange's statements later, Fadnavis just said "I did not hear what he spoke".

"Some people are being lured and pressured to make false allegations against me. Fadnavis is behind these conspiracies. He wants to kill me. I am ready to march to Sagar bungalow (Fadnavis' official residence in Mumbai's Malabar Hill) right away," Jarange said.

The announcement led to chaos at the site, where the activist's supporters had gathered in large numbers.

Even as some of them tried to take away his microphone, Jarange said he would march to Mumbai alone and all he needed was a stick for support.

He said allegations against him were levelled once the Maratha quota bill was passed in the Maharashtra legislature on February 20.

"How come these people realised my so-called mistakes now and began speaking about them,' Jarange asked.



He also spoke about the "Brahminical tricks" of Fadnavis even while asserting that his allegations were not against "all Brahmins"

"Fadnavis does not like anyone to be more popular than him. It is because of Fadnavis that police complaints were filed against Maratha activists despite their peaceful protests.

The court has allowed us to protest peacefully. Then why were police complaints filed," he told a regional news channel.

"I am not backing down from my demand to include Marathas in the OBC segment and issuing of Kunbi certificates. There was a plan to finish me by poisoning me through saline. This government is trying to demean major communities through politic tricks," he alleged.

Hitting back,BJP MLA Nitesh Rane warned Jarange that he would have to cross a "huge wall of party workers" to reach Fadnavis, adding that the quota activist was "now reading from a script".

"He should enter politics but he should not stoop low to make such allegations against Fadnavis,"

Bhatkhalkar Jarange's "true face" was now in the open for all to

"The Maharashtra government has given 10 per cent reservation to the Maratha community (through a bill passed in Legislature February 20). Why is he continuing to protest? Fadnavis was CM for five years and everyone knows him. His image is not going to be affected by Jarange's allegations," Bhatkhalkar said.

Mumbai BJP chief Ashish Shelar said anyone speaking in this condemnable manner against Fadnavis must be careful.



place because of them. We need not attach importance to such things... I do not think there is anything Modi Individuals are not put on a pedestal in BJP-RSS. That has been Congress culture." Swamy also welcomed the return to the NDA of Bihar Chief Minister Nitish Kumar and said it would be in the JD(U) president's own interests to refrain from more flip-flops.

"He was always ours. I still do not understand why he had left us. He is intelligent and learned and should understand that he cannot afford to go against Hindu sentiments. He should, therefore, take the pledge that he will never part ways with the BJP again," said Swamy.

## IIT-Madras researchers patent use of Indian spices to treat cancer

Researchers at Indian Institute of Technology (IIT), Madras, have patented the use of Indian spices to treat cancer and the medicines are likely to be available in the market by 2028, according to officials.

The Indian spice-derived nanomedicines have shown anti-cancer activity against lung, breast, colon, cervical, oral and thyroid cell lines but were safe in normal cells, they said.

nanomedicines were also found to be safe in normal cells. The researchers are currently working on addressing the safety and cost issues which are major challenges in the existing cancer medicines.

Animal studies have been successfully concluded recently and clinical trials are being planned with a target of making the medicines available in the market by 2027-28.

'While the medical benefits of Indian spice oils have been known through the ages, their bioavailability has limited their application and use. Formulation as a nanoemulsion effectively overcomes this limitation. Stability of the nano-emulsion was a key consideration and it was optimised in our laboratory," R Nagarajan, a professor at Department the Chemical Engineering in IIT-Madras, told PTI.

mechanistic 'While studies to identify the active ingredients and their modes of interaction with cancer cells are important and will continue in our labs, parallelly, we will attempt to translate the positive results in our animal studies to clinical trials in an expedited manner. We are looking at a two to three-year window for bringing the formulations to market," he added.

Animal studies have been carried out on the patented anti-cancer nanoformulations. Animal vali-

Clinical trials to begin soon dation to adjust the dosage (GLP phase) and efficacy

studies (non-GLP phase) have been carried out through funding support from Madras Distinguished Alumnus Awardee and Infosys Co-Founder Gopalakrishnan through Pratiksha Trust. Nagarajan said there are several advantages of nano-oncology over conventional cancer treatment therapy. "The benefits include no toxic sideeffects, reduced cost of treatment, abundance of Indian spice oils and leveraging of nano-scale for optimising effectiveness and bio-availability," he said.

M Joyce Nirmala, Chief Scientific Officer (Cancer Nanomedicine and Drug Design Laboratory), IIT Madras, said the patented Indian spice-based nanoformulations have proven effective in many common

types of cancers through in-vitro studies. "The drug dosage adjustment and efficacy are now under investigation through animal models. This will be followed by clinical trials. This cancer nanomedicine is being developed to reduce the cost and pain of cancer treatment and also to overcome the toxic side effects seen in the existing cancer treatments." India is the world's

largest spice producer. Hence, large-scale production could be achieved at a low cost with our Indian spice-based cancer nanomedicine. "Moreover, the formulations are developed for an oral route of administration to ease the treatment process. The spices chosen are edible, hence, biocompatibility is good, reducing toxic side effects. "Also, plant and spice

oils, in general, could influence multiple oncogenic signalling pathways, which have an added advantage in improving the quality of life cancer patients, Nirmala said.
