'Corruption, mis-governance are INDI Alliance's ideology'

Fuelling anti-national agenda

New Delhi, Mar 14 (PTI):

Prime Minister Narendra Modi Thursday accused the opposition INDIA bloc of being guided by corruption, mis-governance and fuelling anti-national agenda, asserting he stands for rooting out corruption and appeasement.

His ideology is ensuring the country's welfare through people's welfare, he said at a programme here attended by the beneficiaries of PM Street Vendor's AtmaNirbhar Nidhi scheme, under which loan is given to street vendors.

Targeting INDIA group parties who have united in the national capital to take on the BJP in the Lok Sabha polls, Modi said they have come together on the agenda of "abusing" him day and night.

The Aam Aadmi Party

said the PM Modi SVANidhi scheme has been a big boost to the lakhs of families of street vendors who were never paid any "attention" by previous governments. They used to suffer insults as they hardly got loans from banks and had to obtain capital at exorbitant interest rates, he said.

"Modi ki guarantee' has ensured that they can get loans from banks at simple rates," he said, adding more than 62 lakh people have been given loans of about Rs 11,000 crore.

At the event, the prime minister distributed loans to 1 lakh street vendors (SVs) including 5,000 SVs from Delhi as part of the scheme. He handed over SVANidhi loan cheques to five beneficiaries. He also laid the foundation stone of two additional corridors of Delhi Metro's Phase 4.

On Wednesday, the Union Cabinet approved two new corridors of Delhi Metro's Phase-IV project -- Lajpat Nagar to Saket G-Block and Inderlok to Indraprastha -in a move that will further improve the metro connectivity in the national capital. The BJP government and ran from pillar to post at the Centre has been

working to improve the lives of the poor and middle class in the national capital, Modi said, adding that it has been making honest efforts to ease traffic and curb pollution in Indian cities.

Over 1,000 electric buses have been deployed in Delhi, he said, and highlighted the expansion of expressways around the city's periphery and increase in its Metro network. The PM pointed out that past governments did not take any interest in the welfare of street vendors which led to them facing disrespect and hardships.

They did not pay any heed to the needs of street vendors nor did they make any effort to tackle their issues, PM Modi said.

"This servant of yours has come out of poverty. I have lived in poverty. That is why those who have not been cared for by anyone, they were not only cared for but have been worshipped by Modi," said the prime minister.

Ex-bureaucrats Sukhbir Sandhu, Gyanesh Kumar named ECs

New Delhi. Mar 14 (PTI):

Former bureaucrats Sukhbir Singh Sandhu and Gyanesh Kumar have been named as the new election commissioners by a panel chaired by Prime Minister Narendra Modi, committee member and Congress leader Adhir Ranjan Chowdhury said on Thursday. Chowdhury, however,

gave his dissent note on the selection, raising questions over the procedure. He said he had sought the names of the shortlisted candidates for the posts in the Election Commission but was provided 212 names the night before the committee met.

Addressing reporters at his residence soon after meeting Chowdhury said six names came up before the panel for the selection of



the two election commissioners and the names of Sandnu and Kumar were finalised by a majority of members of the high-powered panel. The six names shortlist-

ed were that of Utpal Kumar Singh, Pradeep Kumar Tripathi, Gyanesh Kumar, Indevar Pandey, Sukhbir Singh Sandhu, Sudhir Kumar Gangadhar Rahate, all former bureaucrats. The selection panel is chaired by the prime minister. It has as members one Union minister --Home Minister Amit Shah -- as nominated by the government and the leader of the largest opposition party in the Lok Sabha.

"Of the six names, the names of Gyanesh Kumar Sukhbir Sandhu were finalised for appointment as election commissioners, Chowdhury said.

He said that "I did not

have information about tne background, experience and integrity of these people and I did not like the procedural lacunae' but the appointments were made. While Kumar during his tenure in the home ministry oversaw the abrogation Constitution's Article 370, which granted special status to Jammu and Kashmir, Sandhu is a former chief secretary of Uttarakhand. Kumar and Sandhu are 1988-batch officers of the Indian Administrative Service and belonged to the Kerala and Uttarakhand cadres,


32 parties supported one nation, one poll; 15 opposed

New Delhi, Mar 14 (PTI):

A high-level panel on Thursday recommended simultaneous elections for Lok Sabha and state assemblies as the first step followed by synchronised local body polls within 100 days in its report on 'one nation, one election' submitted to President Droupadi Murmu.

Simultaneous polls will help save resources, spur development and social cohesion, deepen "foundations of democratic rubric" and help realise the aspirations of "India, that is Bharat", the panel headed by former president Ram Nath Kovind said in its report that runs into more than 18,000 pages. However, the panel has

made 321 pages public.

The committee noted that B R Ambedkar had envisioned the necessity of uniformity in the electoral process and further advocated for the Union to be responsible for conducting elections in India.

Separately, the Law Commission is also likely to come up soon with its own report on simultaneous polls, of which Prime Minister Narendra Modi has been a strong votary.

Sources said that the Law Commission is likely to recommend holding simultaneous polls for all three tiers of government -- Lok Sabha, state assemblies and local bodies like municipalities and panchayats -- starting with 2029 and a provision for unity government in cases like hung house or no-confidence motion. The 2024 general elec-

The National Payments Corporation of India on Thursday granted approval to Paytm-owner One97 Communications Ltd to participate in UPI as a Third-Party Application Provider (TPAP) under the multi-bank model.

Axis Bank, HDFC Bank, State Bank of India, and YES Bank will act as Payment System Provider (PSP) banks to Paytm.

YES Bank shall also be acting as merchant acquiring bank for existing and new UPI merchants for One97 Communications Ltd (OCL). "@Paytm" handle shall be redirected to YES Bank, NPCI said in a

brand. "This will enable existing users and merchants to continue to do UPI transactions and AutoPay mandates in a seamless and uninterrupted manner," it said.

The NPCI's decision comes a day ahead of the Reserve Bank deadline asking customers and merchants of Paytm Payments Bank Ltd (PPBL) to shift their accounts to other banks by March 15.

In a big move towards transparency in political funding, the Election Commission of India has uploaded the data of the electoral bonds given to it by the State Bank of India. The details have been uploaded on Thursday, a day before the deadline set by the Supreme Court.

The data pertains to purchases of bonds of three denomination - Rs 1 lakh, Rs 10 lakh and Rs 1 crore - dating back to April 12, 2019 and reveals purchases by companies as well as individuals.

Thursday said it has taken action to block 18 OTT platforms and social media accounts associated with them for publishing obscene, vulgar and in some instances pornographic content.

In a statement, the Ministry of Information and Broadcasting said 18 OTT platforms and 19 websites, 10 apps (seven on Google Play Store, three on Apple App Store), and 57 social media accounts associated with them have been disabled for public access in India

Union Minister for Information and Broadcasting Anurag Thakur has emphasised the responsibility of the platforms to not propagate obscenity, vulgarity and abuse under the guise of 'creative expression'.

The decision to act against the OTT platforms was taken under the provisions of the Information Technology Act, 2000 in consultation with other ministries/departments of the Government, and domain experts specialising in media and entertainment, women's rights, and child rights, the statement said. The Ministry Information Broadcasting (I&B) has taken action, in coordination with various intermediaries, to block 18 OTT platforms publishing "obscene," "vulgar," and, in some instances, "pornographic content".





He suggested that patients with high blood pressure and a high sugar level should come for regular kidney checkups. No. registered in the 'Choudahi details' and Revenue Records is different from that of the 'Choudahi'.

The above Laltalab was purchased by Pankaj Jain on 23/03/2005 by terming Late Dalichand Bothara as his adopted father, whereas in the Khasara of Patwari H. No. and B-1, the purchaser of Kh. No. 380 is Pankaj Kumar alias Anand Bothara S/o Sampatraj and has got the correction done in the record with 'basara' amendment. As per information in this regard, on 10 Oct 2018, with change in 'basara' and the new 'basara' No. is 64/37. With name of father being different, it was in nexus with the then Patwari, the land mafia got the Khasara No. included and got the 'basara' changed, so that it is by changing name of father, all the irregularities can be hidden behind the cover. Reliable sources informed with name of father being different, different 'Khasara No.'s cannot be includ-

ed into one and nor the 'Basara'

Beat Vidarbha by 169 runs in final


Mumbai, Mar 14 (PTI):

One Nation, One Election

A Step Towards Efficiency or Constitutional Ouandary?

he notion of 'One Nation, One Election' resonates with the spirit of unity, suggesting a harmonized electoral process across India's diverse landscape. The submission of a report on this matter by a committee led by former President Ram Nath Kovind underscores the government's commitment to exploring avenues for enhancing the efficiency and integrity of our democratic processes. The panel - set up in September - has since studied "best practices from other countries", consulted 39 political parties, economists, and the Election Commission of India. It said today it backs the idea, but calls for a legally sustainable mechanism that can break and re-align existing electoral cycles. The committee is of unanimous opinion that simultaneous polls should be held, the report, submitted to President Droupadi Murmu, said, noting that Lok Sabha and Assembly polls could be held together with local body elections (also synchronised) 100 days later. At its core, 'One Nation, One Election' seeks to synchronize Lok Sabha and Assembly polls, streamlining the electoral calendar and reducing the frequency of polls. This proposal, enshrined in the BJP's 2019 manifesto, has ignited fervent debate and elicited varied responses from across the political spectrum. Proponents of the initiative argue that simultaneous elections offer numerous advantages, including substantial financial savings, streamlined governance, and increased voter participation. The rationale behind these claims is compelling: by reducing the frequency of polls, the government can minimize the logistical and financial burdens associated with repeated electoral cycles, thereby enabling a more efficient allocation of resources towards developmental initiatives. Furthermore, proponents assert that synchronized elections would mitigate disruptions caused by the imposition of the Model Code of Conduct, facilitating the seamless implementation of welfare schemes and policy initiatives. By aligning electoral cycles, the government aims to foster political stability and enhance governance effectiveness, ultimately bolstering democratic institutions and processes. However, amidst these purported benefits lie significant constitutional and logistical challenges that merit careful consideration. Critics argue that 'One Nation, One Election' poses a threat to India's federal structure, potentially undermining the autonomy of state governments and eroding the principles of democratic decentralization. The proposal necessitates a constitutional amendment, requiring ratification by state governments and political parties, a formidable task fraught with political complexities. Legal experts have cautioned against the potential constitutional pitfalls, highlighting the need for a robust legislative framework to safeguard democratic principles and federalism. Furthermore, concerns have been raised regarding the practical implementation of synchronized elections, particularly in the event of premature dissolution of legislative assemblies or hung parliaments. Addressing these contingencies demands meticulous planning and coordination, ensuring that electoral integrity and democratic norms remain uncompromised. Opposition parties, including the Congress, AAP, and regional entities, have voiced vehement opposition to the initiative, citing concerns over its potential ramifications on democratic principles and governance dynamics. Chief Ministers Mamata Banerjee and MK Stalin have criticized the proposal as an affront to constitutional integrity, warning against its potential to subvert democratic norms. Amidst the polarized discourse surrounding 'One Nation, One Election', it is imperative to prioritize constructive dialogue and consensus-building. While the initiative holds promise for enhancing electoral efficiency and governance effectiveness, its implementation must be guided by a steadfast commitment to constitutional principles and democratic values.

India's ambitious Fifth-gen fighter programme starting to take shape finally



he Cabinet Committee on Security on March 7 cleared the project to design and develop the Advanced Medium Combat Aircraft (AMCA), which will be a fifth-generation, medium weight stealth fighter jet. It is being developed by the Defence Research & Development Organisation (DRDO), under a project worth around Rs 15,000 crore. DRDO's Aeronautical Development Agency (ADA) will develop the stealth jet and the associated technology in partnership with various private and public sector agencies. According to sources, about five prototypes will be built in around five years. Public sector unit Hindustan Aeronautics Limited (HAL) will have a role in manufacturing of the Prototypes. The aircraft will propel India into a handful group of nations that have or are developing 5th generation fighter jets, based on futuristic technology in partnership with various private and public sector agencies.

A fifth-generation fighter jet has four main attributes. First, it is stealthy. That means it is near-invisible to enemy radars, which is a function of the jet's radar cross section. Secondly, it can

'Supercruise', or fly faster than the speed of sound without using the fuelguzzling afterburners on its engines. Third, it has advanced avionics and sensors with network centric operations. Increasingly, artificial intelligence is also being used in this regard to enhance pilot-aircraft interface. This allows a single pilot to both fly the aircraft and engage in combat. Last but not least, it should be able to outrange its adversaries by detecting and engaging targets from long distances, which is achieved by employing active electronically scanned array (AESA) radars. To achieve stealth, these aircraft are specifically shaped to scatter radar waves, instead of reflecting them back. After that, special materials and paints, called 'Radar absorbing structures' and materials, are used to further reduce radar reflectivity. When operating in stealth mode, these fighters have to conceal their weapons in an internal bay and can only count on the fuel carried in tanks located within their body. Weapons or fuel tanks carried externally, like conventional aircraft do under their wings, reflect radar waves and

compromise stealth. AMCA is proposed to be developed in two phases. Phase 1 development will result in AMCA Mk-1, powered by the US GE-414 engine. Phase 2 development will result in AMCA Mk2, which will feature an advanced, more powerful engine. What is more significant is it would be a difficult-to-swallow pill that the AMCA projected to be inducted by 2035 may not be a 'Completely 5th-generation fighter aircraft'. Based on specifications, it would be categorised as a 4.5 gen Bird. AMCA Mk-1 will lack 'at least' three defining 5th-generation fighter traits which include Supercruise. Supermaneuverability and Sensor fusion. Additionally, AMCA Mk-1 would feature limited stealth. Why these timeline developments are significant, can be appreciated from the already exist-

ing global Fifth-gen fighter ecosystem. China is set to outpace the US in the production of stealth aircrafts. In fact, China's inventory of the J-20A Mighty Dragon, China's first fifth-generation fighter, was slated to overtake that of the US Air Force's F-22 Raptor last year. The F-22 Raptor was the first-ever fifthgeneration fighter to enter service. However, the F-22 hasn't been in production for some time now, and the US has shifted its attention to the F-35 Lightning II family of stealth fighters, which are meant to be more affordable. Incidentally, in April of 2018, India pulled out of the Fifth Generation Fighter Aircraft programme, or FGFA, which was a joint effort with Russia that was supposed to lead to an Indiaspecific variant of the Russian Su-57 stealth fighter. Even South Korea and Turkey have taken a lead in the race for fifth-generation fighter aircraft. In July of 2022, the prototype of South Korea's KF-21 Boramae next-generation fighter jet conducted its first flight. Indonesia is a 20 per cent partner in the Boramae

programme. The KF-21 Boramae is stealthier than previous fourth-generation iets. In February this year. Turkey's next-generation fighter, known as the TF KAAN, took off for its first flight. Of concern to India would be the fact that in August last year, the Turkish government had announced that Pakistan could officially join the Turkish Aerospace KAAN aircraft programme. Also, the reports of Chinese J-20 being offered to Islamabad has been an eyebrow raiser. Following years of ups and downs,

the home-grown, Desi-bird LCA Tejas

has been inducted by the Indian Air Force and a naval version is in the works. To address the Elephant in the room, India's fighter squadron strength is on a decline and lagging behind the sanctioned strength of 42 squadrons. New Delhi is exploring all options to augment the squadron numbers as a couple of Rafale and Tejas LCA squadrons are too inadequate to fill the gap. decade of reforms in Indian Public Broadcasting merit a critical examination for not only the transformation that has taken place since Prime Minister Narendra Modi took office but also for the pivotal role public service media is poised to play in India's developmental journey towards achieving a 'Viksit Bharat' by 2047. If the period between 2004 and 2014 when the UPA governed India, is often referred to as the 'lost decade', it is especially true of public broadcasting given the lackadaisical approach of the then government towards undertaking any meaningful reforms. Doordarshan and All India Radio remained trapped in a time warp of status quo as organisations with a 20th century mindset incapable of meeting the challenges of the 21st century.

However, since 2014, thanks to the stewardship of Prime Minister Narendra Modi. Prasar Bharati embarked on an unprecedented journey of public broadcasting reforms the impact of which was best felt when the COVID-19 pandemic struck. Redeploying the manpower from these transmitter sites towards managing its fast expanding FM radio network, Prasar Bharati also undertook long overdue convergence between its television and radio operations breaking the silos within which Akashvani

and Doordarshan had long operated. The expansion of Doordarshan's satellite channels from 23 in 2017 to 36 in 2021, including dedicated channels like DD Kisan, underscores a commitment to diversified content catering to the needs of every Indian. Similarly. Akashvani's footprint expanded significantly, ensuring that the voice of India reached the farthest corners of the country and beyond.Digitalization and the integration of IT systems across Doordarshan (DD) and All India Radio (AIR) have made public broadcasting more accessible and inclusive. channel in India and expanding its global footprint to over 190 countries through a combination of platforms such as mvK in Korea. YuppTV in North America apart from YouTube. This international outreach is critical for projecting India's perspectives and values on the global stage.

Financial sustainability has also been a focus, with Prasar Bharati achieving a 13% revenue growth in 2021-2022 from commercial operations. This financial prudence, coupled with technological advancements, established a strong foundation for a roadmap towards a self-sustaining public broadcasting ecosystem.The strategic interventions, like broadcasting weather reports for Pakistan-occupied Kashmir and expanding the digital footprint through platforms like the NewsOnAir App, reflected a bold and innovative approach to leveraging public broadcasting for national interest and global outreach. The impact of a decade of reforms in public broadcasting is clearly visible with the Reuters Institute of Journalism Studies in its annual surveys ranking Doordarshan and Akashvani as the most credible and trustworthy sources of news in India. Yet, these reforms are not an end but a beginning.

To realize Prime Minister Modi's vision of a 'Viksit Bharat' by 2047, public broadcasting must continue to evolve. It must serve as a platform for educa-

tion, innovation, and dialogue, bridging the digital divide and ensuring that every Indian, irrespective of their socio-economic status, has access to information, education, and entertainment. This becomes apparent when one considers the diversity of India's languages across regions many of which are either underserved or unserved by the private media. Today AI models are being developed for these languages and dialects by leveraging the corpus of Mann ki Baat recordings and the archives of Doordarshan and All India Radio. The journey from 'Sabka Saath, Sabka Vikas' to 'Viksit Bharat' is long and challenging, but with the strategic use of public broadcasting, India is poised to achieve this vision, ensuring that the voice of every Indian is heard, and the story of India's development reaches every corner of the globe by amplifying these billion voices.

Fitch raises India's GDP forecast for next fiscal to 7 pc

Fitch Ratings on Thursday raised its forecast for India's economic growth to 7 per cent for the next fiscal year starting April 1 on the back of strong domestic demand and sustained level of business and consumer confidence. With stronger-than-expected 8.4 per cent growth in gross domestic product (GDP) during the third quarter (October-December) of the current fiscal year, Fitch saw the Indian economy expanding 7.8 per cent in 2023-24 financial year (April 2023 to March 2024), marginally higher than the government's estimate of 7.6 per cent. In its latest 'Global Economic Outlook', the rating agency said the country's economic growth continued to outperform quarterly forecasts with domestic de-

mand (investment growth

increased 10.6 per cent



vear-on-vear while private consumption was 3.5 per cent higher). For the world, Fitch Ratings has raised its 2024 global GDP growth forecast by 0.3 percentage points to 2.4 per cent, as near-term world growth prospects have improved. This on back of a sharp upward revision to its US forecast to 2.1 per cent, from 1.2 per cent in the December 2023 Global Economic Outlook (GEO). "Stronger US growth prospects outweigh a marginal cut to our China 2024

growth forecast -- to 4.5 per cent from 4.6 per cent -- and a minor revision to our eurozone forecast, to 0.6 per cent from 0.7 per cent," it said. "Growth in emerging markets, excluding China, has been revised up by 0.1 percentage point to 3.2 per cent, with forecasts raised for India, Russia and Brazil." It expected world growth in 2025 to edge up to 2.5 per cent as the eurozone finally recovers - on a pick-up in real wages and consumption -- but as US

GDP growth having exceeded 8 per cent for three consecutive quarters, we expect an easing in growth momentum in the final quarter of the current fiscal year, implying an estimate of 7.8 per cent for growth in FY24." Recent quarterly data has shown that GDP is rising much faster than gross valueadded -- indirect taxes net of subsidies is the difference between the two -- and this unusually wide gap may normalise. Strong business survey data for January and February represents an upside risk to these estimates, it said. "We expect the Indian economy to continue its strong expansion, with real GDP forecast to increase 7 per cent in FY25, a 0.5 percentage point upward revision from our December forecasts," Fitch Ratings said. "Domestic demand, especially investgrowth slows. For India, ment, will be the main

sustained levels of business and consumer confidence." Its forecasts imply that growth in the short term will outpace the economy's estimated potential, and that the pace of growth of activity will then moderate towards trend in FY25, with real GDP rising 6.5 per cent. DFS Secy says 5 PSU banks to reduce govt shareholding to meet MPS norms

Five public sector lenders, including Bank of Maharashtra, IOB and UCO Bank are planning to reduce government stake to less than 75 per cent to comply with Sebi's minimum public shareholding (MPS) norms, Financial Services Secretary Vivek Joshi has said. Out of 12 public sector banks (PSBs), four were complying with MPS norms as on March 31, 2023. "As part of an ongoing effort, three more PSBs have complied with minimum 25 per cent public float during the current financial year. Remaining five PSBs have laid out action plans to meet MPS requirement," he told PTI in an interaction.




