#### As 2014-2023 recorded hottest decade ever

New Delhi, Mar 19 (PTI):

Greenhouse gas levels, surface temperatures, ocean heat and acidification, and sea level rise all reached record highs in 2023, according to a new report by the World Meteorological Organization (WMO) released on Tuesday.

The report, titled "State of the Global Climate 2023", confirmed that 2023 was the warmest year in the 174year observational record, with the global average

near-surface temperature at 1.45 degrees Celsius above the pre-industrial baseline (1850-1900). "Sirens are blaring across all major indicators... Some records are not just chart-topping, they are chart-busting. And changes are speeding up," said United Nations Secretary-General Antonio Guterres.

"Never have we been so close albeit on a temporary basis at the moment to the 1.5 degrees Celsius lower limit of the Paris Agreement on climate change. The WMO community is sounding the red alert to the world... The climate crisis is the defining challenge that humanity

faces," WMO Secretary-General Celeste Saulo said "Climate change is about much more than temperatures. What we witnessed in 2023, especially with the unprecedented ocean warmth, retreat, and Antarctic Sea ice loss, is cause for particular concern," she added.

COP28 President Sultan Al Jaber said the world has no time to spare.

To limit warming to 1.5 degrees Celsius, countries must deliver enhanced Nationally Determined Contributions (NDCs), economy-wide emissions reductions, and investments in nature and adaptation, he stressed.

Raipur, Mar 19: Collector and District Returning Officer Dr Gaurav Singh said that it was necessary for all political parties and candidates to commit to the Model Code of Conduct of the Election Commission. Model Code of Conduct should be followed to ensure free and fair elections, he said, adding that the role of political parties is very important in this process. With everyone's cooperation, the process of the upcoming Lok Sabha elections would be completed successfully, he said at a meeting with representatives of various political parties held in the Red Cross meeting room in the Collectorate

Collector Dr Singh said that at the time of nomina-

hicles of any candidate and his supporters will come within a radius of 100 meters of the RO or ARO office. On the day of polling, candidates will be allowed to operate only three vehicles - one for themselves, one for election agents and one for workers. Permission letters for these vehicles will be issued by the competent authority and this permission letter will be displayed on the front windshield of the vehicles. Vehicles engaged in campaigning will not, under any circumstances, run in convoys of more than three.

He said that every political party and candidate should promote itself by avoiding caste and religious issues. Religious places or institutions should not be used while appealing for votes. The Collector said that no party or candidate should put up flags, posters, banners etc on anyone's per-

sonal property, building, land or premises without his prior permission. Temporary campaign offices will not be allowed on any encroached land or building and in buildings adjacent to educational institutions or hospitals. No office will be allowed within a radius of 200 meters of any polling station. These offices cannot be operated in any religious buildings.

He said that political parties using helicopters and aircraft should apply to the competent authority three days in advance for permission. The Collector said that processions, rallies and meetings should be organized during elections only after obtaining competent approval. Burning of effigy will not be allowed in the rally nor should any inflammatory slogan or language be used during this period.

If any person creates obstruction during the proces-

#### In Orthopaedics **Department of Ambedkar Hospital**

Raipur, Mar 19: Doctors of the Orthopaedics Department of Dr Bhimrao Ambedkar Memorial Hospital, affiliated to Pandit Jawahar Lal Nehru Memorial Medical College, Raipur, have successfully performed total hip replacement surgery on a 37year-old patient suffering from sickle cell anemia. The surgery was conducted under the leadership of Dr (Prof) Rajendra Ahire of the Department of Orthopaedics.

According to Dr Ahire the hip of the patient, a resident of Jashpur, Kunkuri, was completely worn out due to sickle cell anemia. After successful surgery, the patient is now walking like before. Giving information regarding the operation, Dr.



Rajendra Ahire said that the patient had been suffering from sickle cell anemia since childhood. This genetic disease affects the structure of red blood cells present in the body which transport oxygen throughout the body. Due to this disease of the patient, the bones on both sides of his waist had worn out and got damaged. The patient had trouble walking since 2014, so he visited a private hospital in Ambikapur where he was asked was performed successfully on

to go to Raipur. Due to gradual increase in pain patient was unable to walk. The patient then reached OPD in Ambedkar Hospital, where he was admitted and his blood, MRI, X-ray and all other types of tests were done. On the basis of test report he was advised to undergoe total replacement surgery. Accordingly he was admitted to Ambedkar Hospital on 19 February 2024 and the surgery



him. The patient is now completely walking. According to Dr. Rajendra Ahire, if this operation had been done in a private hospital, it would have cost lakhs of rupees, but in Ambedkar Hospital this operation was done free of cost with the help of Ayushman Yojana.

While sharing his experience after the operation, the patient said that he was very worried due to sickle cell disease. He said that it had become difficult

for him to walk due to wear and tear of the bones in his hip joints. After the operation, a ray of hope has returned that now he can walk again like before, he said. The team that carried out this complex operation comprised Dr. (Prof.) Dr. Rajendra Ahire, an orthopaedic surgeon at Ambedkar Hospital, Dr. Atin Kundu, Dr. Saurabh Jindal, PG Dr. Pritam Prajapati, Dr. Intezar, Dr. Shyam Dhar and Dr. Sonali Sahu from Anesthesia.

"Hiring detectives to know the strategies and information related to hidden criminal records, scandals, illicit relationships and videos related to that, or cases of corruption that have the potential to hit one's election campaign has always been the main focus," Sharma said.





Military airstrikes in western Myanmar killed at least 25 members of the Muslim Rohingya minority, including children, local media reported, prompting the UN chief to express con-

According to the reports, the airstrikes took place early on Monday morning and targeted the village of Thada, north of Minbya township in Rakhine state. The strikes also left another 25 people wounded. The military government had no immediate comment on the re-



General Antonio Guterres expressed deep concern over "the deteriorating situation and escalation of conflict in Myanmar," according to a spokesperson.

The UN chief "condemns all forms of violence and reiterates his call for the protection of civilians, including aid workers in accordance with international humanitarian law, for the cessation of hostilities, and humanitarian acsaid Guterres' spokesperson, Farhan Haq, in a state-

increasingly airstrikes to counter the widespread armed strug-gle against its rule since its seized power from the elected government of Aung San Suu Kyi in February 2021.

A report issued at the end of last year by Nyan Lynn Thit Analytica, a Myanmar research and advocacy organization, said that since the military's 2021 takeover, 936 civilians had been killed and 878 wounded in 1,652 airstrikes. It said 137 religious buildings, 76 schools and 28 hospital and dispensaries had been damaged by aerial attacks.

The Rohingya village of Thada is about 340 km (120 southwest of Mandalay, the country's second largest city. However, almost 90% of Myanmar's people are constitutes the Southeast Asian nation's ruling

Two villagers from the Thada village told The Associated Press late on Monday that a jet fighter dropped two bombs on the village at around 1:30 am. Six children were among the 25 killed, they said, speaking on condition of anonymity for fears of arrests and reprisals.

The victims included those who had fled fighting in nearby villages, the villagers said.

Independent media including Myanmar Now, The Irrawaddy and Rakhine-based outlets also reported about the incident, giving death tolls between 21 and 23 on Monday and Tuesday. Different casualty tolls are common in areas of Myanmar that are difficult

### **UN reports 35% increase** in people affected by violence in South Sudan

Juba, Mar 19 (AP):

The number of people affected by violence in South Sudan surged by 35% in the last three months of 2023, the United Nations reported.

The UN Mission in South Sudan, or UNMISS, documented 233 incidents of violence affecting 862 people. Of that, 406 were killed, 293 were injured, 100 were abducted and 63 subjected to conflict-related sexual violence, it said in a report released Monday. It was a 35% increase in the number of victims reported from the previous quarter.

South Sudan is to hold elections later this year, the first since a 2018 peace deal between President Salva Kiir and his former rival, Riek Machar, that ended a five-year conflict that killed hundreds of thousands.

### **Nawaz Sharif courts controversy** as he chairs Punjab govt meetings

Nawaz Sharif, supreme leader of the PML-N, assumed a "defacto" role of Punjab chief minister, a post officially held by his daughter Maryam Nawaz, and presided over three administrative meetings of the provincial government, raising many eyebrows.

Maryam Nawaz took over as the first woman chief minister Pakistan's Punjab province last month.

However, her father Sharif, 74, assumed a "defacto CM role" and issued directions to the authorities concerned and ministers regarding different projects in the province, which used to be the bastion of his Pakistan Muslim League-Nawaz (PML-N) party.

An official handout issued after the meeting said the three-time former prime minister issued directions to ministers and officials regarding different infrastructure projects, including the underground train and metro bus, farmers' plight, electric bikes for students and Ramzan relief package.

However, the veteran leader chairing the meetings raised many questions since he holds no official position in either the provincial or federal gov-



ernment and is officially only a National Assembly member.

Sharif was elected from Lahore on a National Assembly seat in February 8 polls, which were marred by allegations of rigging. Jailed forpremier Imran Khan's Pakistan Tehreeke-Insaf (PTI) party has alleged that its mandate was stolen by the PML-N.

Independent candidates backed by jailed former prime minister Khan's PTI won the maximum number of seats in the

National Assembly. He was the party's candidate for the prime minister slot, but his dream to don the premier's cap for the fourth time was shattered as his party couldn't secure a simple majority in the lower house; thus, his younger brother Shehbaz Sharif emerged as favourite of the military establishment to lead a six-party coalition government in the Centre.

### **UN** weather agency issues 'red alert' on climate change after record heat

Geneva, Mar 19 (AP):

is sounding a "red alert" about global warming, citing record-smashing increases last year in greenhouse gases, land and water temperatures and melting of glaciers and sea ice, and warning that the world's efforts to reverse the trend have been inadequate. The World Meteorological Organisation, in a "State of the Global Climate" report released Tuesday, ratcheted up concerns that a muchvaunted climate goal is increasingly in jeopardy: That the world can unite to limit planetary warming to no more than 1.5 degrees Celsius (2.7 degrees Fahrenheit) from pre-industrial levels.

"Never have we been so close albeit on a temporary basis at the moment to the 1.5 C lower limit of the Paris agreement on climate change," said Celeste Saulo, the agency's secretary-general. "The WMO community is sounding the red alert to the world."

The 12-month period from March 2023 to February 2024 pushed be-

yond that 1.5-degree limit, averaging 1.56 C (2.81 F)  $\,$ higher, according to the Union's European Copernicus Service. It said the calendar year 2023 was just below 1.5 C at 1.48 C (2.66 F), but a record hot start to this year pushed beyond that level for the 12-month average.

"Earth's issuing a distress call," UN Secretary-General Antonio Guterres said. "The latest State of the Global Climate report shows a planet on the brink. Fossil fuel pollution is sending climate chaos off the charts.

The latest WMO findings are especially stark when compiled in a single report. In 2023, over 90% of ocean waters experienced heat wave conditions at least once. Glaciers monitored since 1950 lost the most ice on record. Antarctic sea ice retreated to its lowest level ever. "Topping all the bad news, what worries me the most is that the planet is now in a meltdown phase literally and figuratively given the warming and mass loss from our polar ice sheets," said Jonathan Overpeck, dean of the University of Michigan School for Environment and Sustainability, who wasn't involved in the Established 1974 Volume 49 No. 169

### **Transparency Imperative**

Crucially, the Court's directive transcends the confines of a mere procedural order. It serves as a potent reminder of the judiciary's unwavering commitment to upholding constitutional values. By stipulating a deadline of March 21, the Bench underscores the urgency of the matter, leaving no room for ambiguity or procrastination. The significance of this mandate becomes even more pronounced against the backdrop of recent controversies surrounding electoral funding. The electoral bond system, ostensibly introduced to enhance transparency, has been mired in ambiguity and skepticism. The lack of transparency in donor identities has fueled apprehensions regarding the sanctity of our electoral process. The Court's refusal to entertain pleas for retrospective disclosure underscores a judicious balance between accountability and practicality. While acknowledging the imperative of transparency, the Bench demonstrates prudence by delineating a temporal boundary that ensures legal clarity and procedural coherence. In rebuffing attempts to impede transparency under the guise of procedural technicalities, the Court reaffirms its commitment to the broader principles of justice and equity. The admonition directed towards the SCBA president serves as a poignant reminder that the judiciary remains impervious to extraneous influences and steadfast in its pursuit of truth and justice. The assertions made by various stakeholders, including the petitioner Association for Democratic Reforms and the Solicitor General representing the Centre, underscore the divergent perspectives surrounding electoral funding. However, amidst the cacophony of competing interests, the Court's mandate stands as a beacon of clarity, guiding our collective endeavor towards a more transparent and accountable electoral landscape. By demanding unfettered transparency, the Court reiterates its role as a custodian of constitutional values and a guardian of democratic integrity. It is incumbent upon all stakeholders to heed this clarion call for transparency and collectively strive towards a more accountable and equitable democratic paradigm.

# How rising dengue burden is costing India and Sri Lanka billions

he increasing incidence of dengue in India and Sri Lanka is not just a significant health concern but also exacts a hefty economic toll on these South Asian countries, say experts who estimate the annual losses to be in billions.

Researchers highlight the dire economic consequences of this affliction caused by a virus spread through the bite of an infected Aedes mosquito species, reinforcing the benefits that the region would realise if the neglected tropical disease was substantially controlled.

As the sweltering heat swept across Colombo in June, Seetha, a 60-year-old daily wager found herself in the grips of dengue hemorrhagic fever, a severe and some-

times fatal form of the disease. "I had a fever, body aches, and a relentless headache for four days before being admitted to the hospital. I was catheterised and not even al-

lowed to go to the toilet," she told PTI. Seetna's work involved providing care to a 5-year-old child until the mother returned from work. The onset of dengue, however, disrupted her livelihood.

I was bedridden for seven days in the hospital, unable to move, and the impact on my work was severe. It took me almost a month to recover," she recalls.

As the sole breadwinner following her husband's death, Seetha faced a financial quandary during her illness.

"Mv children were not working and there was no money. My brother and another relative had to step in and provide us with financial support for survival," the woman explained.

Seetha's narrative underscores the broader economic challenges faced by South Asian countries that grapple with the relentless on-

slaught of dengue every year. In 2023, India officially recorded nearly 95.000 cases and 91 deaths by September 17. In 2022, the figure was 2.33 lakh with 303 deaths.

Sri Lanka had reported more than 80,000 dengue cases by the first week of December last year and 47 deaths, according to the National Dengue Control Unit (NDCU).

Dr Nayani P Weeerasinghe, a consultant microbiologist and senior lecturer at the University of Ruhuna in Galle, Sri Lanka, noted the economic burden of dengue in the two countries is substantial, with significant strains on healthcare systems and families, especially those reliant on daily wages.

"Both agricultural and industrial sectors suffer due to the disabling nature of dengue and absenteeism from work, particularly in labour-intensive industries, adversely affect-ing productivity," Weeerasinghe

Echoing Weerasinghe, epidemiologist and economist Ramanan Laxminarayan noted that although dengue rarely kills, it causes significant health burdens and costs.

"When hospitalisation is required, it drives many families into poverty. I recently had a coworker in India suffering from dengue. Fortunately, he survived but the hospital bills were over Rs 14 lakh," Laxminarayan, founder and director of One Health Trust, told PTI.

Most people with dengue have mild or no symptoms and get better in up to two weeks. Symptoms include high fever, severe headache, muscle and joint pains, swollen glands, and rash.

However, severe symptoms such as snooting abdominal pain, bleed ing gums or nose, and blood in vomit or stool, often come after the fever has gone, and can be fatal. What makes matters worse is that there are no effective drugs to treat the disease.

The economic impact of dengue is multifaceted.

A cost analysis study in southern Sri Lanka estimated direct medical costs per hospitalised dengue patient at USD 233.76 (around Rs 20,000) in 2017-18. For complications requiring intensive care arise, the cost soars to USD 733.46 (over Rs 61,000).

The burden extends beyond direct medical expenses to indirect costs, with households bearing 77.29 per cent of the monthly income on average, the expert said.

Weeerasinghe also highlighted variations across South Asian countries, citing a systemic analysis in India which indicates a cost of USD 5.71 billion from 2013 to 2016, substantially higher than in Sri Lanka.

The direct costs were for seeking

medical care for the illness -- channeling fees, costs of laboratory investigations, medications, travel expenses for seeking medical care and for visiting the admitted family members, among others. Direct household cost per patient

was 16.29 USD, almost 4 per cent of a person's average monthly income in the island nation. Indirect costs for the families af-

fected by dengue resulted in absenteeism from work, thereby leading to loss of family income. People with informal employment and daily wage jobs are more likely to be affected by this, the experts said.

A considerable proportion of families in the South Asian region have only one member working. An average of 22 days of absenteeism from work has been reported due to dengue in the countries here, according to a 2019 study published in the journal International Journal of Infectious Diseases

"When we add both direct and indirect costs to the household, it accounts for 77.29 per cent, which is almost three-fourths of the monthly household income in Sri Lanka, Weeerasinghe said.

In Thailand, another South Asian country with high dengue prevalence, the economic impact of the disease is 600 million Baht (over Rs 138 crore) per year for just treatment, noted Darin Areechokchai, from the Bureau of Vector-Borne Diseases, Department of Disease Control, Ministry of Public Health.

The epidemiology of the disease has changed and is now equal in both children and adults, so the economic impact in South Asia will be higher in the future than in the past," Areechokchai told PTI.

Weerasinghe warned of longterm consequences of dengue, especially in the case of pediatric infections leading to school absenteeism, potentially impacting future earnings.

"If people develop severe dengue, hospitalisation becomes unavoidable -- and that's where the expenses add up both for the individual and the healthcare system," said Neelika Malavige, DNDi's Head of Dengue Global Programme and Scientific Affairs, South Asia.

"However, the costs are huge even when patients are not hospitalised, as they have to visit their doctor daily if they are suspected to have dengue, as we don't have a test to find out who will develop plasma leakage leading to severe dengue and who will have mild symptoms," she told PTI.

As global changes in urbanisation, mobility, and climate contribute to the spread of dengue, Laxminarayan foresees an increased incidence of cases. "Climate change increases the

range for the main vector for dengue - Aedes aegypti. The expansion of water tanks and storage containers where this mosquito usually breeds is likely to increase dengue cases in coming years, expand the season during which the disease is transmitted, and cost us even more money," he explained.

To reduce the economic impact of dengue, experts say it is necessary to control the number of such cases, educate the general public, and implement policies for disease control.

Weeerasinghe stressed the importance of preventive measures, including health education programmes and legal actions for environmental cleanliness.

International collaboration is deemed crucial for sharing knowledge and resources to address the economic burden effectively.

Studies are being conducted in South Asian countries on dengue, with the research teams providing information for the policymakers on effective control and effective management measures for the disease, Weerasinghe said.

For instance, the US. Australia. and even countries in Southeast Asian regions like Singapore have used Aedes mosquitoes with Wolbachia bacteria to successfully reduce the number of mosquitoes in regions with dengue epidemics.

Certain strains of Wolbachia can reduce the capacity of mosquito species to transmit diseases like dengue fever, either by directly inhibiting the pathogen or by shortening the mosquito's lifespan.

"Unfortunately, currently there's no drug that can prevent dengue from spiralling into a severe state. This is a gaping hole in research and development that we urgently need to fill "Neelika added

"I can't imagine going through that again. It was terrible for the whole family," she added.

### Age, sex, location could be important to antibiotic resistance

ge, sex and location A could be important in assessing the antibiotic resistance of a bacterial infection, new research has found. Antibiotic, or antimicrobial, resistance is a global public health threat and occurs when disease-causing germs evolve and develop a resistance to the very drugs designed to kill them, rendering these drugs ineffective.

The research, led by those at London School of Hygiene and Tropical Medicine, UK, analysed data on bloodstream

infections of nearly 9.5 lakh individuals across European countries. The data was collected through routine surveillance between 2015 and

The team looked at the bacterial species that were isolated and sent to the surveillance service, and the antibiotics that were used to treat these bloodstream or bacterial infections. The findings are published in the journal PLOS Medicine.

They observed that gender played a role in antimicrobial resistance, with men at a higher risk of developing it than

The team also found that the participants' resistance to various bacterial species peaked at different stages of their lives, with the peaks related to most of these species being seen at the youngest and oldest ages.

For example, the superbug MRSA, responsible for many hard-to-treat infections in humans, becomes more resistant with increasing age of the host, whereas resistance of E. coli decreased with age, they said. E. coli can cause infections in

the gut and digestive tract. The Pseudomonas aerugi-

nosa - known to cause infections in mainly hospital patients - was found to be most likely to resist several antibiotics when the host is around 30 years old.

For women, the team found that the incidence of bloodstream infections due to E. coli peaked between ages 15 and 40.

The researchers said that even though antibiotic usage, changes in immunity, and exposure to high-risk settings are all linked to age and sex, little is known how resistance varies with age and sex.

"These findings highlight

important gaps in our knowledge of the epidemiology of antimicrobial resistance that are difficult to explain through known patterns of antibiotic exposure and healthcare contact," the authors wrote in their study.

"In order for us to address this growing threat to public health, we now need data from a wider range of sources to determine the contribution that cultural versus natural history differences have in driving these patterns globally and the role that they play in the increasing rates of AMR being seen," they wrote.

#### Rupee declines 12 paise to close at 83.02 against US dollar

Mumbai, Mar 19:

The rupee depreciated 12 paise to 83.02 (provisional) against the US dollar on Tuesday, weighed down by a heavy selloff in domestic equities and persistent foreign capital outflows. Besides, a surging greenback against major crosses overseas also pulled down the other local currency, forex traders said.

At the interbank foreign exchange market, the local unit opened at 82.94 and touched the intra-day low of 83.05 and a high of 82.93. It finally settled at 83.02 (provisional) against the dollar, registering a loss of 12 paise from its previous close.

On Monday, the rupee dropped 4 paise to settle at 82.90 against the US

### I-T dept expands scope for filing appeals by tax officers, includes TDS disputes

The CBDT has permitted income tax authorities to file appeals irrespective of monetary threshold in cases relating to TDS/TCS, undisclosed foreign income, or information received from investigating agencies like ED and GST Intelligence. Currently, tax authorities can file appeals before the ITAT, High Court and Supreme Court, if the disputed tax demand exceeds Rs 50 lakh, Rs 1 crore and Rs 2 crore respectively -- a threshold fixed in 2019.

The Central Board of Direct Taxes (CBDT) in a circular dated March 15 said that the said monetary limits will not be applicable for filing appeals in cases where prosecution has been filed by the department in the relevant case, and trial is pending and conviction order has been passed and the same has not been compounded. Cases where the assessment is based on information with regard to an

law and information received from law enforcement or intelligence agencies like CBI, ED, DRI, NIA, Directorate General of GST Intelligence (DGGI), and state law enforcement agencies, in such cases the appeals would be filed irrespective of the tax demand on the assessee.

The threshold would not

apply to litigation arising out of disputes relating to TDS/TCS in domestic and international taxation, or disputes relating to the applicability of provisions of the Double Taxation Avoidance Agreement. Taxmen would also have to file appeals irrespective of the tax demand in dispute in cases of undisclosed foreign income /assets/bank accounts.

About 2.7 crore direct tax demands totalling about Rs 35 lakh crore are being disputed at various foras. AKM Global, Tax Partner, Amit Maheshwari said the

"CBDT has broadened the scope of exceptions which are now outside the scope of monetary threshold and on which department may file the appeals / SLP irrespective of the amount involved. Such exceptions although seem to be reasonable will add to the volume of appeals filed by the department in fu ture," Maheshwari said.

The CBDT circular also clarified that an appeal should not be filed merely because the tax effect in a case exceeds the monetary limits prescribed by the CBDT. "Filing of appeals in such cases is to be decided on the merits of the case. The officers concerned should keep in mind the overall objective of reducing unnecessary litigation and providing certainty to taxpayers on their I-T assessments while taking a decision regarding filing an appeal,'

A sharp plunge in the stock market made investors poorer by Rs 4.86 lakh crore on Tuesday, on a day when the BSE benchmark Sensex tanked over 700 points. The Sensex tumbled 736.37 points or 1.01 per cent to finish at  $72,01\overline{2}.05$ . During the day, the benchmark fell by 815.07 points or 1.12 per cent to 71,933.35. Amid weak leads from equities, the market capitalisation of BSE-listed firms fell by Rs 4,86,777.98 crore to Rs 3,73,92,545.45 crore.

Following the BoJ's (Bank of Japan) decision to hike interest rates for the first time in 17 years, the Asian peers' mood turned sour, which pulled the Indian mar-

The automaker has also lined up a capex of EUR 41 billion for the period between 2024-2028. Audi AG will invest EUR 11.5 billion in the development of ICE (internal combustion engine), PHEV (plug-in hybrid electric vehicle) and other segments and EUR 29.5 billion for BEV (battery electric vehicles) and digitisation. **Benchmark Sensex tanked** 736 points while Nifty fell below the 22,000 level on Tuesday following a sell-off in index majors TCS, Infosys and RIL and weak Asian trends as Japan's central bank hiked rates for the first time in 17 years. The 30share BSE Sensex tanked 736.37 points or 1.01 per cent to settle at more than a month's low of 72,012.05. As many as 23 Sensex shares declined while seven advanced. The index declined by 815.07 points or 1.12 per cent to slide below 72,000 at 71,933.35 in day trade. The broader NSE Nifty

slumped 238.25 points or

1.08 per cent to settle at a month's low of 21,817.45. As many as 41 Nifty shares closed in the red while nine ended with gains. The key indices opened on a weak note amid losses in Asian markets as the Bank of Japan hiked interest rates for the first time in 17 years. Investors were also cautious ahead of the US Fed interest rate decision this week, analysts said. Sharp losses in TCS also dragged the indices to month's lows. ### Exporters need to follow new UK rules to avail duty benefits: DGFT

New Delhi, Mar 18:

Exporters seeking to avail duty concessions on shipments to the UK will have to adhere to the new British rules under the Developing Countries Trading Scheme (DCTS). In a trade notice, the Directorate General of Foreign Trade said that the United Kingdom (UK) has replaced its existing origin declaration process Generalized Scheme of Preferences (GSP) with the UK DCTS effective from June 19. 2023. The transition period for this change was extended until December 31, "Starting from January 1, 2024, onwards,

are required to adhere to the new rules under DCTS to avail concessions on their exports to the UK," the trade notice to the exporters community said. It added that goods that meet the UK DCTS Rules of Origin (RoO) requirements would be eligible to claim a concessional rate of import duty for exports to the UK. "Consequently, the origin criteria necessary for satisfying the Rules of Origin to avail tariff concessions on exports from India to the UK must be filled in through self-certification," it added. Accordingly, it said, Indian exporters are directed to use origin declaration

Indian exporters to the UK wording under DCTS scheme, in place of origin declaration wording under GSP. Certain labour-intensive sectors such as leather, carpets, chemicals, iron amd steel and textiles were the major beneficiaries of the GSP scheme. The US, European Union (EU), Australia, Japan and many other developed countries grant unilateral import duty concessions to developing countries under their GSP schemes. As per estimates, India's exports worth USD 2.5 billion were entitled for the GSP benefit in the UK. and the UK have been negotiating a free trade agreement since January 13, 2021.

### Matua body asks members not to apply under CAA

Till formation of new govt

Kolkata, Mar 19 (PTI):

The Matua community's initial jubilation over the implementation of CAA has been dampened as its key organisation advised its members not to apply for citizenship under the new law for now as many of them do not have documents required to prove their previous residential address in Bangladesh.

The All India Matua Mahasangha has asked its members to apply for Indian citizenship only after the formation of a new government at the Centre. Matuas, originally from East Pakistan, are a weaker section of Hindus who migrated to India during the Partition and after the creation of Bangladesh following religious perse-

Rules of the CAA were notified last week, and the government will now start granting Indian nationalito persecuted non-Muslim migrants



Hindus, Sikhs, Jains, Buddhists, Parsis, and Christians Pakistan, Bangladesh, and Afghanistan who arrived in India before December 31, 2014. All India Matua Mahasangha general secretary Mahitosh Baidya said a communication has been sent to all the members of the community "not to file applications for citizenship till the formation of the next government". The Centre has launched a portal for applying for citizenship under the CAA.

"After the rules were framed, several members of the Matua community tried to fill up online applications. But they faced problems since while filling up column 5, they have been asked to fill it with address proof or documents related to their residence in Bangladesh," Baidya told PTI.

Baidya highlighted that the Matuas face a catch-22 situation, as the majority either arrived without documents from Bangladesh or discarded them after obtaining some in India. "They destroyed the old documents after managing voter cards and Aadhaar cards here since it is dangerous for a person to carry documents from two

Election Commission, on the ground that it is disrupting the level playing field. The NCP, founded by Sharad Pawar, had 'clock' as its election symbol before its split. The symbol is now with the Ajit Pawar faction. The bench directed the Election Commission and State Election Commission (SEC) to recognise the 'Nationalist Congress Party-Sharadchandra Pawar' and

its symbol 'man blowing turha'. It also asked the EC to not allot the 'man blowing turha' symbol to any other party or an independent candidate. It asked the Maharashtra deputy chief minister Ajit Pawar-led faction to issue a public notice in newspapers in English, Hindi and Marathi saying that the 'clock' symbol is sub-judice and its use is subject to adjudication.
