Centre defends dropping CJI

- From EC selection team
- Says EC's independence doesn't stem from judicial member's presence

New Delhi, Mar 20 (PTI):

Centre Wednesday defended in the Supreme Court the appointment of two new election commissioners

(ECs) under a 2023 law that excludes the Chief Justice of India from the selection committee, saying the independence of the Election Commission does not arise from the presence of a judicial member on the commit-

In an affidavit filed in the apex court, the Union Law Ministry rejected the petitioner's claim that the two election commissioners were hastily appointed on March 14 to "pre-empt" the orders of the

top court the next day, when the matters challenging the 2023 law were listed for hearing on interim relief. The affidavit has been

filed in response to a batch of pleas, including those by Congress leader Jaya Thakur and the Association for Reforms, Democratic challenging the Chief Election Commissioner other Election Commissioners (Appointment, Conditions of Service and

Terms of Office) Act, 2023. "It is submitted that the case of the petitioners is premised on one fundamental fallacy that the independence can only be maintained in any authority when the selection committee is of a particular formulation. It must be noted that the independence of Election commission, or any other organisation or authority, does not arise

from and is not attributa-

ble to the presence of a ju-

dicial member in the se-

lection committee," the affidavit said.

Refuting the petitioners' claim that no list of probable appointees was shared with the opposition, the Centre submitted that the names of short-listed persons were made available to Leader of the Opposition in the Lok Sabha Adhir Ranjan Chowdhury on March 13, 2024, after the Search Committee had finalised six names for recommendation. "It is, therefore, wholly wrong, misleading

and malicious to suggest that the third member of the Selection Committee was given the shortlisted names as an act of premeditation on the mind of the two members of the Executive as all the members received the list simultaneously. Furthermore, the list of dates clearly brings out the fact that profiles of all eligible persons were shared with the leader of the single largest opposition party in the Lok Saba on March 13, 2024

Two teenagers held for raping 5-year-old girl

Bilaspur, Mar 20:

A five-year-old girl was allegedly raped multiple times by two teenage boys living in her neighbourhood in Bilaspur district, police said on Wednesday.

The minor boys, both aged 15 years, were detained on Tuesday evening based on a complaint of the victim's mother, said Gopal Satpathi, Station House Officer (SHO), Koni police station.

As per the complaint, the two accused sexually assaulted the girl multiple times in the last one month after luring her chocolates snacks, he said.

The victim and the accused resided in the same neighbourhood, the officer said. Based on the complaint, a case was registered against the duo under provisions of the Indian Penal Code and the Protection of Children

Mohammed Abdul, a resident of Nacharam here, went to the US in May 2023 to pursue a Masters in IT from Cleveland University, and was staying in Cleveland. his family said. Saleem, Mohammed

Abdul's father, said his son last spoke to him on March 7, and since then he was not in touch with his family and his mobile phone was switched off.

Abdul's roommates in



the US informed him that they have lodged a missing complaint with Cleveland Police. However, on March 19, Abdul's family received a call from an unidentified person, who claimed that Abdul had been kidnapped allegedly by a gang selling drugs and demanded USD 1,200 to "release" him.

The caller also threat ened to sell Abdul's kidnevs if the ransom wasn't paid, his father said.

SC recommends transfer of Chh'garh HC judge Arvind **Singh Chandel to Patna HC**

New Delhi, Mar 20 (PTI):

The Supreme Court collegium headed by Chief Justice D Y Chandrachud on Wednesday resolved to recommend transfer of Chhattisgarh High Court judge Arvind Singh Chandel to the Patna High Court after he sought reconsideration of the earlier proposal. On March 15, the collegium had proposed transfer of Justice Chandel to the Madras High Court for better administration of justice. In terms of the Memorandum of Procedure, Justice Chandel was requested to send his response to the recommendation. By a communication

dated March 17, he requested

reconsideration of the proposal of his transfer or to consider transferring him to any of five high courts -- Raiasthan. Madhya Pradesh, Allahabad, Punjab and Haryana or Delhi. The collegium said in terms of the Memorandum of Procedure, it consulted one of the judges of the Supreme Court who being conversant with the affairs of the High Court of Chhattisgarh is in a position to offer views on the proposed transfer. The chief justice of the high court of judicature at Patna, whose opinion was sought in terms of the Memorandum of Procedure, also conveyed his consent to the proposed trans-

fer of Justice Chandel, it said.



Raipur Municipal Corporation lags behind in revenue collection

Will have to collect Rs 7 crore every day to meet the target

Raipur, Mar 20: The Municipal Corporation has again lagged behind in revenue collection. There are only 11 days left for the financial year to end and the revenue collection has reached only Rs 174 crore. In such a situation, to meet the target, the corporation will now have to recover approximately Rs 7 crore every day. Meanwhile, there will be two days of Holi holiday along with two Sundays. This has increased the concern of corporation officers and employees.

This year the corporation has set a target of revenue collection of Rs 250 crore, but so far only Rs 174 crore has been collected. Whereas last year a revenue of Rs 223 crore was collected. Currently, the corporation is lagging behind by Rs 49 crore as



compared to last year. At the same time, to achieve its target, the corporation is left to recover Rs 76 crore. Corporation officials said that the target will be achieved on time. The financial year ends on March 31. There will also be Holi holiday in these 11 days. It is difficult to achieve the target due to

The corporation is taking action to collect revenue through all the zones. In this, the revenue officers of the zone along with the corporation central team are continuously taking action of attachment and sealing against the defaulters, but even after this the treasury of the corporation does not seem to be

Commissioner is also busy on the orders of the Corporation Commissioner. Direct action is being taken by the competent authorities against defaulters who use identity or access to make revenue payments.

The target of the corporation's revenue team are the big defaulters of the city. The corporation team is collecting revenue by preparing a zone-wise list of big defaulters of the city. Even after this the revenue is not being paid by the defaulters.

Revenue officials said that there are some defaulters from whom officials have to make several trips to recover money. If they do not pay even after repeated calls, then action is taken against them. Officials say that everyone has to pay the revenue, but if they are not paying revenue on time, they are charged tax with 17 per-

Issue of cheating heats up again Applications of 50 women of in Atmanand Girl's School Tikrapara missing for MVY

In mathematics paper of 10th Board

Khairagarh, Mar 20:

The issue of cheating in Mathematics paper is gainmomentum Atmanand Girls School of District Headquarters. It is known that on March 9, a complaint memorandum related to the cheating case in the school premises was submitted by the students there to the Collector and the District Education Officer, in which the students specifically informed

the Collector and the DEO

about the cheating case and the involvement of some teachers. But after this, despite the formation of the inquiry committee. no meaningful action has been taken till date.

On the complaint by the students regarding the cheating case in Kanya Shala Atmanand School by the District Education Officer, an investigation committee team was constituted by the then District Education Officer Fattaram Ram Kosaria, in which the investigation team has not taken any action till date, giving rise to doubts. Allegedly, when

the students complained, some students received threatening phone calls and some were given verbal threats, in protest against which the students took immediate action by reaching the Collectorate premises and submitting a memorandum to the Collector.

The investigation committee team includes Dr. Rashmi Khare, Assistant Education Officer, Kishori Lal Amela, Assistant Development Block Officer. Education Girendra Khairagarh, Assistant Education Meanwhile, the department has given notice to the center head and four supervisors. Regarding the cheating issue in the board exam, the department has revealed from some reliable sources that the investigation process will be conducted under the leadership of the investigation team in the school premises on March 22 and while further action will be taken mainly by the investigation team by seeking answers from the complaining students.




Pakistan not to tolerate cross-border terrorism: PM Shehbaz Sharif

Islamabad, Mar 20 (PTI):

Amidst a spike in terror attacks in Pakistan, Prime Minister Shehbaz Sharif on Wednesday asserted that his government will not tolerate any acts of cross-border terrorism and that his country would like to exist in peace with all its neigh-

Days after what is now known as the Mir Ali attack in the restive northwest Pakistan, Prime Minister Shehbaz Sharif was addressing the first meeting of the apex committee – a top official civil-military body tasked to tackle militancy since the new government came to power earlier in the

Pakistan is facing a renewed threat by militancy. Over the weekend, two



five soldiers were killed in a terror attack at Mir Ali in the troubled northwest of the country. Without naming any country, Sharif asserted that his country would not tolerate any cross-border terrorism from the neighbouring countries "under no circumstances."

The prime minister said that Pakistan would like to bours and urged them to come and sit with Pakistan to devise a plan against terrorism "with sincerity of purpose work towards erad-

"We want to exist in a very peaceful environment with our neighbouring merce and expand our relations — but unfortunately, if a neighbour's land is used for terrorism, this is intolerable" he stated. The premier also hoped that "our neighbouring country will carefully consider my invitation." There has been an uptick in the incidents of terrorism in Pakistan since the Taliban took over the government in Kabul in 2021, dashing hopes in Islamahad that a friendly government in Afghanistan would help to tackle mili-

Texas' migrant arrest

7 dead after South Korean tanker capsizes off Japan, 2 still missing

Tokyo, Mar 20 (AP):

A South Korean tanker capsized off an island in southwestern Japan on Wednesday, authorities said, killing seven people on board. One crew member survived, and the fate of three others was un-

The Japan Coast Guard said it received a distress call from the chemical tanker Keoyoung Sun, saying that it was tilting while seeking refuge from the weather near Japan's Mutsure Island, about 1,000 kilometers (620 miles) from Tokyo in southwestern Japan.

The ship was completely capsized by the time rescuers arrived at the scene. Footage on Japan's NHK television showed the ship lying upside down, a rough sea washing over its

The ship was carrying 11 crew, of whom nine have been found, authorities said. The one crew member confirmed alive was from Indonesia, while the coast guard is still searching for two more. Another person found was in unknown condition, officials said.

The ship was en route from the Japanese port of Himeji to Ulsan in South Korea from, according to NHK. Its captain was South Korean, and its crew included another South Korean national, a Chinese national and eight Indonesians, according to the coast guard.

The tanker was carrying 980 tons of acrylic acid, officials said. No leak has been detected, and officials are studying what environmental protection measures may be needed

Imran Khan approaches Supreme Court; seeks judicial commission probe into Feb polls

Islamabad, Mar 20 (PTI):

Pakistan's jailed former prime minister Imran Khan on Wednesday approached the Supreme Court to form a judicial commission comprising serving judges to probe the authenticity of last month's elections marred by allegations of rigging.

The general elections were held on February 8 but Khan's Pakistan Tehreek-e-Insaf refused to accept the outcome by alleging that the results were manipulated.

Senior lawyer Hamid Khan, who is also a leader of PTI, filed the petition on behalf of Khan, stating the commission should investigate, audit and review matters related to the procedure and conduct of the general elections held on results and the investiga-

tion should be complete and made public.

"It is further prayed that all the consequential acts of forming the government at the federal and Punjab levels be immediately suspended till the result of the probe by the Judicial Commission appointed on this behalf is made public," the petition stated. Khan's party claims that it had won

National Assembly but the results were rigged and it was deprived of dozens of them and won only 92 out of 266 contested seats. The Pakistan Muslim League-Nawaz (PML-N) and the Pakistan Peoples Party (PPP) along with some other political parties have formed a coalition government, denying Khan's PTI from returning to power.

However, the Election Commission of Pakistan rejected the allegation and said that polling was held in a fair manner and results compiled accordingly. Though the PTI has joined Parliament, it has been protesting in the assemblies as well as outside on the streets against the alleged injustice. Khan's party has formed a government in the Khyber-Pakhtunkhwa province

The agreement, however, is subject to the approval of the Executive Board of the International Monetary Fund (IMF) to be held in April.

Pakistan's new finance minister Aurangzeb, who assumed charge last week, had said that his priority was to start negotiations with the Washington-based IMF to bail out the country from its

the IMF Executive Board Stand-By Arrangement (SBA) for Pakistan, the term for which is set to expire next month. So far, two tranches have been issued while the last one is pending the review of the conditions set by the lender.

Led by IMF's Mission chief to Pakistan, Nathan Porter, the team visited Islamabad from March 14 to 19 and discussed the Second Review of Pakistan's economic programme with senior officials. Doing business in China is growing tougher, more uncertain: European business group

Beijing, Mar 20 (AP)

Uncertainty and "draconian regulations" have drastically raised risks for foreign businesses in China, a report by a European business group said on Wednesday.

The lengthy paper by the European Union Chamber of Commerce in China urges China's leaders to do more to address concerns that it says have "grown exponentially" in recent years. "This report comes at a time when the global business environment is becoming increasingly politicised, and companies are having to make some very tough decisions about

how, or in some cases if, they can continue to engage with the Chinese market," it says. The study, compiled by the chamber and the China Macro Group consultancy, echoes concerns that have been raised European

American companies operating in China. Foreign investment fell 8 per cent last year from a year earlier as companies recalibrated their commitments in the world's second largest economv. EU Chamber officials said China's changing business environment partly reflects moves by Beijing to minimise risks due to trade friction and dependence on imports of key commodities or industrial products. That's especially the case given trade friction with Washington and discussions about "decoupling" supply chains from China after the disruptions that occurred during COVID-19 pandemic.

But they said European companies also must manage their own risks. China has sought to emphasise its openness to foreign companies and investment. Its commerce ministry spokesperson said the country was working to ensure 100 per cent access to manufacturing by eliminating remaining trade barriers.

On Tuesday, the State

Council, China's Cabinet, issued an updated version of an action plan announced in July to promote more foreign investment, especially in high-tech areas favoured for growth such as computer chips, biopharmaceuticals and advanced equipment.

, Krishna and his wife Radha live near this tree. Lord Vishnu has said that the fast of Amalaki Ekadashi of Falgun Shukla Paksha is very good for those who wish to attain heaven and

Story of Amalaki Ekadashi

According to the legend, two stories are read and heard about Amalaki Ekadashi. In one story, there is a story of getting the virtue of the Amalaki Ekadashi fast done in this birth and in another story, there is a story of getting the virtue of this fast done in the previous birth in the next birth. The meaning of both the stories is the same that the fast of Amalaki Ekadashi is auspicious in every birth.

According to the first story, King Chitrasen and his subjects kept the fast of Amalaki Ekadashi. During one of his hunting trips, King Chitrasen fought with demons and fell unconscious. When he regained consciousness, he found the demons lying around him. He understood that this was the auspicious effect of Amalaki Ekadashi fast, he and his subjects observed.

According Brahmanda Purana, Sage Vasishtha has told that King Chaitrarath of Vaidisa and his subjects were blessed with wealth due to the worship of visnnu.

Once, on Amalaki Ekadashi, Chaitrarath and his subjects were worshipping Vishnu and the Amla tree ,near the Vishnu temple on the river bank. The devotees kept fast and stayed awake all night to worship Vishnu ji. A hungry hunter joined the group and unknowingly observed the Amalaki Ekadashi fast. The good deeds of which he received in his next birth. It is said that after his death he was reborn as King Vasurtha.

Rituals to be performed on Amalaki Ekadashi

On this day, devotees take a vow to fast after taking bath and stand in front of the idol or picture of Lord Vishnu with sesame seeds, kusha, mudra and water in their hands. They pray to Lord Vishnu for salvation. After this, Lord Hari is worshipped with full rituals. After worshipping the Lord, the Amla tree is worshipped with the worship material. First of all, the land around the tree is smeared with cow dung and sanctified. A Kalash is placed at the root of the tree and the gods, holy rivers and pilgrimage sites are symbolically invited in this Kalash.

Put Pancha Pallava on the Kalash and a lamp is lit. Sandalwood is applied around the neck of the Kalash and clothes are worn.

Finally, a golden idol of Parshuram, the sage incarnation of Lord Vishnu, is placed on the Kalash and it is worshipped in a proper manner. On the day of Dwadashi, after taking bath in the morning, feed a Brahmin, pray for prosperity, wealth and health and offer as much donation as possible. Only after that, the devotee takes food and water. Although the festival of starts from Vasant Panchami, but the main celebration starts from Amalaki Ekadashi and ends on Poornima. in ancient times, people used to start playing with colors from

JSW MG Motor India to invest Rs 5,000 cr, to set up second plant at Halol

MG Motor India will invest Rs 5,000 crore to enhance production capacity and launch one new car every 3-6 months starting September, top company officials said on Wednesday. The newly formed company, a joint venture between China's SAIC and Indian conglomerate JSW Group will also seek to create a "Maruti moment" in the new energy vehicle segment, JSW Group Chairman Sajjan Jindal said here, while announcing the finalisation of the partnership here. The joint venture aims to sell one million units of passenger electric vehicles in India by 2030 when the total market is expected to be 10 million units annually. "We have announced today that we are going to



have our second plant in Gujarat near our existing unit at Halol itself," MG Motor India Chairman Emeritus Rajeev Chaba told PTI on the sidelines of the event. The company's production capacity will go from over 1 lakh per year to over 3 lakh a year,

Asked about the investment, he said, "The total investment from all stakeholders in this space is going to be over Rs 5,000 crore on capacity enhancement and new product introductions." Outlining the roadmap for the company, Jindal in his address said the JSW Group believes in scale when it comes to building capacity. "We are going to churn the whole industry a lot and we will create some sort of disruption in the industry. Our idea is that we will bring one new car every 3-4 months, six months down the line," he said.

September onwards, he said, "We will be bringing the new cars. We will manufacture them in India not only for India but also export these cars to the most developed markets." "Forty years ago when Maruti came to India, it changed the auto industry. It brought very efficient cars, very lightweight cars and the Ambassadors and the Fiats went into oblivion. "Maruti brought in state-of-the-art new cars. Today they are the market leader." he said.

"I believe that with MG we can create a new energy vehicle Maruti moment," Jindal said. JSW MG Motor India is seeking to be the market leader in the new energy vehicle (NEV) segment in India, targeting sales of 10 lakh units annually by 2030.

This will be the fourth time in five years that India will face Afghanistan in an official match. The two meetings in the World Cup Qualifiers in 2019 and 2021 ended 1-1 each, while India ran out 2-1 winners in the Asian Cup Qualifiers in 2022 in Kolkata, thanks to Sahal Abdul Samad's added-time

"We have been training normally as usual. We came here earlier so the boys can adapt to the different climate in Abha, and things look okay at the moment," said the Croat.

Indian men and women occupy second place in maiden FIH Hockey 5s rankings

Lausanne, Mar 20 (PTI):

Indian men's and women's teams are both placed second in the maiden Hockey 5s rankings issued recently by the world body (FIH).

The Indian men's team occupies second spot jointly with Oman and Malaysia following a three-way tie with 1400 points each.

Having won the Asian Championship, India had finished fifth at the World Cup at Muscat from January 28-31.

Oman on the other hand had won bronze medal in front of their home crowd in their first-ever World

Cup appearance.
World Cup runners-up
Malaysia improved massively since their fourthplace finish at the Asian

Championships.

The Netherlands (1750 points) lead the pack after winning the inaugural World Cup following their victory at the European Championships.

Poland (1350) and Egypt (1350) are tied for fifth place in the world rankings. Poland narrowly

missed out on the bronze medal in the World Cup, while Egypt finished in sixth place.

Following closely behind are Trinidad & Tobago (1200) and Kenya (1200) tied for seventh in the world rankings.

Pakistan (1150) find themselves in ninth place, after winning the Challenger Trophy at the World Cup and Australia (1100) close out the top-10.

The Netherlands once again occupy pole position in the women's rankings with their gold medal at the World Cup as well as the European Championships that se-

cured them 1750 points.

India (1550), who won the silver medal at the World Cup after winning the Asian Championship, are ranked second. World Cup bronze medallists Poland (1450) are placed third. Uruguay (1350) and South Africa (1350) are tied for fourth place after their impressive show at

the World Cup.

Malaysia (1250) are ranked sixth following a sixth place finish in the

T20I rankings: Surya maintains pole position in batting list

Dubai, Mar 20 (PTI):

Suryakumar Yadav maintained his numero uno position among batters despite being out of competitive cricket for past three months while ace spinner Rashid Khan, back in Afghan jersey after an injury lay-off, is back among top-10 in bowlers' list in the latest ICC T20I rankings published on Wednesday.

Surya, who will make a comeback for Mumbai Indians in the upcoming IPL, is way ahead of the pack with 861 points under his belt. Phil Salt is a distant number two with 802 points. Surya hadn't played any cricket since December, having undergone sports hernia surgery.

Afghanistan spin wizard Rashid re-entered the elite list of the ICC men's T20I bowler rankings following his contribution in team's 2-1 series victory over

The 25-year-old spinner returned from injury in style, claiming eight wickets and his exploits saw



ninth in the latest rankings. The Afghanistan ace collected a series-high eight wickets over the three matches at an average of 5.62 in what was his first series since he injured his back during last year's ICC Men's Cricket World Cup. Rashid, who first held the No.1 ranking for T20I bowlers at the start of 2018 and has consistently remained near the top, only slipped out of the top 10 recently and will be keen to maintain his position within the premier spots in the lead-up to the T20 World Cup in USA and the Caribbean.

Rashid's Afghanistan teammate Naveen-ul-Haq (up two places to 55th) made some ground following his three wickets during the Ireland series, while Irish trio of Josh Little (up seven spots to 39th), Mark Adair (up two places to 56th) and Barry McCarthy (up 15 spots to 77th) also boosted their T20I bowler ranking that is still being led by England spinner Adil Rashid.

Treesa-Gayatri pair enters second round of Swiss Open

Indian shuttlers Treesa Jolly and Gayatri Gopichand advanced to the women's doubles second round of the Swiss Open Super 300 with a straight game win over USA's Annie Xu and Kerry Xu here.

Treesa and Gayatri, who made a first round exit at the All England Open last week, cruised past the American duo in 39 minutes with a 21-15, 21-12 win in the opening round on Tuesday.

Starc puts on a spirited show in warmup match

Returning to "IPL circus" after almost a decade, Australian left-arm pacer Mitchell Starc bowled with the new ball, and took some hits from Rinku Singh at the death during Kolkata Knight Riders' second warm-up match at Eden Gardens here on Tuesday.

The Aussie, who last played in the IPL for Royal Challengers Bangalore in 2014 and 2015, was bought by KKR ahead of IPL 2018 but an injury had ruled him out of that season.

The Shah Rukh Khanowned franchise broke the all-time auction record this year to buy him at a price tag of Rs 24.75-crore to bolster their pace attack that had lacked sting in the recent past.

"It's always a bit of a circus when it is the best T20 league in the world. It's definitely a new challenge. Yeah, it's going to be excit-



ing. So, yeah I look forward to it," Starc told cricket.com.au.

"I guess my memories are a few and far between of back in 2014 and 2015 with RCB but yeah, really excited to get stuck in. Obviously, a new group of players. A bunch of guys I certainly haven't met or been able to work with before," he said.

Representing Team Purple in their warm-up match against Team Gold, the 34-year-old appeared

very positive.
Starc bowled full tilt

with the new ball, giving Rahmanullah Gurbaz and 18-year-old Angkrish Raghuvanshi some anxious moments in his opening over.

He generated odd bounce from a sluggish Eden wicket, as the 2022 U-19 World Cup winner Angkrish was beaten a few times outside the offstump.

Starc troubled Afghan batter Gurbaz with an awkward bounce before trapping him LBW in an eventful opening over that read 1-0-1-1.

Rishabh Pant appointed Delhi Capitals captain for IPL 2024

Rishabh Pant was on Tuesday appointed as the captain of Delhi Capitals for the upcoming edition of the IPL, marking a wonderful chapter in his miraculous comeback saga.

The keeper-batter missed cricketing action for 14 months after suffering a horrific car accident in December 2022.

"We are delighted to welcome Rishabh back as our captain. Grit and fearlessness have always dictated his brand of cricket, and not surprisingly, even his road to recovery.

"I can't wait to see him walk our team out once again as we look forward to a new season with renewed passion, vigour and enthusiasm," said DC chairman and co-owner Parth Jindal in a media release.

The left-hander has been a part of the Capitals preseason preparatory camp in Visakhapatnam, ahead of their first IPL 2024 match against Punjab Kings in



Chandigarh on March 23. The IPL begins on March

Earlier, Pant was given clearance by the BCCI to play as a wicketkeeper batter in this year's IPL.

"After undergoing an extensive 14-month rehab and recovery process, following a life-threatening road mishap on December 30, 2022, near Roorkee, Uttarakhand, Rishabh Pant has now been declared fit as a wicket-keeper batter for the upcoming IPL 2024," the board had stated in a medical update.

'Need to move beyond Nehru era cult worship'

New Delhi, Mar 20 (PTI)

External Minister S Jaishankar on Wednesday took a critical view of some of the key decisions made by the Jawaharlal Nehru government, and said one needs to get out of this "cult worship" that the period from 1946 onwards was "great years" and the country did 'splendidly".

In the early years, it was very much "a Nehruvian ideological bubble" when it came to foreign policy and "vestiges of that continue, even today," he said in response to a question during a session at the News18 Rising Bharat Summit here.

A career diplomatturned-politician, Jaishankar spoke on a range of issues such as India's role during G20 presidency, the criticism surrounding

Citizenship (Amendment) Act, abrogation of Article 370, and India-China and India-Pakistan relations in the current context and the geopolitical scenario.

Asked about the legacy of the foreign policy of the government in the early years after independence, Jaishankar said, "You got Pakistan wrong, you got China wrong, you got US right, and we had a great foreign policy. So, put that

mind," he said, adding he would also be very happy to discuss the last 10 years with anyone He argued that in the

early years after independence, "it was very much a Nehruvian ideological bubble. Nehru was against America, so everybody was against America. Nehru said China is a great friend, everybody said China is a great friend. So, the vestiges of that continue, even today". "I mean, you have a con-

cept called 'Chindia', and many of you will remember, who put that concept Jaishankar forward.' added. On ties with Pakistan,

he said, India's relations with its neighbours at a formal level are "very min-

It happened for two reasons, one is that India has "put terrorism fair and square at the centre of the relationship"

Secondly, Pakistan's reaction to the "long-awaited decision" on abrogation of Article 370, he said.

"So what would the opposition want us to do, not do (Article) 370, because it will upset Pakistan. Or talk to Pakistan, ignoring that they do terrorism. Actually, that is what the opposition was doing," the minister said.

Jaishankar asserted that foreign policy is "not run as a global popularity exercise" and said, "if you have an appeasement mentality at home, you will take it outside"

'Inequality rising since 2000s, top 1 pc in India holds 40 pc wealth'

New Delhi, Mar 20 (PTI):

Inequality in India has skyrocketed since early 2000s, with the income and wealth share of top 1 per cent population rising to 22.6 per cent and 40.1 per cent, respectively, in 2022-23, according to a working paper. The paper titled 'Income and Wealth Inequality in India, 1922-2023: The Rise of the Billionaire Raj' said between 2014-15 and 2022-23, the rise of top-end inequality has been particularly pronounced in terms of wealth

concentration. The paper authored by Thomas Piketty (Paris School of Economics and World Inequality Lab), Lucas Chancel (Harvard Kennedy School and World Inequality Lab) and Nitin Kumar Bharti (New York University and World Inequality Lab). "Between 2014-15 and 2022-23, the rise of top-end inequality has been particularly pronounced in terms of wealth concentration.

"By 2022-23, top 1 per cent income and wealth shares (22.6 per cent and 40.1 per cent) are at their highest historical levels and India's top 1 per cent income share is among the very highest in the world, higher than even South Africa, Brazil, and the US," the paper said. According to the paper, the Indian income tax system might be regressive when viewed from the lens of net wealth. "A restructuring of the tax code to account for both income and wealth, and broad-based public investments in health, education and nutrition are needed to enable the average Indian, and not just the elites, to meaningfully benefit from the ongoing wave of globalisation," it noted. As per the paper, besides serving as a tool to fight inequality, a "super tax" of 2 per cent on the net wealth of the 167 wealthiest families in 2022-23 would yield 0.5 per cent of national income in revenues and create valuable fiscal space to facilitate such investments.

ing in Jharkhand. The top court was hearing the default bail plea of Prem Prakash, an alleged associate of former Jharkhand chief minister Hemant Soren. Prakash was arrested in August, 2022 after raids during which two AK-47 rifles, 60

live rounds and two magazines were claimed to have been found at his home in Ranchi. He was booked for the offences of money laundering and under the Arms Act.
