A total of 31 accused were made in this case, out of which two, Baltu Pathak and Surendra Singh, became government witnesses.

nosed with Sickle Cell disease at the age of 2. Initially, his family opted for the standard treatment, which included regular blood transfusions and a few medications. While the treatment helped him survive the disease, Jay experienced frequent excruciating episodes of pain that were difficult to bear. Gradually, the frequency and severity of these pains became overwhelming, raising concerns about his survival, according to his father, Raju Diwan, a resident of Korba district in Chhattisgarh. During one of their visits to the hospital, they met a boy who was the same age as Jay and had undergone a bone marrow transplant in January 2023. His transplant was performed by Dr. Gaurav Kharya, director of the Centre for Bone Marrow Transplant at Indraprastha Apollo Hospital in Delhi. The parents of this boy shared their story,

explaining how the transplant had relieved him of the pain and other complications caused by Sickle Cell disease. Inspired by this encounter, Jay's family decided to pursue a bone marrow transplant and consulted Dr. Gaurav Kharya. Dr. Kharya invited them to Indraprastha Apollo Hospital in Delhi for the treatment. "Currently, bone marrow transplant is the only curative treatment available for Sickle Cell Anemia, and its success rate has significantly improved in recent years," says Dr. Kharya. He says the advancements in

enhanced the success of various types of transplants, including haploidentical (half-matched) transplants, matched related donor (MRD) transplants where a sibling provides the bone marrow, as well as unmatched and unrelated donor transplants. "Precise planning is crucial for successful transplants, and in most cases, patients are given a new lease on life. The earlier the transplant is performed, the better the patient's chances of recovery, as repeated infections and other complications can

says Dr. Kharya. In July last year Jay and his family traveled to Delhi, where further tests were conducted on Jay, his mother, and his father to determine the best donor. His father was found to be a better match. Jay underwent two rounds of chemotherapy, followed by radiation, to eliminate his original bone marrow cells. Afterward, the donor's cells were transplanted into his body Six months later, Jav is now free of pain and ready to begin his Class 12 studies, eager to catch up on the education he missed during his years of illness. Raiu expresses only one regret-that they had not made the decision to pursue a bone marrow transplant sooner Most patients with Sickle Cell disease go for standard treatment- regular blood transfusions and oral medications- to manage the disease. However, the quality of life for these patients deteriorates with age.

In 2014, Gamang was

again defeated by BJD's Jhina Hikaka from Koraput LS seat and his wife, who had switched over to BJD from Congress and contested the 2014 assembly poll from Laxmipur lost the election, in spite of Chief Minister Naveen Patnaik's wave sweeping across the state. Similarly Pangi who had entered the state assembly at age 25 by winning the Pottangi assembly constituency under Koraput Lok Sabha seat in 1977 as a Janata Party candidate was denied a Congress ticket despite his recent entry to the party.

US election: Trump leads Biden in 6 of 7 battleground states, says latest opinion poll

Washington, Apr 04 (PTI):

Ahead of the upcoming US scheduled November, President Joe Biden is trailing behind his main opponent Donald Trump in six of the seven battleground states, according to a latest opinion poll.

Voters are broadly dissatisfied with the national economy and there are deep doubts about Biden's capabilities and job performance, the survey conducted by the Wall Street Journal revealed.

Trump leads between two and eight percentage points in six battleground states of Michigan, Pennsylvania, Arizona, Georgia, Nevada and North Carolina. However, Biden is leading Trump by

three points in Wisconsin. In every state in the survey, negative views of the president's job performance outweigh positive views by 16 percentage points or more, with the gap topping 20 points in four states. By contrast, Trump earns an unfavourable job review for his time in the White House in only a single state -Arizona – where negative marks outweigh positive ones by 1 percentage point, The Wall Street Journal reported.

Helsinki, Apr 04 (AP):

Finland will extend the closure of its border crossing points with Russia bevond the current April 14 deadline "until further notice" due to a high risk of organised migration orchestrated by Moscow, the Finnish government said on Thursday.

The Finnish Interior Ministry said in a statement that the Nordic country's national security and public order would come under serious threat if the estimated hundreds of third-country nationals were to continue to attempt to enter from Russia without proper documentation.

"Based on information provided by public authorities, the risk that instrumentalised migration (by Russia) will resume and expand as seen previously remains likely," the min-

Finland closed the 1,340kilometre land border late last year after more than 1.300 migrants without proper documentation or visas — an unusually high number — entered the country in the three months since September, not long after Finland joined the NATO alliance.

Most of the migrants hail from the Middle East and Africa, from countries including Afghanistan, Egypt, Iraq, Somalia, Syria and Yemen.

The SCO must prioritize counterterrorism efforts, including the prevention of cross-border terrorism and the use of technology by terrorist organizations. Effective mechanisms for cooperation, such as the Regional Anti-Terrorism Structure (RATS), must be strengthened to combat terror financing and ensure swift action against perpetrators. The security situation in Afghanistan remains a pressing concern, with terrorist networks posing a significant threat to regional stability. India's support for humanitarian assistance, inclusive governance, and counterterrorism efforts in Afghanistan reflects its commitment to promoting peace and security in the region. As India assumes a proactive role within the SCO, it is essential to align its priorities with the acronym SECURE: Security, Economic Cooperation, Connectivity, Unity, Respect for Sovereignty and Territorial Integrity, and Environment Protection. By upholding these principles, the SCO can emerge as a potent force for regional stability and prosperity.

Gut bacteria and the immune system

How aging changes the microbiome and can lead to inflammaging

he human immune system changes with age. Immune responses start to become less robust as people get older, which makes them more vulnerable to certain infections and diseases. However, immune system aging looks different from person to person. Research has shown that changes to the composition and diversity of the microorganisms in the gut may explain these differences in immune system aging.

The gut microbiome — the population of microorganisms that lives in the gastrointestinal tract — helps the body maintain a stable internal environment when it is faced with external changes. This is known as homeostasis. The gut microbiome supports homeostasis in different ways, such as through helping to keep the immune system alert, and digesting dietary fibre into shortchain fatty acids to strengthen the intestinal wall.

The gut microbiome also helps us to regulate our inflammatory reactions. Inflammation helps the body fight microorganisms that cause disease, and helps repair damaged tissues. However, as the composition of our gut microbiome changes with age, a low level of inflammation can become constant throughout the body. This is called inflammaging.

When inflammaging develops in the gut, it leads to a decrease in immune responses, which puts people at a higher risk for infection and research has also shown that the disease. Let's take a closer look at the gut microbiome and how it changes with age.

Gut microbiome imbalances in older adults

Our gastrointestinal tract can be compared to a densely populated city inhabited by a variety of different bacteria, fungi, archaea and viruses collectively called the gut microbiota. In fact, compared to other parts of the body, the gut microbiome has the largest number of bacteria. In a healthy gut microbiome, there are four dominant families (or phyla) of microorganisms, including Bacteroidetes, Firmicutes. Proteobacteria and Actinobacteria.

Firmicutes and Bacteroidetes make up around 80 to 90 per cent of the gut microbiota in the digestive tract. Firmicutes help with the production of short-chain fatty acids to support intestinal health and the secretion of mucus to improve intestinal wall defence. Bacteroidetes metabolize complex carbohydrates into vitamins and nutrients, and help promote glycogen storage to improve glucose metabolism.

The gut microbiome and immune system work closely together. The microorganisms in the gut send out signals that are detected by immune sensors. This allows the immune system to regulate the beneficial bacteria in the gut, helping maintain immune homeostasis. Through this interaction, the adaptive immune system also receives stimuli from harmful substances called antigens, which

trigger an immune reaction. However, as people age, the composition and balance of microorganisms in the gut changes. This gives rise to microbial dysbiosis. which means there is a reduction in the number of beneficial bacteria in the gut, alongside a higher number and pro-inflammatory organisms and bacteria that can cause disease. In addition to this.

general diversity of bacteria in our gut also decreases with age.

Over time, the shortage of beneficial bacteria such as Firmicutes in older adults starts to compromise the integrity of their intestinal barrier, causing it to become leaky. This is because the Firmicutes family plays a very important role in keeping the intestinal wall healthy and strong by producing a short-chain fatty acid called butyrate. Shortchain fatty acids such as butyrate help provide nutrients to strengthen the intestinal wall, inform immune responses and lower inflammation.

When intact, the intestinal barrier works to prevent harmful bacteria from passing through the intestinal wall, entering the circulatory system and reaching important organs. However, when there are not enough gut bacteria to produce the short-chain fatty acids that are needed for the intestinal wall to function, bacteria are able to enter the bloodstream. This contributes to the formation of intestinal inflammaging, which refers to a low level of inflammation that becomes steady throughout the body with age.

HOW INTIAMMAGING WORKS

Inflammaging creates an environment that is prone to inflammation, which is caused and maintained by several factors. These can include microorganism imbalances in the intestines (microbial dysbiosis), psychological stress, physical inactivity, poor nutrition and chronic infections.

When the body is exposed to these factors on a regular basis, cellular senescence occurs. Cellular senescence is a state in which cell growth is permanently arrested. which means that cells are no longer able to self-renew. Eventually, this leads to a decrease in immune responses, which are important to prevent foreign substances and pathogens from entering the body.

Maintaining a healthy balance of gut microbiota

There is a common saying that claims "you are what you eat." Indeed, nutrition and diet play an important role in regulating the number of different microorganisms that live in the gut. This means that diet may also play a key role in the immune function of older adults.

The Mediterranean diet, known for its lower intake of refined carbohydrates, saturated fats, dairy products and red meat, has been shown to have a positive effect on the balance of microorganisms in the gut and the strength of the intestinal barrier. The Mediterranean diet has also been linked to a lower risk of Type 2 diabetes in older adults, allowing these individuals to live a longer and healthier life.

The use of probiotics and prebiotics can also help fight age-related inflammation. Probiotics, such as Lactobacilli and Bifidobacteria, are live microorganisms that can be consumed to support overall health. More specifically, probiotics help improve the function of the intestinal barrier and regulate immune responses by modifying the composition of the gut microbiome. However, tnere is still some debate around whether the acidic conditions in the stomach allow probiotics to survive long enough to be able to move into the intestine.

It is clear that the immune system has an intricate relationship with the gut microbiome. A healthy and wellbalanced gut microbiome will strengthen the intestinal barrier, which helps to reduce inflammation throughout the body and support the immune system.

To achieve this, it is important to maintain a healthy and well-balanced lifestyle as we grow older. This can include lower intake of dairy products and red meats, and harnessing the benefits of probiotics and prebiotics.

With the meteorological department forecasting a harsh and long summer, the government has asked all plants that are shut for maintenance or other reasons, to quickly start operating and harness surplus power available at generating stations dedicated to specific users.

The government is also ensuring that thermal power plants - the backbone of India's electricity supply - have enough coal stocks to last through June and has asked all units to offer their uncontracted or surplus power in power ex-

with PTI, Singh exuded confidence of meeting peak summer demand without any disruption. He said, "We are mobilising our entire capacity whether it is thermal, hvdro, renewable or gasbased.

So I think we will meet the demand." The Ministry of Power has projected a peak power demand of 260 gigawatt (GW) this summer (April-June), higher than the record of 243 GW in September last year. The ministry had projected

India's services sector witnessed one of the strongest growth rates in over 13-and-a-half years in March on the back of strong demand that spurred sales and business activity, a monthly survey said on Thursday. The seasonally adjusted

HSBC India Services **Business Activity Index** rose from 60.6 in February to 61.2 in March, one of the strongest expansions in total sales and business activity in close to 14 years. the Purchasing Managers' Index (PMI) parlance, a print above 50 means expansion, while a score below 50 denotes contraction. The HSBC

piled by S&P Global from



responses to questionnaires sent to a panel of around 400 service sector companies.

"India's services PMI rose in March, following a small dip in February, on the back of strong demand that spurred sales and business activity. Service providers in-

creased hiring at the fastest pace since August 2023 in order to expand production capacity," said Ines Lam, Economist at HSBC. The upturn was largely attributed to healthy demand conditions, efficiency gains, and positive sales develop-

ments, the survey said.

Companies signalled a substantial improvement in new order intakes during March. The rate of growth was one of the best seen since June 2010. New export business rose at the fastest rate since the started September 2014. Survey participants re-

ported gains from Africa, Asia, Australia, Europe, the Americas, and the Middle East. Services companies indicated that the substantial upturn in new business volumes added pressure on Accordingly, service

providers recruited additional staff in March. "The latest increase in employment was the 22nd in as many months, and the jointstrongest since November 2022," the survey said.

Prez launches India's first homegrown CAR T-cell therapy

Mumbai, Apr 04 (PTI):

President Droupadi Thursday Murmu on launched India's first indigenously-developed CAR T-cell therapy for cancer treatment, hailing it as a major breakthrough that provides "new hope for humankind" in the battle against the disease.

Developed by the Indian Institute of Technology (IIT) Bombay and Tata Memorial Centre, the genebased therapy is being rolled out in India at about one-tenth of its price outside the country, a senior official said

Speaking at the launch event at IIT Bombay here, Murmu said the indigenous development of the therapy was an example of the Make in India initiative. A CAR T-cell therapy involves modifying a patient's T cells (a type of immune system cell) in the laboratory and using them

to attack and destroy cancer cells. The `NexCAR19 CAR T-cell therapy' is the country's first 'Made in India' CAR T-cell therapy which is expected to bring down the cost of treatment significantly. This therapy is considered a phenomenal advance in medical sciences, the president said in

"The development of this therapy is also an example of the 'Make in India' initiative and speaks volumes about Indian scientists and physicians," she said.

The launch of India's first gene therapy is a major breakthrough in our battle against cancer. As this line of treatment, named CAR T-cell therapy, is accessible and affordable, it provides a new hope for the whole of humankind," Murmu added.

Centre, said the CAR T-cell therapy was enormously expensive and out of the reach of an overwhelming majority of people. NexCar19 needs to be

custom manufactured for every patient under the most stringent conditions, but it has been rolled out at approximately one-tenth of the price at which it is available outside India, he said. IIT Bombay director Prof Subhasis Chaudhuri said the treatment costs approximately Rs 4 crore abroad against Rs 30 lakh in India. The low-cost CAR T-cell therapy is a huge achievement for the country and for cancer patients, and places India firmly on the global map of cell and gene therapy, he said.

"Just like Chandravaan-3 that launched India's entry into elite space club, the CAR-T cell therapy heralds India's entry into the cell and genetic engineering group," Chaudhuri said.
