The high court allowed Kapur's appeal challenging a family court's order denying him divorce and said it is a settled position of law that making reckless, defamatory, humiliating and unsubstantiated allegations against a spouse in public amounts to cruelty.

# 10 Naxalites killed in encounter

#### Arms seized

Bijapur, Apr 02:

In a major anti-insuroperation, 10 Naxalites, including a woman, were killed in an encounter with security personnel in Bijapur district on Tuesday, police

Bijapur district comes under the Bastar Lok Sabha constituency, which will go to polls in the first phase of the general elections on April 19.

The gunfight occurred around 6 am in a forest between Lendra and Korcholi under Gangaloor police station area, where a joint team of security personnel was out on an anti-Naxal operation, Inspector General of Police (Bastar Range) Sundarraj P told PTI. Personnel belonging to the District Reserve Guard (DRG), Special Task Force (STF),

Reserve Police Force (CRPF) and its elite unit Commando Battalion for Resolute Action (CoBRA) were involved in the operation, he said. Acknowledging the current dominance of five nations - China, France, Russia, the UK, and the US - as the UN's original per-



manent members, the minister, however, said the international momentum was now favouring India's bid for a permanent seat.

The United Nations was formed around 80 years ago, and these five nations decided among themselves to become permanent members of its security council, Jaishankar said. He highlighted the historical context of the

five nations secured permanent membership, underscoring the evolving global landscape with around 193 countries 'But these five nations

have kept their control, and it is strange that you have to ask them to give us their consent for a change. A few agree, a few others put forward their position with honesty, while others do something from behind," he said.

Jaishankar spoke about the collaborative proposals involving India, Japan, Germany, and Egypt which have been submitted to the UN, signalling progress.

## SBI refuses to disclose SOP for sale, redemption of electoral bonds

#### In RTI reply

New Delhi, Apr 02 (PTI):

The State Bank of India (SBI) has refused to disclose its standard operating procedure for the sale and redemption of the electoral bonds that were issued to its authorised branches, citing the exemption given under "commercial confidence", according to an RTI response.

In an application filed under the Right to Information (RTI) Act, transparency activist Anjali Bhardwaj had sought the details of the standard operating procedure issued to the SBI's authorised branches on the sale and redemption of the electoral bonds.

"Standard Operating Procedures (SOPs) of Electoral Bond Scheme-2018 issued to authorised branches from time to time are internal guidelines with regard to sale and redemption of electoral bonds (meant for internal circulation only), which is exempted under section  $8(1)(\tilde{d})$  of the Right to Information Act,' the response from M Kanna Babu, the central public information officer and deputy general manager of the SBI, said on March 30.

# INDIA acronym: HC give last chance to parties to reply

New Delhi, Apr 02 (PTI):

The Delhi High Court on Tuesday granted a last opportunity to the Centre and several opposition parties to respond to a petition seeking to restrain them from using the acronym INDIA (Indian National Developmental Inclusive Alliance).

A bench of Acting Chief Justice Manmohan and Justice Manmeet PS Arora said that the replies be filed within one week to the public interest litigation which alleged that by using the INDIA acronym, the parties were taking "undue advantage in the

name of our country". The high court, which refused to prepone the date of hearing of the petition, said an endeavour shall be made to hear and dispose of the petition on April 10.

"The contesting respondents are given the last and final opportunity to file their replies within a week," the bench said. The court was hearing

an application by petitioner Girish Bharadwaj seeking early hearing of the matter on the grounds that the petition was pending since August 2023 and pleadings are yet to be completes and the election

# Doctors perform combined liver and kidney transplant

Doctors at a city hospital performed a rare combined liver and kidney transplant on a 46-year-old critically ill patient from Uzbekistan, with organs harvested from live donors' wife and daughter in a sur-

plants are rare and challenging and underscore remarkable feats achievable in modern medicine, doctors said. The patient presented

with the history of recurrent ascites (water in tummy), needing multiple admission for draining the water. When he visited Max Hospital, Vaishali, upon evaluation it was found that he had a liver cirrhosis as well as a nonfunctioning kidney, the hospital said in a statement. The patient was suffering from advanced kidney failure and both of his kidneys put together were functioning less than 20 per cent of normal. "The

Dr Dinesh Mishra added that some newborn babies have some problems in the initial days, cold, cough, fever, pneumonia, waking up at night, crying repeatedly, gas, indigestion, stomach

vomiting, but for all these, the innocent baby should be properly examined and treated by a trained doctor.

There are different causes of diseases which are treated by examination and testing. How can a sick person be cured of the disease by self-treatment, exorcism, iron rods, burning with hot incense sticks, wearing amulets, removing the evil eye, etc., rather the child can become more ill and his condition can

doubts over the credibility of EVMs. "He has a problem with everything. Why didn't he raise questions when Congress introduced EVMs? He has been raising questions on EVMs for the past 10-15 years. No question is asked by Congress (on EVM credibility) when it wins but a lot of doubts are raised when they lose," said Scindia while responding to a query on Singh's demand.

It is a stigma to raise the questions over democracy and voting rights of people, the BJP leader said.

Queried on Rahul Gandhi's critical post on Prime Minister Narendra Modi, Scindia questioned Congress' moral rights for speaking about corruption. A day before, Gandhi alleged that the Prime Minister talked about fighting corruption but he is distributing the franchise of corruption from Assam to Maharashtra.

'This is the example of the proverbial 'Ulta Chor Kotwal Ko Dante' (the pot calling the kettle black). During the 10-vear Congress rule, India's identity in the world was a country with corruption and crony capitalism.

## **Conch blowers in high demand as election approaches** Berhampur (Odisha), Apr 02 (PTI)

The services of conch blowers are generally required during the auspicious occasions of Hindu marriages, thread ceremonies and other events.

But with the elections to the 147-member Odisha Assembly and 21 Lok Sabha seats in the state approaching they are in high demand as "sankha' (conch) is the symbol of the ruling Biju Janata Dal and the regional party candidates start their campaign by blowing conch across the state.

The conch blowers are hired by BJD candidates during the elections to familiarise the voters with the party symbol 'conch' during their campaigning. The BJD candidates in all the 168 constituencies (21 Lok Sabha and 147 assembly segments) require conch blowers during the campaign.

There are around 25,000

conch blowers in Odisha's Ganjam district and most of them are engaged in the election campaign for BJD candidates in different constituencies.

## Sri Lanka to probe hazardous cargo on vessel Dali: Minister

Colombo, Apr 2 (PTI)

Sri Lanka will investigate reported hazardous materials on board the cargo vessel that collided with a key Baltimore bridge last week, the state minister of environment told Parliament on Tuesday, insisting that the country's authorities have not been informed about the content of the cargo.

The Singapore-flagged container ship vessel, Dali, which was mainly manned by an Indian crew, collided with the 2.6-kmlong four-lane Francis Scott Key Bridge over the Patapsco River Baltimore in the early hours of March 26. The 984-foot cargo ship was bound for Colombo, Sri Lanka. It was reported that the container ship was carrying 764 tonnes of hazardous materials to

Colombo. Central **Environment Authority**  has not been informed of any hazardous cargo,' Janaka Wakkumbura, the state minister of environment, told Parliament.

He said both Sri Lanka Customs and the Colombo Port have been instructed to carry out a probe.

'They will carry out an investigation, Wakkumbura said.

He was responding to a question from Opposition leader Sajith Premadasa who asked if permission had been granted to unload cargo in the Colombo

The port officials said the ship was due to reach Colombo on April 22 and the information on its cargo would only have been known 48 hours before its arrival.

## **Parliamentary speaker faces imminent arrest** over graft charges after court bid fails

Pretoria, Apr 2 (AP):

South Africa's parliamentary speaker faces imminent arrest over corruption charges after a court on Tuesday dismissed her bid to block police and prosecutors from arresting

Nosiviwe Mapisa-Nqakula, who is a senior member of the ruling African National Congress party, is accused of receiving bribes from a defense contractor while she was defence minister.

According to prosecutors, she received 11 payments totalling USD 135,000 between December 2016 and July 2019. She sought another bribe of USD 105,000 but that wasn't paid, prosecutors said.

Opposition lawmakers have called for her to step down from her position as speaker over the allegations. Mapisa-Nqakula last week launched an urgent court bid to block her arrest, but a judge at the

North Gauteng High Court in Pretoria dismissed her application on Tuesday.

Speaking to reporters after the judgment was delivered, National Prosecuting Authority spokesman Mthunzi Mhaga did not say when the arrest would be made but confirmed the judgement paved the way for it

"Obviously the wheels of justice will now be in motion, as we were listening to the judgment, which was well reasoned,'

Mhaga said. "We have always maintained that this is unprecedented and it was unnecessary for us to be brought to court. We have always maintained that the process of arrest will be done seamlessly," he added. Before launching her court bid, Mapisa-Ngakula was told by prosecutors she should turn herself in to authorities for

processing and to appear

before a judge.

# Pope exposes confidential details of past conclaves and settles scores with Pope Benedict XVI's aide

Kinshasa (Congo), Apr 2 (AP):

## **India-China Inch Closer Pursuing Peace Amidst Complexity**

The meeting between Indian and Chinese diplomats on the simmering Ladakh border tensions has elicited a cautious optimism. Yet, despite the apparent cordiality, tangible progress remains elusive. The 29th meeting of the Working Mechanism for Consultation and Coordination on India-China Border Affairs (WMCC) underscored the intricacies of the Sino-Indian border dispute, steeped in historical grievances and geopolitical intricacies. Conversely, China's portrayal of the situation as less critical and its emphasis on progress made suggest a divergence in perspectives, potentially hindering meaningful progress. Underlying strategic concerns further complicate the landscape. China's assertiveness, coupled with its strategic alliance with Pakistan, casts a shadow over India's security calculus. Moreover, the unresolved border dispute impedes economic cooperation and regional stability, necessitating concerted efforts towards resolution. Moving forward, transparency and confidence-building measures (CBMs) are imperative. Detailed disengagement plans, coupled with regular dialogue and joint military exercises, can foster trust and prevent inadvertent escalations. Diplomatic channels must remain the primary avenue for resolution, facilitated by dedicated working groups or special representatives. While incremental progress may lack the allure of immediate breakthroughs, it is these small steps towards dialogue and cooperation that lay the groundwork for lasting peace. Both nations must eschew brinkmanship and unilateral actions, opting instead for statesmanship and foresight in pursuit of a mutually acceptable solution. As stakeholders in regional stability and prosperity, neighboring countries and global powers have a vested interest in promoting dialogue and de-escalation. A peaceful resolution to the border dispute holds the promise of increased economic cooperation and stability, benefiting the entire region. The road ahead is arduous, but not insurmountable. The recent talks offer a glimmer of hope amidst the complexities. However, achieving lasting peace and stability demands unwavering commitment to dialogue, transparency, and creative solutions. It is imperative that both India and China rise above aggressive posturing and demonstrate a genuine willingness to engage constructively in pursuit of peace along this strategically sensitive border.

T he development of Arvind Kejriwal, Delhi's Chief Minister, being sent to judicial custody for 15 days without tendering his resignation has triggered an unprecedented situation, sparking a potential constitutional crisis. # Silver Screen's Influence on **Kerala's Political Sphere**



he south Indian cinema and politics are intertwined for over several decades more so in Tamil and Telugu speaking states, where the cine heroes, heroines, script writers became the Chief Ministers. The influence of cinema was minimal despite some attempts by Kannada film fraternity, only few actors or their spouses got elected in Karnataka. The other state of south, the Kerala claimed to be different from other states in many aspects including the cinema influence on politics. This was not so despite the tall claims of LDF leaders as the communist parties also took the help of cine personalities in reaching out the voters. Though the top actors and actresses are not involved politically there are second rung actors had political connections and this time around the entry of cine actors is more open proving that Kerala is no exception in the south.

Currently at least four artists are legislatures in the Kerala assembly and there are some others who are financially involved in the cinema industry, though there names may not appear on the titles of the Malayalam screens. The current transport minister K.B. Ganesh Kumar, who also held forest and environment ministries in earlier

stints is member of Kerala Congress (B) since last two decades. He was a television host and was a member of both Congress led UDF as well as LDF in different times.

Already four members of film fraternity are in the Kerala assembly representing different political interests. Mani C Kappan is a film actor, producer and director represents NCP from Pala constituency. Daleema Jojo of CPM is a cine singer and also famous for singing religious hymns of Christianity and Hindu .As a member of CPM she got into politics in 2015 through local body elections and then won 2021 assembly election. The fourth one is Mukhesh Madhavan, actor and producer for over four decades was associated with the CPM and is currently an MLA in Kerala assembly. He is now picked by CPM as the candidate for Kollam Lok Sabha seat. This is to neutralise the cine glamour of actor G. Krishna Kumar who is trying his luck in Kollam as BJP candidate.

As per Unnikrishnana, the general secretary of the Film employees Federation of Kerala directors union the cine personalities joining politics is now now and it has history of over two decades but media is highlighting this just because BJP has put up actors for the upcoming Lok Sabha

light and project it as a glamour dependent party having no root at the base level. As the Left parties tried to hide its role in putting up actors as candidates in election, now the past being dug out by the media. It is a fact that Kerala remained

unassailable area for BJP where there is no candidate ever got elected form that soil till 2016 when one of its veteran leader Rajagopal created history by entering the assembly. He failed to retain his seat in 2021, thus pushing BJP to the square one. Despite many decades of work by RSS in Kerala and many groups getting attracted to the core ideology of Sangh, it never got transformed into electoral politics to win seats for BJP. Since Modi government taking over Delhi, it made sustained attempt to crack Kerala politics which are well polarised between LDF and Congress lead UDF. In 2019 Lok Sabha elections, despite being in power in the state. LDF could win only one seat while the UDF won 19 seats. LDF withstood that reversal and bounced back by retaining power in 2021 state assembly elections. Now BJP slowly trying to build a third front though its success is not encouraging.

To gain political foothold in Kerala the BJP tried many ways, including the Sabarimala temple entry verdict, Love Jihad issue, where even Christian girls are also victims. Besides them the cine glamour is also injected to wean away the young voters. Suresh Gopi, the actor, was picked up for nominated Rajya Sabha seat, then gave assembly ticket in the last elections and now nominated as the candidate from Thrissur constituency. Thrissur is the temple town and is nerve centre during the agitation against the judicial verdict on Sabarimala entry for women of all ages. Women were in forefront of

that agitation and BJP hopes that Nari-Shakthi and Suresh Gopi's cine glamour will put Thrissur in their kitty this time.

The Kollam seat is also going to be a fight between two actors. Mukesh Madhavan of CPM known for his ribtrickling roles and sitting member of Kollam assembly constituency now candidate for Lok Sabha constituency is challenged by Krishna Kumar of BJP who is through television and cinema characters. He along with his daughters used the social media platforms to become the influencers and then use that popularity in the political arena.

It is not that Malayalam voters are totally against filmy glamour into the elections. In 2014 actor Innocent, who acted over 700 films in different languages, got elected from Chalakudy constituency as an independent candidate. The LDF tactfully supported him to cash cine popularity of Innocent elsewhere. At that time actor Innocent was the Malavalam Movie artists' association president.

Movies artist's interest in politics in Kerala is there even in Prem Nazir time where Congress party encouraged him to some extent and then dropped him. In 1965 itself film personalities contested and won election. LDF fielded director Lenir Rajendran in 1989 elections. There are many unsuccessful attempts some cine artists.

The only difference between Kerala and other southern states is that top heroes never took a plunge unlike in Tamil Nadu and Andhra Current top guns Pradesh. Mammutty and Mohan Lal are totally detached from politics. But who knows when they will be bitten by political bug and turn Kerala into any other southern state where politics and cinema are happily combined.

# How to make sure your leftovers are safe to eat

ating leftovers can be a great way to save money, diversify your cooking repertoire and reduce food waste.

But eating leftover food can also be risky as these foods have already been exposed to bacteria in the environment. If you haven't stored and re-heated leftovers correctly, you could be putting yourself at risk of potentially lifethreatening food poisoning.

That doesn't mean you should start avoiding leftovers, however. By following the the correct food safety practices, you can ensure you avoid harm when eating left-

How quickly should leftovers be refrigerated or frozen?

Bacteria exist everywhere in our world, including in kitchens - and the foods within them. The bacteria that cause food to spoil can grow rapidly with the right nutrients, moisture and temperatures. Some double in numbers in as little as 20

It's important that any leftovers are put into the fridge or freezer as quickly as possible and within two hours maximum. This time advice is based on how quickly bacteria

can grow in food at non-refrigerated temperatures, and means leftover food become less safe to eat the longer it is left at more than 5°C. You should also make sure that leftovers are covered. Clingfilm and airtight lids help prevent air from getting at the food. This is important, as most pathogens need oxygen to grow.

How long are refrigerated leftovers safe to eat?

Your fridge should be kept at a temperature of between 0 and 5°C, as this inhibits the growth of food poisoning bacteria on leftovers.

Leftovers must be eaten within two days, as any longer gives harmful bacteria more time to grow. Indeed, pathogens such as Listeria. which can cause flu-like symptoms, can even grow in refrigerated temperatures and are more likely to grow beyond two days which is why this is the recommended time limit for storing your

If you don't think you'll eat your leftovers within that timeframe, consider freezing them. Leftovers can be kept for up to three months

if frozen at -18°C. What is the safest way to re-heat

your leftovers?

When you reheat leftovers, you must ensure the food is piping hot all the way through. If not, don't eat

Leftover foods should be reheated to an internal temperature of at least 165°F (74°C). For sauces, stews, soups and gravy, it's best to bring them to a full boil, stirring for at least three minutes. These practices will kill most bacteria and inactivate any heat-sensitive bacterial toxins that are present.

If reheating leftovers in the oven, set the oven temperature to at least 325°F (163°C or gas mark 3) and bake long enough to completely heat the food through to at least 74°C. If reheating leftovers in the microwave, vou should also make sure they reach an internal temperature of 74°C before eating.

Reheating food using a slow cooker is not a good idea because if foods stay at a temperature less than 165°F for several hours, this can permit bacterial growth increasing your risk of food poison-

Can you reheat leftovers more

food warms and cools, it provides

than once? You really should not reheat leftovers more than once. Each time a the right temperature and amount of time needed for any harmful bacteria to start to re-grow.

This then makes it harder for heat kill all the pathogens present the next time you warm up the leftovers. If you don't think you'll eat all your leftovers within two days, consider freezing them.

Can vou reheat a takeaway? Whether you can safely re-heat takeaway foods depends on how you stored it.

If it was stored warm in the back of your car or left at room temperature in your home for more than two hours, then the meal may be a food poisoning risk - especially if you've already touched or partially eaten it (which introduces bacteria to the food).

But if you didn't handle the food much and refrigerated it within two hours of purchase, then the takeaway is safe to re-heat - provided the next time it's eaten it's first heated to a piping hot temperature of at least 74°C. It also shouldn't be stored in the fridge for more than two days.

There are some takeaway foods that you should be careful about saving as leftovers. Cooked rice dishes are possibly the most risky to save. Uncooked rice may contain spores of Bacillus cereus, a bacterium that causes food poisoning.

While the parent bacterium is killed when rice is cooked, its spores can survive the temperature of boiling water. If rice is not refrigerated within two to three hours of cooking, the spores can grow into bacteria which in turn release the rice toxins which give rise to food poisoning symptoms such as diarrhoea, abdominal pain and vomiting. The longer contaminated cooked rice is left to stand at a nonrefrigerated temperature, the more Bacillus cereus will be present and

the more unsafe the dish becomes. If cooked rice needs to be saved. it should be covered once cooked and cooled quickly (ideally within 2 hours), then stored and refrigerated for no more than 24 hours. Cooked rice leftovers should be piping hot when reheated, and should never be reheated more than once.

Leftovers can be safe to eat so long as you take the right precautions. But if you're ever in doubt. or don't think you'll eat them within two days, storing them in the freezer will give you more flexibility than storing them in the fridge.

# Transparency most fundamental attribute of trust: Buch

Mumbai, Apr 02

chairperson Madhabi Puri Buch on Tuesday said the entire edifice of the capital markets rests on trust, and called transparency as the "fundamental attribute" of the same. She said the capital markets regulator acts as a proxy to safeguard the interests of the public shareholders, which account for 56 per cent of the listed companies' holdings as against 44 per cent with the promoters. "Not just the market, but the entire economy rests on the edifice of trust," she said, speaking at an event on corporate governance organized by industry lobby grouping CII here. "To us as a regulator, the most fundamental attribute of trust is transparency," the Sebi chief added. She said trust is a two-way street. where a company has to build trust with the regulator to build trust with the market while the regu-



lator is working to build trust with the industry as a representative of the public shareholders. Bajaj Finserv's head Sanjiv Bajaj, who also chairs the CII council on corporate governance, said the lobby grouping is a frontrunner on corporate governance and advises its members to follow it not only in letter but also in spirit. "Sound corporate governance practices play an important role in building sustainable businesses. But they also contribute towards stability, growth and credibility of the larger economy as a whole,' Bajaj said. He said that coming out with a charter on corporate governance in family businesses. 
## Govt has taken up issue of ban on imports of Russian diamonds by EU, G7: Jaishankar

India's manufacturing sector growth climbed to a 16-year high in March on the back of the strongest increase in output and new orders since October 2020, amid reports of buoyant demand conditions, a monthly survey said on Tuesday. The seasonally adjusted HSBC Manufacturing Purchasing Managers' Index (PMI) surged to a 16year high of 59.1 in March, from 56.9 in February, re-

In Purchasing Managers' Index (PMI) parlance, a print above 50 means expansion while a score below 50 denotes contraction. "India's March manufacturing PMI rose to its highest level since 2008. "I'm working hard and focusing on building my bowling fitness back up to fulfil a full role as an allrounder in all formats of



IPL and the World Cup will hopefully be a sacribe for the foreseeable future," Stokes said in a statement issued by the ECB. Stokes, 32, was incharge of the the team that suffered a 1-4 Test series loss to India earlier this year and said the tour made him realise that he isn't quite up for it when it comes to bowling.

The recent Test tour of India highlighted how far behind I was from a bowling point of view after my knee surgery and nine months without bowling.

# **SC deprecates non-appearance of TN DMs before ED**

Terms it 'cavalier approach'

New Delhi, Apr 02 (PTI)

The Supreme Court on Tuesday strongly deprecated the non-appearance of five district collectors of Tamil Nadu before the **Enforcement Directorate** going money laundering probe related to alleged illegal sand mining, despite the court's order.

It directed the officials to appear before the ED personally on April 25 saying failure to do so will serious consequences. A bench of justices Bela M Trivedi and Pankaj Mithal said the officials adopted a "cavalier approach" and the action shows they have no respect for the court, law and the Constitution.

"In our opinion, such a cavalier approach will land them in a difficult situation. When the court had passed the order directing them to appear in response to the summons

were expected to obey the same order and remain present before the ED.

'This shows that the officers don't have either respect for the court or the much less the Constitution of India. Such an approach is strongly deprecated," the bench said.

Senior advocates Kapil Sibal and Amit Anand Tiwari, appearing for the Tamil Nadu government, said the officials were busy in maintaining public order and implementation of the social security scheme. They said the Lok Sabha

elections are scheduled in

Tamil Nadu for April 19 and the officials have been looking after the poll-related works. The bench said the officials should have appeared before the probe agency and explained the reasons. It said that one last opportunity is being given to the officials to appear before the ED in connection with the money laundering probe. Sibal said a review application has been filed against the apex court by which the court had asked the officials to appear before the

probe agency. 'What is the point of sending the officials before the probe agency, when they have said that they do not have the requisite data sought by the ED," the senior lawyer said, adding that even authorised agents of the officer can be sent. He added that ED has not specified whether the officials are being summoned as witnesses or an accused. The bench asked Sibal to read section 50 of the Prevention of Money Laundering Act (PMLA) and said, "ED can summon anybody as it says 'any person'." Section 50(2) of the PMLA says "The Director, Additional Director, Joint Director. Deputy Director Assistant Director shall have power to summon any person whose attendance he considers necessary whether to give evidence or to produce any records during the course of any investigation or proceeding under this

"You were given sufficient time to appear. The order (February 27) was passed a month back. But, they chose not to appear.'

On February 27, the top court directed the five district collectors to appear before the ED in connection with an ongoing money laundering probe. The Madras High Court,

on November 28, last year, stayed the summons issued by the central probe agency seeking the presence of district collectors

Tiruchirappalli, Karur, Thanjavur and Ariyalur in connection with its ongoing probe. The ED moved the top court against the high court order, saying the non-cooperation would hamper its probe. ## **Victims locked themselves inside bathroom**

Firefighters wearing gas masks ran up staircases and in and out of rooms shrouded in thick black smoke as they raced against time on
