



The agriculture centres providing local handmade bills instead of the GST provisioned bills and are selling medicines without principal certificate

KHAIRAGARH: Agricultural centre operators are selling medicines without principal certificate; while on the other hand, shopkeepers are giving medicines to farmers at higher prices. In such a situation, farmers of Bazaar Ataria, Thelkadih, Mudhipar are forced to go to agricultural shops and buy fertilizers and seeds at higher prices and agricultural centre operators are taking full advantage of the scenario. As per reports, there are more than 50 agricultural centres operating in the surrounding areas including Bazaar Ataria, Panda Daha, Thelkadihi, where the agricultural centres are being run bypassing the rules. Here it takes a special mention that in order to sell medicines, fertilizers, seeds, hybrid seeds, research seeds and vegetable seeds in the agriculture centre, principal certificate are given to the company and agriculture centre operators. But the operators are not enlisting the quantity and rates are not mentioned on the stock register, information board, neither is the original GST bill being given to the customers. Thereby by handing over local bills to the farmers, they are

extracting huge amount of



money from the farmers by selling the medicines of the local company at higher prices.

On the other hand the Department is not inspecting, the shops resulting in open market black marketing. Sugar in Baby Food: Disparity by Nestle Sparks Concern

he revelations regarding the sugar content in Nestle's baby-food brands across different nations have sparked global concern. Public Eye, alongside the International Baby Food Action Network (IBFAN), shed light on a disconcerting reality: while countries like the UK, Germany, and Switzerland enjoy sugar-free variants of Nestle's products, India and several other nations face a concerning excess of added sugar in their infant cereals. The findings paint a distressing picture: an average of nearly three grams of sugar per serving in Cerelac baby products in India, a stark contrast to the sugar-free versions available elsewhere. This disparity extends beyond India's borders, with similar patterns observed in countries like Ethiopia, Thailand, and the Philippines. Nestle's practices seem to defy international guidelines aimed at curbing obesity and promoting healthier dietary habits among infants. Nestle India Ltd's response, citing a reduction in added sugar content over the past five years and ongoing efforts to further reformulate products, does little to assuage concerns. While the company emphasizes its commitment to nutritional quality and the use of high-quality ingredients, the glaring inconsistency in sugar levels across regions raises questions about corporate responsibility and ethics. The Guardian's report further underscores the gravity of the situation, highlighting the discrepancies in Nestle's practices between affluent and economically disadvantaged markets. Such a double standard is indefensible, as emphasized by WHO expert Nigel Rollins. The presence of added sugar in products targeted at infants as young as six months not only contradicts nutritional recommendations but also poses potential health risks in the long term. As consumers, regulators, and advocates, we must demand accountability from multinational corporations like Nestle. Access to safe, nutritious food is a fundamental right, especially for the most vulnerable members of society. It is imperative that companies prioritize the well-being of consumers over profit margins and address the systemic inequalities perpetuated by their practices. The findings of this investigation serve as a wake-up call for the health and future of our children depend on it.

acebook parent Meta Platforms unveiled a new set of artificial intelligence systems Thursday that are powering what CEO Mark Zuckerberg calls "the most intelligent AI assistant that you can freely use". But as Zuckerberg's crew of amped-up Meta AI agents started venturing into social media this week to engage with real people, their bizarre exchanges exposed the ongoing limitations of even the best generative AI technology. One joined a Facebook moms' group to talk about its gifted child. Another tried to give away nonexistent items to confused members of a Buy Nothing forum.

Meta, along with leading AI developers Google and OpenAI, and startups such as Anthropic, Cohere and France's Mistral, have been churning out new AI language models and hoping to persuade customers they've got the smartest, handiest or most efficient chatbots.

While Meta is saving the most powerful of its AI models, called Llama 3, for later, on Thursday it publicly released two smaller versions of the same Llama 3 system and said it's now baked into

the Meta AI assistant feature in Facebook, Instagram and WhatsApp.AI language models are trained on vast pools of data that help them predict the most plausible next word in a sentence, with newer versions typically smarter and more capable than their predecessors. Meta's newest models were built with 8 billion and 70 billion parameters - a measurement of how much data the system is trained on. A bigger, roughly 400 billion-parameter model is still in training.

"The vast majority of consumers don't candidly know or care too much about the underlying base model, but the way they will experience it is just as a much more useful, fun and versatile AI assistant," said Nick Clegg, Meta's president of global affairs, in an interview.

He added that Meta's AI agent is loosening up a bit. Some people found the earlier Llama 2 model - released less than a year ago - to be "a

little stiff and sanctimonious sometimes in not responding to what were often perfectly innocuous or innocent prompts and questions," he said. But in letting down their guard, Meta's AI agents also were spotted this week posing as humans with made-up real world experiences.

A chatbot with the official Meta AI label inserted itself into a conversation in a private Facebook group for Manhattan moms, claiming that it, too, had a child in the

Meta said in a written statement Thursday that "this is new technology and it may not always return the response we intend, which is the same for all generative AI systems."

Indian-origin men arrested in Canada's biggest ever heist, first time in history



NEW DELHI: Canada on Thursday cracked one of the most audacious heists in its history, unravelling a web of criminal activity that intertwined gold, cash, and firearms. The plot, reminiscent of a script straight out of a crime thriller, unfolded at Toronto's Pearson International Airport, leaving investigators grappling with a multimillion-dollar puzzle.

The heist, which took place on April 17 in 2023, saw an unexplained disappearance of a staggering cache—along with 2.5 million Canadian dolof riches: over 22 million Canadian lars' worth in foreign currency.

dollars' worth of gold bars and foreign currency stolen away from a secure storage facility within the airport's premises. The modus operandi to carry out the heist involved forged paperwork to gain access to the precious cargo. SEOUL: The United States and its allies are discussing options "both inside and outside the UN system" to create a new mechanism for monitoring North Korea over its nuclear weapons programme, the American ambassador to the United Nations said on Wednesday.

Russia last month vetoed a UN resolution in a move that effectively abolished monitoring by UN experts of Security Council sanctions against North Korea, which prompted Western accusations that Moscow was acting to shield its arms purchases from North Korea to fuel its war in Ukraine. US vetoes Palestinian bid to gain statehood

UNITED NATIONS: The US has vetoed a resolution in the UN Security Council on the latest Palestinian bid to be granted full membership of the United Nations, an outcome lauded by Israel but criticised by Palestine as "unfair, immoral, and unjustified". The 15-nation Council voted on a draft

resolution Thursday that would have recommended to the 193-member UN General Assembly "that the State of Palestine be admitted to membership in the United Nations." The resolution got 12 votes in its favour, with Switzerland and the UK abstaining and the US casting its veto. To be adopted, the draft resolution required at least nine Council mem-



bers voting in its favour, with no vetoes by any of its five permanent members - China, France, Russia, the United Kingdom and the United States.

Palestinian attempts for recognition as a full member state began in 2011. Palestine is currently a non-member observer state, a status that was granted in November 2012 by the UN General Assembly.

G7 foreign ministers warn of new sanctions on Iran

CAPRI (ITALY): Group of Seven foreign ministers warned of new sanctions against Iran on Friday for its drone and missile attack on Israel, and urged both sides to avoid an escalation of the conflict. Italian Foreign Minister Antonio Tajani, who chaired the meeting of ministers of industrialised countries, said the agenda of the three-day meeting was changed on Friday to address the latest developments. Early Friday, Iran fired air defences at a major air base and a nuclear site near the central city of Isfahan after spotting drones. They were suspected to be part of an Israeli attack in retaliation for Tehran's unprecedented drone-and-missile assault on the country last weekend. Tajani didn't immediately address the incident, but said that G7 ministers condemned Iran's weekend attack on Israel and urged both sides to exercise restraint. PTI



Ukraine claims it shot down a Russian strategic bomber

KYIV (UKRAINE): Ukraine's air force claimed Friday it shot down a Russian strategic bomber, but Moscow officials said the plane crashed in a sparsely populated area due to a malfunction after a combat mission. Neither claim could be independently verified.

Previous Ukrainian claims of shooting down Russian warplanes during their more than two-year war have met with silence or denials from Moscow.

Meanwhile, Russian missiles struck cities in the central Dnipro region of Ukraine, killing eight people, including an 8-year-old girl, and injuring 25, local officials said. Ukraine President Volodymyr Zelenskyy repeated Kyiv officials' almost daily appeals for more Western air defense systems, again drawing a parallel with how Israel blunted a recent Iranian attack.





Shalu Chaudhary cleared of doping after DNA test reveals contamination

NEW DELHI: The National Anti-Doping Agency's appeals' panel has exonerated middle-distance runner Shalu Chaudhary of doping charges and lifted her four-year ban after DNA testing revealed that her urine sample had either been tampered with or contaminated at the time of collection. The 30-year-old Chaudhary was banned last year after she lost her appeal to NADA's disciplinary panel. She was suspended for the alleged use of two substances including a stimulant and peptide hormones. The runner, who is a national-level medallist in 800m, subsequently sought a DNA testing of her urine sample, a plea that was rejected by the disciplinary committee but accepted by the appeals panel. The DNA testing was eventually conducted at the Forensics department of King's College, London. "The A and B samples from the previously analysed urine sample produced extremely poor partial DNA profiles.




